Dear Speaker Bernstein:

I have signed HB 1448, which clarifies, but does not change, existing North Dakota law. This bill has been the subject of some confusion among the public, and I am offering comments to provide better understanding of the current law and the effect of this legislation.

Currently, North Dakota property owners may choose whether or not to rent property to unmarried people of opposite gender. Simply put, landlords have this discretion in North Dakota, Minnesota and other states.

While HB 1448 does not alter existing law, it may serve to help landlords and tenants avoid confusion and litigation. To help the legislature clarify this issue I have signed this legislation.

Every insurance company, nonprofit health service corporation, and health maintenance organization is a financial institution for purposes of chapter 6-08.1, relating to disclosure of customer information. The commissioner shall enforce compliance with this section.

**SECTION 6.** A new section to Senate Bill No. 2127, as approved by the fifty-seventh legislative assembly, is created and enacted as follows:

**SECTION 3. EFFECTIVE DATE.** Section 1 of this Act becomes effective on August 1, 2003."
