1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
2 governor; and to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota
3 Century Code, relating to the salaries of the governor and lieutenant governor.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
6 funds as may be necessary, are hereby appropriated out of any moneys in the general fund in
7 the state treasury, not otherwise appropriated, to the office of the governor for the purpose of
8 defraying the expenses of the governor, for the biennium beginning July 1, 2001, and ending
9 June 30, 2003, as follows:

10 Salaries and wages	\$2,127,065
11 Operating expenses	224,370
12 Equipment	9,600
13 Contingency	10,000
14 Roughrider awards	<u>10,800</u>
15 Total general fund appropriation	\$2,381,835

16 **SECTION 2. APPROPRIATION - AUTHORIZATION - GOVERNOR'S OFFICE.** The
17 governor's office may receive and expend any federal or private funds which are hereby
18 appropriated which become available during the biennium beginning July 1, 2001, and ending
19 June 30, 2003.

20 **SECTION 3. AMENDMENT.** Section 54-07-04 of the 1999 Supplement to the North
21 Dakota Century Code is amended and reenacted as follows:

1 **54-07-04. Salary of governor.** The annual salary of the governor is ~~seventy-six~~
2 ~~eighty-five~~ thousand ~~eight~~ five hundred ~~seventy-nine~~ six dollars through June 30, ~~2000~~ 2002,
3 ~~seventy-eight~~ and ~~eighty-seven~~ thousand ~~four~~ two hundred ~~seventeen~~ sixteen dollars through
4 ~~December 31, 2000~~, and ~~eighty-three~~ thousand ~~thirteen~~ dollars thereafter.

5 **SECTION 4. AMENDMENT.** Section 54-08-03 of the 1999 Supplement to the North
6 Dakota Century Code is amended and reenacted as follows:

7 **54-08-03. Salary of lieutenant governor.** The annual salary of the lieutenant
8 governor is ~~sixty-three~~ sixty-six thousand ~~one~~ three hundred ~~eighty-three~~ eighty dollars through
9 June 30, ~~2000~~ 2002, and ~~sixty-four~~ sixty-seven thousand ~~four~~ seven hundred ~~forty-seven~~ eight
10 dollars thereafter.
