

Chairman Wald So the spending limit is about the same?

Don. LC Overall, yes.

Senator Andrist On behalf of the appropriations committee, responding primarily to the two judiciary committees, they decided that this was not a good home as they had expected for the indigent defense so they are putting it back in judiciary and they are probably going to spend another two years figuring out if they can't find a better home than the judiciary. They would like to separate the two initiatives.

Senator Traynor I served on both of the judiciary committees and at that time the court expressed dissatisfaction with the operation of the indigent defense program because the judges felt that there is a possibility of conflict when the judge appoints an attorney to represent a defendant and later had to rule whether that representation was adequate or inadequate. They felt that that was not correct. When we got the matter in the Senate judiciary committee, our committee thought that a better home for the indigent defense program was to remain with the court because the court has an apparatus all over the state. If there is a conflict because of an appointment in Wahpeton, they could bring in a judge from Devils Lake. I think they can resolve that problem. We found as we were looking at HB 1088 that there was a great deal of dissatisfaction among the firms that are handling these indigent defense contracts. HB 1088 is the money vehicle. The problem with the contracts was under funding to the extent of about \$750,000 over and above what the court had budgeted which was something over \$3 million.

The problem was how do we find the \$750,000, do we just look to the general fund or do we find some other funding mechanism. The Senate judiciary passed HB 1088 and the Senate has passed it and it is in the House to impose administrative fees. The judges have the right to do that in

criminal cases. HB 1088 provides that the courts access administrative fees at a fixed level for each category of crime starting with class B misdemeanors at \$125 and rising on the scale up to class A felonies and AA felonies at \$900. Those fees go to the general fund. Last year, without any mandate from the legislature, the courts raised \$565,000 in the year 2002 by imposing administrative fees. So we felt that there was ample room there to fund the indigent defense program deficit of \$750,000 and the courthouse facilities program. Another bill provided there be an imposed, I believe a \$10 increase in civil filing fees to fund the court facilities in courthouses around the state. The feeling of the counties was, now the courts are the state's responsibility. In response to that, this bill sets up a committee, so to speak, to supervise how this is distributed. HB 1088 is the funding mechanism for that because it provides, in addition to the amount imposed for each category of crime which goes to the general fund, the court must impose an additional \$100 in each criminal case. I think in the last biennium there were 25,000 class B misdemeanors, so if you add \$100 a case even if you get 50% of that, you've got enough money to take care of these problems. HB 1088 provides the funding mechanian for the indigent defense program and the court facilities program and specifies that the first \$750,000 generated from the \$100 accessed in each criminal case be spent for indigent defense. The next \$460,000 is spent for court facilities. Any amount over that is divided equally between the two programs. I think the fiscal note is conservative as to the amount of money that would be raised. The plan now is there is a study resolution that will study this program for the next blennium and the ultimate objective is to have an independent department handle the indigent defense so the court does not have the possibility of conflict. We think for the present time the indigent defense

program should remain with the court. We are not prepared at this time to create this independent department.

Rep. Aarsvold What collection mechanisms does the court have at its disposal?

Senator Traynor The court has vast collection powers. If the defendant is capable of paying and doesn't pay it, it operates just as a judgment. The court can issue an order to show cause citing the defendant to come in before the court and show cause why he or she has not paid the administrative fees. That is pretty persuasive. If the defendant refuses, the court can lock them up.

Rep. Aarsvold The source of the funding will be ultimately with the state general fund for the indigent defense, is that correct?

Senator Traynor There is a separate fund set up. In HB 1088 there is a separate fund for indigent defense and a separate fund for the court facilities. Those do not go into the general fund as I understand it. When those two funds are fully funded, overage is divided equally between them, that is as to the \$100 in each criminal case. The amounts that the Senate put in for each crime, for instance a class B misdemeanor is \$125, if somebody appears on a DUI, the administrative fee would be \$225 because you would add the additional \$100 to it.

Rep. Aarsvold It seems to me that the general fund would be a better source for indigent defense, it would insulate the process more. Is there some rationale to that thought?

Senator Traynor I agree, but there wasn't enough money in there. The \$3 million was not enough so we had to get \$750,000 some place else.

<u>Chairman Wald</u> Mr. Holmberg are you comfortable with the Senate changes?

<u>Senator Holmberg</u> Yes.





agencies have many hearings each year, while others have made only a few requests for hearings since 1991. For example, in 2001 and 2002 only 32 agencies or entities made requests for OAH services. The bulk of those requests came from two agencies, the Department of Human Services and the Workers Compensation Bureau.

During that time period, OAH occasionally contracted with temporary ALJs on an as-needed basis. In September 1995, OAH began conducting all of the administrative hearings for the Workers Compensation

Bureau. OAH uses both permanent ALJs and temporary, contract ALJs to provide services for the Bureau. However, temporary ALJs conduct the bulk of Bureau hearings for OAH.

At the peak of providing services to the Bureau, OAH contracted with 19 temporary ALJs in several cities around the state. In late 1997, after the reduction of a huge backlog of Bureau cases, the Bureau's caseload began to decline, and continued to decline until about the beginning of the 2001-2003 biennium. During this biennium the Bureau's caseload leveled off and even rose some during 2002. See attached comparison of calendar year 2001 to 2002 agency hearing requests (only the Bureau and DHS had substantial increases in caseloads from 2001 to 2002). OAH now contracts with eight temporary ALJs located in three cities.

With a leveling-off of its caseload, the Bureau has now asked OAH to conduct its hearings using full-time OAH ALJs rather than temporary, contract ALJs. The Bureau has asked OAH to return to full-time ALJs because it believes that the overall cost will be less, full-time ALJs will be better trained, and permanent ALJs will be easier to manage. ALJ to conduct other agencies' hearings. There will also still be an occasional need to contract with temporary ALJs on an as-needed basis.

Since the 1997-99 biennium, OAH's budget has had a second component under its one major program, for conducting Bureau hearings by means of temporary, contract ALJs. Different billing rates were established for OAH temporary work for the Bureau and for all other OAH ALJ work. OAH kept these separate components through this biennium (2001-2003) but with its 2003-2005 proposed budget will return to a budget with only one component under one major program, using one cost center. #### **BUDGET ANALYSIS**

OAH's present 2001-2003 budget shows a total funding of \$1,374,820. OAH is asking for a budget of \$1,236,984, with the Governor's recommendations, for 2003-2005. This is a decrease of 8.1%. OAH's 1999-2001 budget was \$1,426,016. OAH's request for 2003-2005 is just over 13% less than that budget. This rather large reduction over a four year period is due to the decrease in the Bureau's caseload and the corresponding decrease in the cost of providing fewer hearing officer services to the Bureau, and is also due to the decreased costs of providing the Bureau services using full-time ALJs

This increase in FTEs will result in an increase of \$289,581 in salaries and wages [plus benefits], but a decrease in \$400,812 in total operating, despite an increase of \$18,100 in equipment and \$13,870 in information technology expenditures. Again, overall, with the Governor's recommendations OAH's budget is decreased by \$111,231, an 8.1% decrease.

The huge decrease in total operating will occur because OAH will no longer pay for temporary, contract ALJs on an hourly basis. Paying OAH full-time ALJs a salary will be cheaper than paying eight contact ALJs on an hourly basis. Also, OAH will pay a full-time salary to the support staff person for these two new ALJs. Under the current system, temporary ALJs provide their own support staff. Under the proposed system a new support staff person filling the vacant position is necessary to fill the void left with the replacement of temporary ALJs who had their own office support. With both the two new full-time ALJs and their secretarial support, the cost will still be less than having to pay for eight contract ALJs on an hourly basis.

Other than the change from temporary ALJs to full-time ALJs, this budget contains nothing that is really new. OAH will maintain its operations essentially as it has since September 1995, conducting Bureau hearings and the hearings of other voluntary user agencies, as well as conducting the hearings of all other agencies required to use OAH. OAH is aware of no new legislation that will expand or contract OAH's jurisdiction, and voluntary users are happy with the services provided by OAH and intend to continue to use OAH. OAH will continue to bill all user agencies at an hourly rate, determined by our billing consultant, to fund all of its budget. For this proposed budget, however, the billing rate will be the same for all agencies.

In summary, with the budget proposed today, OAH should be able to fulfill its mission of providing quality, independent hearing officer services to all state agencies required to use its services and to all state or local entities voluntarily requesting an independent ALJ to conduct hearings. OAH respectfully requests that the House approve OAH's 2003-2005 operating budget request as proposed today.

Attached to this memorandum are various statistical documents of OAH, including a breakdown of requests received by agency, and the number of hearings and prehearing conferences held. The documents should be self explanatory. Other statistics can be provided if the Committee desires.

Finally, the committee should know that there is a bill introduced by the Judiciary A Committee of the Legislative Council that would place the management of all indigent defense counsel services in North Dakota within OAH. See HB 1044. This legislation would require an increase in OAH's budget of \$3,143,179 in general funds and \$42,900 in special funds for the 2003-2005 biennium, if the bill is amended as proposed by OAH (the North Dakota Supreme Court supports these amendments). It would also require OAH's FTEs to be further increased by one more FTE. If HB 1044 passes and is signed by the Governor, OAH would likely have two separate major programs, with two cost centers. OAH's current cost center 1000 would continue to be funded only by billing agencies, but the new cost center would have to be funded by general funds and other funds restricted to the provision of indigent defense counsel services as authorized under HB 1044. Much of the money for this program would be money transferred to OAH from the budget of the courts, but \$152,632 would be new general fund money. Of course, the committee will need to watch the progress of HB 1044 and act accordingly in adjusting OAH's budget, if necessary. A detailed explanation of the effects and requirements of HB 1044 is given in the fiscal note to HB 1044.



Under the proposed system a new support staff person (filling the vacant position) is necessary to fill the void left with the replacement of temporary ALJs who had their own office support. With both the two new full-time ALJs and their secretarial support, the cost will still be less than having to pay for 8 contract ALJs on an hourly basis.

Other than the change from temporary ALJs to full-time ALJs, this budget for administrative hearings contains nothing that is really new. OAH will maintain its operations for administrative hearings work essentially as it has since September 1995, conducting Bureau hearings and the hearings of other voluntary users and conducting the hearings of all other agencies required to use OAH. OAH is aware of no new legislation that will expand or contract OAH's jurisdiction. Voluntary users are happy with the services provided by OAH and intend to continue to use OAH. OAH will continue to bill all user agencies at an hourly rate, determined by our billing consultant, to fund all of its administrative hearings budget. For this proposed budget, however, the billing rate will be the same for all agencies.

In summary, with the budget proposed today, OAH should be able to fulfill its mission of providing quality, independent hearing officer services to all state agencies required to use its services and to all state or local entities wishing, for whatever reason, to engage

an independent ALJ to conduct its hearings. OAH respectfully requests that the Senate approve OAH's 2003-2005 operating budget request for administrative hearings as proposed today.

Attached to this memorandum, for the Committee's information, are various statistical documents of OAH, including a break down of requests received by agency, and the number of hearings and prehearing conferences held. The documents should be self explanatory. Other statistics can be provided if the Committee desires.

Finally, I have kept separate from the budget analysis of the administrative hearings work of OAH, the results of the passage of House Bill 1044 in the House. House Bill 1044 was introduced by the Judiciary A Committee of the Legislative Council and it would place the management of all indigent defense counsel services in North Dakota within the operations of OAH. See HB 1044, as amended (Ree: grossed House Bill No. 1044). This legislation requires an increase in OAH's budget of \$3,143,179 in general funds for 2003-2005. Additionally, OAH will have the use of an estimated \$42,900 in special funds from the indigent defense administrative fund for the 2003-2005 biennium. The estimated \$42,900, is a continuing appropriation of the indigent defense administration fund to OAH which does not need to appear in OAH's budget. See section 3 of Reengrossed House Bill No. 1044 (amendment to subsection 4 of section 29-07-01.1 of the North Dakota Century Code).

HB 1044 would also require OAH's FTEs to be further increased by another 1 FTE, for a total of 9 FTEs. This additional FTE is required to hire a person to manage the indigent defense counsel services in North Dakota.

If HB 1044 passes and is signed by the Governor, OAH would take over management of indigent defense counsel services from the courts on January 1, 2004. OAH would then likely have two completely separate major programs, with two cost centers. OAH's current Cost Center 1000 would continue to be funded only for administrative hearings by billing agencies, but another cost center would have to be funded by general funds and other funds all of which are restricted to the provision of indigent defense counsel services as authorized under HB 1044. All of the general fund money for this program is transferred to OAH from the budget for the courts. Again, the special fund moneys is a continuing appropriation to OAH. A detailed explanation of the effects and requirements of HB 1044 is given in the fiscal note OAH submitted for HB 1044.
