Minutes: 12 members present, 1 absent (Rep. Bernstein)

Chairman DeKrey: We will now hear testimony on HB 1059.

Rep. B. Thoreson: (See testimony)

Chief Deputy Jim Thoreson: I'm here today to testify in favor of HB 1059, this bill would allow for the service of civil process on election day, which is currently prohibited by law. Our officers serve approximately 9,000 civil papers a year. When the current law was written, its concern was that the sheriff of the town would sit at the one polling place and wait to make service on an individual coming to vote. We've never laid in wait at any of the polling places to make service. There should be no negative impact in the change of this law. This change is similar to Sunday retail opening, and liquor establishments being open on election day. There is nothing more efficient than doing our jobs.

Rep. Kretschmar: Has this caused you problems in not being able to serve someone on election day?

J. Thoreson: What brought this to light was that we needed to serve a child support paper of a trucker who was in and out of town and we wanted to make service and it happened to be election day and we couldn't; and that is what prompted this.

Rep. Klein: I know you said you can't imagine anyone lying in wait for someone to be served, but on the other hand, we have a lot of private process servers who don't necessarily do things exactly the same way as maybe someone in the sheriff department might, and I know from personal experience that there are some people are extremely difficult to get served because they avoid being served. I am wondering if it might accomplish the same purpose if we had some sort of distance restriction from the polling place on where a person could be served, as opposed to just repealing this all together, because if we do repeal it all together, it seems to me that a private process server could lie in wait at the polling place someplace to serve someone, maybe you wouldn't do that, but maybe someone else might. Would you have a problem if we had some sort of distance restriction on the polling place rather than saying we can't do it at all on those dates.

J. Thoreson: I would have no objection to that whatsoever. Our intent is to just to allow us to continue doing our duties on election day.

Rep. Eckre: How far is it on election day, like the federal law says you can't get within so many feet of the polling place, in State of North Dakota, you can't campaign at all; but there is federal law that says you have to be so far from the polling place? We could set it at the same amount, that way we'd be consistent with federal law. The intern could find out. That way it would be similar for law enforcement.

Chairman DeKrey: Is there any other testimony in favor of the bill? Is there anyone wanting to testify in opposition to the bill.

Rep. Eckre: I would like to ask Rep. Thoreson if he has any concerns with Rep. Klemin, for or against or bother you at all to change your bill.

Rep. Thoreson: I would have no problem with changing the bill as long as the people who are in support would care to amend the bill in this way.

Al Jaeger: I am not here to testify for or against the bill, but whenever the bill has the word election in it, it does get our attention. We did first look at the footnotes in the law, it actually goes back to territorial days, and we are probably in a different time and place now than what we were then, so we have run through archives, whether there could be some inhibiting factor in today's climate or environment as far as elections were, where somebody could go out and do something, it may have been more prevalent in the early history of our state, so I am just bringing that to your attention. The other thought that came to mind, while we do have an election day, voting does happen somewhat before election day, whether it's a concern or not, I don't know.

Chairman DeKrey: We will have the intern check on the required feet from the polling place and close this bill for now.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

GOOD MORNING MR. CHAIRMAN AND MEMBERS OF THE HOUSE JUDICIARY COMMITTEE. I AM REP. BLAIR THORESON, FROM DISTRICT 44 IN FARGO. I AM HERE TODAY AS SPONSOR OF HB 1059.

I HAVE INTRODUCED THIS BILL AT THE REQUEST OF CASS COUNTY, WHICH SEES A NEED FOR A CHANGE IN THE NORTH DAKOTA CENTURY CODE. CURRENTLY, SECTION 1-08-09 OF THE CODE PROHIBITS LAW ENFORCEMENT FROM SERVING CIVIL PROCESSES ON THE DAY OF A SPECIAL OR GENERAL ELECTION. THIS LITTLE, IF EVER, USED SECTION OF LAW IS NOW CAUSING DIFFICULTY FOR LAW ENFORCEMENT, AS THEIR LOAD OF SERVING PROCESSES HAS GROWN BY LARGE NUMBERS OVER THE PAST SEVERAL YEARS. BEING PROHIBITED FROM SERVING CIVIL PROCESSES ON JUST ONE OR TWO DAYS A YEAR CAN BACK UP THEIR WORKLOAD BY MANY CASES. THOSE WHO WILL FOLLOW ME IN THEIR TESTIMONY THIS MORNING WILL GIVE MORE SPECIFIC CIRCUMSTANCES AS TO WHERE THE CURRENT LAW HAS BROUGHT ABOUT TROUBLE FOR THEM.

Mr. Chairman and members of the Committee:

My name is Jim Thoreson. I am the Chief Deputy with the Cass County Sheriff's Office.

I am here today to testify in favor of House Bill 1059. This Bill would allow for the service of civil process on election days, which is currently prohibited by law.

Our office serves approximately 9,000 civil papers per year. These include court subpoenas, child support orders, small claims, summons and complaints, executions, levies, etc.

My guess is that when the current law was written, the concern was that the sheriff of a county would sit at the one polling place and wait to make service on an individual coming to vote. I can assure you that in my 32 years with the Sheriff's Office that we have never laid in wait at a polling place to make service, and there are currently 67 polling places in our county.

I cannot imagine anyone in law enforcement getting in the way of the people's opportunity to cast their vote and there should be no negative impact whatsoever regarding this change in law. This change, in my mind, is similar to Sunday retail openings and also liquor establishments being open on election days. It is nothing more than allowing us to be more efficient in doing our job.

GOOD MORNING MADAM CHAIR AND MEMBERS OF THE SENATE GOVERNMENT AND VETERANS AFFAIRS COMMITTEE. I AM REP. BLAIR THORESON, FROM DISTRICT 44 IN FARGO. I AM HERE TODAY AS SPONSOR OF HB 1059.

I INTRODUCED THIS BILL AT THE REQUEST OF CASS COUNTY, WHICH SEES A NEED FOR A CHANGE IN THE NORTH DAKOTA CENTURY CODE WHEN DEALING WITH THE SERVING OF CIVIL PROCESSES. CURRENTLY, SECTION 1-08-09 OF THE CODE PROHIBITS LAW ENFORCEMENT FROM SERVING PROCESSES ON THE DAY OF A SPECIAL OR GENERAL ELECTION. THIS LITTLE, IF EVER, USED SECTION OF LAW IS NOW CAUSING DIFFICULTY FOR LAW ENFORCEMENT, AS THEIR LOAD OF SERVING PROCESSES HAS GROWN BY LARGE NUMBERS OVER THE PAST SEVERAL YEARS. BEING PROHIBITED FROM SERVING CIVIL PROCESSES ON JUST ONE OR TWO DAYS A YEAR CAN BACK UP THEIR WORKLOAD BY MANY CASES. THOSE WHO WILL FOLLOW ME IN THEIR TESTIMONY THIS MORNING WILL GIVE MORE SPECIFIC CIRCUMSTANCES AS TO WHERE THE CURRENT LAW HAS BROUGHT ABOUT TROUBLE FOR THEM.

MADAM CHAIR AND MEMBERS OF THE COMMITTEE, HB 1059 WAS AMENDED BY THE HOUSE TO ALLOW FOR THE SERVICE OF CIVIL PROCESSES ON ELECTION DAY, BUT THE AMENDMENT ALSO PUT IN PLACE A BUFFER ZONE OF 100 FEET AROUND THE POLLING PLACE. THIS BUFFER PROVIDES A LEVEL OF PROTECTION TO THE VOTER, SO THAT A OVERLY EAGER PROCESS SERVER COULD NOT "LIE IN WAIT" WITHIN THE POLLING PLACE ITSELF, AND ATTEMPT TO SERVE THE VOTER AS THEY ARE CASTING THEIR BALLOT. WITH THESE AMENDMENTS, THE BILL PASSED THE HOUSE BY A VOTE OF 89-3. I ASK THIS COMMITTEE TO GIVE THE BILL A "DO PASS" RECOMMENDATION, AND ASK THE SENATE FOR THEIR SUPPORT ALSO. AT THIS TIME, I WILL STEP ASIDE AND LET OTHERS WHO WILL PROVIDE ADDITIONAL INFORMATION ABOUT THE NEED FOR THIS LEGISLATION SPEAK. I cannot imagine anyone in law enforcement getting in the way of the people's opportunity to cast their vote. This change, in my mind, is nothing more than allowing us to be more efficient in doing our job.
