Transportation and Highway Officials and using a third party communications vendor who is the go-between using the internet -- everything is in codes and every user has their own codes -- the bidders have their own codes and nobody can use another's code -- bidding deadlines will be setup and observed the same as now. These times will be set in the internet and after the set deadlines have expired no transmissions could be accepted or transmitted. Prior to the deadline the bidder would have access to his bid data to correct errors, change entries, --- DOT would have a code "key" to access the box.

This bill would allow the DOT to accept bids electronically for highway construction bid openings. After the initial, one time third party processor costs of \$52,000 and the one-time data conversion costs of \$38,000, the DOT would save approximately \$14,000 per biennium.

It is expected the construction industry would realize some savings and benefits such as increased bid accuracy resulting in lower review costs, and the ability to modify bids up to the bid deadline.

The DOT conducts about 20 construction bid openings per biennium. The DOT should realize savings of approximately \$14,000 per biennium as a result of reduced time for the bidding process, bid data entry, and bid checking (20 bid openings X 35 hrs. per bid opening X \$20 per hour).

In addition, it is possible the DOT will realize other savings such as reduction in paper usage, reduction in filing and data retrieval costs, and a reduction in needed storage space. However, we have no way of determining the extent of such benefits and thus we cannot determine an amount for those items at this time.

The first biennium the DOT will experience a net increase in expenditures of approximately \$76,000 as a result of the initial, one-time third party processor costs of \$52,000, the one-time data conversion costs of approximately \$38,000, and the offsetting \$14,000 biennial cost savings (\$52,000 third party processor costs + \$38,000 data conversion costs - \$14,000 per biennium cost savings = \$76,000).

Grant Levi reported that there are eight states that have fully implemented it. Other states are working on it.

Senator Nething asked what the House amended.

Grant Levi said that the House removed the emergency clause that was originally part of the bill and put an effective date of January 1, 2004.

Senator Nething asked if there were people from the industry that objected to it.

Grant Levi said that to the best of his knowledge there was nobody from the industry that objected to it.

Senator Expegard asked if a contractor could still submit a bid the old way if he chose.

Grant Levi answered that they would work with the industry and probably run the paper process for a pretty good time until everyone is comfortable with the electronic system.

Mark Dougherty (Membership Services Director for the Associated General Contractors of ND)

Testified in favor of this bill. They have used the program in the past submitting a disc along with the paper. There was a concern with double inputs that errors would be made but that is being fixed. There is some thought that for those who want to continue with the paper way there could be an extra charge for dealing with the paper.

Senator Bercier asked Mr. Levi about the size of computer needed to manage this and the software that would be compatible.

Grant Levi reported that those details have not yet been worked out but most computers today would be capable. He doesn't view it as a complex problem.

Senator Bercier asked about who would submit for the smaller subcontractors.
