Iilona Jeffcoat-Sacco, PSC: (neutral) (12.6) I am here to explain HB 1133. (See Attached)

Rep. Klein: In comparison to other states around us, do they have a fee system?

Iilona: Yes, the ones that I am familiar with do have a fee system. SD has a combined system that is half and half. Half is some sort of general assessment by formula based on size of company or revenue or customers, something like that. The other half is recovered through case specific charges from the company. I've mostly seem a combination between a general assessment and a cost/causer effect.

Rep. Klein: Providing the services now comes out the general fund instead of from the companies you are managing?

Illona: Yes, we do assess in a different function in the environmental siding function. There is a fee assessed that goes back into the general fund. We do have a valuation fund. This can be used in certain types of cases and is billed back to the company.

David Crothers, ND Assoc. Telephone Co-op: (15.2) opposed We represent 164,000 homes and businesses in ND. We are concerned about this bill on a philosophical basis. What is the reason for assessing the fee? We ask that any proposal to assess fees shows the relationship between the fee and the service rendered. Maybe this should be studied more.

Rep. Froseth: Do you know how many companies are in business that don't file any registration so the PSC doesn't know they are out there?

David: Some of the 450 resellers may not be offering service to ND. Maybe it would be good for the Sec. Of State to quarterly send all the companies to the PSC. We don't know who is operating in the state and who is not.

Chair Keiser: You don't propose to turn the PSC into an operation like the Insurance Commission Office?

David: I don't know how the fees are administered today within the PSC. I feel an agency serves all the people of ND. It would be difficult to draw dividing lines on which agencies are going to do that and which are not. We like in a deregulatory era in telecommunications.

Rep. Kasper: Can you give me an average annual cost to a member to register, pay fees, etc. To the state?

David: (18.9) I can't. There are various sizes of companies that belong. I will bring something back for tomorrow.

Chair Keiser: Any more testimony? Hearing none, HB 1133 is closed.

Minutes: Chairman Keiser called for committee work on HB 1133, the companion bill to HB 1132. Rep. Klein stated that this steps up the \$100 fee for all public utility companies doing business in ND. This would standardize things to include all telecommunication companies, telecommunication cooperatives, gas utilities, electric utilities, electric cooperatives and pipe line utilities. Funds would be deposited in the general fund. Some 47 states utilize this fee system that charges the beneficiaries for services provided. I don't think \$100 is break any of these companies. Rep Klein moved a do pass, Rep. Nottestad seconded the motion.

Rep. Froseth stated that the \$100,000 is added to the general fund income, but we never know, as a committee, if their general fund appropriation request is reduced by that much.

Rep.Klein: The money goes into the big pot, not the Public Service Commission pot, not to the coffers of the utilities.

Rep. Ekstrom: Wasn't Carruthers concerned about the relationship between the fee and the reason for the fee?

This bill requires each public utility to pay a \$100 per year fee. There are currently no public utility fees, consequently, this bill would have a fiscal impact of additional revenue to the general fund.

The \$100,000 additional revenue to the general fund would result if 500 utilities each paid \$100 per year. While we currently have more than 500 utilities authorized to provide service in North Dakota, we believe some of these utilities are out of business or inactive, and will abandon their authority if an annual fee is imposed. In addition, some of the authorized utilities offer more than one type of service and may operate under more than one authorization, in which case they would pay only one fee. Consequently, we estimate paymet by 500 utilities, for a biennial revenue impact of \$100,000.

No expenditures are anticipated due to this bill.

TESTIMONY

Chairman and committee members, my name is Illona Jeffcoat-Sacco. I am the director of the Public Service Commission's Public Utilities The Public Utilities Division administers the Commission's Division. jurisdiction over telephone, gas and electric public utilities in North Dakota. The commission asked me to appear here today to explain House Bill 1133, introduced at our request.

House Bill 1133 would impose a small fee on each utility that does business with the Commission. The Public Utilities Division is the only Public Service Commission division that does not generate some revenue through a fee requirement. In addition, North Dakota is one of only a few states that do not self-fund their utility regulatory functions. Likewise, other North Dakota regulatory agencies, such as the Insurance Department and the Banking Department are also self-funded.

The Commission recognizes that the question of whether regulated industry should contribute to funding regulatory oversight is a policy question for the legislature's determination. The Commission felt obligated,

Should you agree that the fee proposal is appropriate as a means of recovering some of the costs of regulation from those regulated, we believe the fee is not so high that it will create an unreasonable burden on industry. Should you determine that the fee measure is not appropriate, but the concept of regulatory self-funding merits further consideration during the 2003-2005 interim, we would be happy to participate in a study to that effect.
