Chairman Svedjan Called the meeting to order. All representatives were present excluding Rep. Kroeber.

Karlene Fine, Executive Directory and Secretary of the Industrial Commission of ND Rep. Kempenich Will this proposed bond issue go over and above the current bond limits authorized by the legislature?

Fine Any financing we would do would be in addition to what we have outstanding but we would still have to be within the authorized limit that is set.

Rep. Delzer I disagree with that because in your revenue bond you don't put under that limitation. You either need to have a bond that you are doing repayments for or else you need to have a lease with the language that it is dependent on legislative appropriation.

Fine The documentation we would still have will always have that language in it.

Delzer So you are going from having either a bond or a lease to just having a loan?

Rep. Kempenich Right now we are limited by statute, if we voted for this would it change the limits?

Fine We would be able to construct it by establishing the additional costs that go with the implementation with ConnectND.

Chair So the lease is between the authority and ITD. What are you, in fact, leasing?

Fine The equipment and services provided to implement that program.

Chair Please distinguish between a revenue bond and the other type subject to the bonding limitation.

Fine We have the lease revenue bonds that are appropriated by the legislature. Others rely on the holding of titles of buildings and those give us more flexibility.

Rep. Delzer So you want to deal with is the lease between the Commission and ITD, what is ITD doing to get this stuff to lease to you?

Fine I'm not sure. What we are looking for is the payment source on those bonds. I think ITD will bill agencies and university systems for their cost.]

Rep. Delzer We need to find out what ITD is doing on this, because that is the true question.

Fine I don't have all that background information.

Rep. Monson I don't see this bill as anything but another form of debt. I don't understand how we can do this without coming up with a limit, at this rate there is no limit whatsoever on the debt we can pile up. Our Constitutional obligation is to not be in debt.

Fine We hold to the Constitution, but maybe that needs to be revised.

Rep. Monson If we don't authorize the repayment of this loan, then what are the repercussions?

Fine If the bondholders are defaulted on they will have other options to claim funds.

Rep. Carison What are we bonding?

Fine I am not the best person to cover HB 1022, I would direct that to ITD.

Rep. Carlson How broad of a category are we making when we change the languages in this bill?

Fine We want to follow your wishes most efficiently. It is your choice, but we need some flexibility.

Testimony on House Bill No. 1162

Mr. Chairman and members of the House Appropriations Committee, my name is Karlene Fine and I am Executive Director and Secretary for the Industrial Commission. The Industrial Commission by statute is also the North Dakota Building Authority.

Before I discuss what is proposed in HB 1162, I want to briefly comment on what the Building Authority does. The Building Authority was established by the 1985 Legislative Assembly to provide the Legislature with another option as it considers how to pay the costs of projects declared by the Legislature to be in the public interest. Since 1985 the Authority has provided financing for projects totaling over \$115,000,000. (Currently the Authority has \$92,275,000 of bonds outstanding.) They have included projects on all the University System campuses, State Penitentiary, Youth Correctional Center, Developmental Center at Grafton, State Hospital at Jamestown, Job Service North Dakota Service Centers, Veterans Home, etc.

House Bill 1162 was introduced by the Commission for two reasons. The main reason is to give the Building Authority the flexibility to arrange for financing in the most efficient manner for the projects authorized by the Legislature. For instance, if the Legislature should authorize bonding for ConnectND (HB 1022), the current lease structure in NDCC 54-17.2 would not really work well; there are more efficient methods of providing that financing rather than the lease structure. The lease structure was designed for construction and remodeling of buildings, not for other types of financing projects. The lease structure involves the sale or lease of a building (or part of a building) by the affected agency to the Building Authority; the Building Authority then issues its bonds, secured by the building and leases back the building to the affected agency. This is a somewhat complicated process that works satisfactorily for building projects but is cumbersome when applied to financing of energy-saving equipment or computer software and equipment. While we can make the lease structure work, it would be more

efficient to have the flexibility to look at simpler and more direct alternatives such as a loan structure in which the Building Authority would loan bond proceeds to the affected agency under a simple loan agreement.

Since we were proposing changes to NDCC 54-17.2 we thought it was also timely to slightly revise the name of the North Dakota Building Authority to be the North Dakota Building and Finance Authority. This title would more accurately reflect what the Authority may do.

The revisions we have proposed in HB 1162 do not change the Legislature's role. The Legislature must still authorize any project that is to be financed. This bill would allow the Commission/Authority the ability to select the most efficient financing method for fulfilling the wishes of the Legislature.

I do have one amendment to House Bill 1162 that is attached to my testimony. On Page 2, line 3, I offer an amendment to change the word "financing" to "undertaking". This suggestion was made by our bond counsel to eliminate confusion when using the word financing.
