Relating to area centers, within this bill is an addition to section 15-20.2-07 -Power and duties of center boards, found on page 16 of the bill, beginning on line 28. It reads - "To accept real or personal 10 operty available for distribution by the United States or any of its departments or agencies and also accept federal grants that may be made available in the field of career and technical education." This addition was made because of the repeal of section 15-20.1-10, there is a copy of that section attached. This section refers to the specific powers of a school board of a vocational school district. There are no such districts in the state and that provision to accept real property was never included in the section for area centers.

As I stated, the proposed name change bill does involve changing terminology within other state agencies' sections of the century code. It does not change any language concerning vocational rehabilitation or voc rehab. We have discussed this proposal with the other agencies and they have indicated that they have no problem with the proposed name change.

This has been a national movement over the past two years, with many states, the US Dept of Education, and professional organizations dropping the term "vocational" and using "career".

The fiscal impact of a name change will be minimal. We have very few printed documents or forms any longer, everything is electronic and current supplies will be used up prior to the name change.

I recommend a do pass on HB1183. I will be glad to answer any questions.

## This section will be repealed by HB 1183:

15-20.1-10. Specific powers - Tuition payments - Bond issues. The school board of a vocational school district is specifically authorized to accept on behalf of the district any real or personal property available for distribution by the United States or any of its departments or agencies, and also, to accept any federal grants which may be made available in the field of vocational education. It may accept enrollments and set the amount of tuition for students residing outside of the district; provided, that the amount of tuition so set may not exceed the difference between the average cost per student for educating a student in the district and the payments, if any, received by the district from state payments on behalf of such student. State payments on behalf of each student attending a vocational school must be made to the vocational school of attendance at the same rate as paid for high school students. A vocational school district must be deemed a municipality within the meaning of section 21-03-01.

It does not change any language concerning vocational rehabilitation or voc rehab. We have discussed this proposal with the other agencies and they have indicated that they have no problem with the proposed name change.

This has been a national movement over the past two years, with many states, the US Dept of Education, and professional organizations dropping the term "vocational" and using "career".

The fiscal impact of a name change will be minimal. We have very few printed documents or forms any longer, everything is electronic and current supplies will be used up prior to the name change.

I recommend a do pass on HB1183. I will be glad to answer any questions.
