Rep. Keiser: What is the risk we are trying to mitigate?

Rep. Drovdal: It is an insurance policy against loses related to an outstanding game and fish license distributed to the auditors office of a particular county. The game and fish department can still receive the funds from the sale of that license despite a bankruptcy or disappearance of a vendor.

Kevin Glatt: Burleigh County Auditor. North Dakota County Auditors Association. Spoke in support of HB 1216. We are trying to be proactive to prevent future problems.

Chair Nelson: Have you spoken to the vendors about this?

Kevin Glatt: Most of the vendors are more than happy to participate in this program rather than try to go to a private bond to cover this program.

Chair Nelson: How many vendors do you have?

Kevin Glatt: It varies however the number is getting smaller and the vendors are getting bigger.

Rep. Nottestad: What is the notification process for the vendors. What do we do for this

season. Will the vendors be in violation from August to November.

Chair Nelson: Paul Shadewell can answer that.

Rep. Keiser: Is the Internet circumventing the vendors for licenses.

Kevin Glatt: The remaining vendors are getting larger. Who would have thought K-Mart would

go out of business. I worry about them and they are one of our largest vendors.

Rep. Porter: Is this bond a good deal compared with the private sector bonds.

Kevin Glatt: There is only one vendor that does that. Stamart pays about \$50 opposed to the

\$10 because their business crosses state lines.

Jeff Bitz: Administrator of state bond fund. Testified in support with a proposed amendment.

Currently the state bond fund has 275 vendors for game and fish licenses. This generates \$2,750 in revenue. This would raise the fee from \$5 to \$15. However it still does not adequately fund the exposure the state could eventually have from a situation from a scenario like K-mart example from Mr. Glatt. We have no open or active claims against the fund from anyone who sells game and fish licenses. There are currently 24 open claims against the fund. None of those were game and fish license vendors.

Senator Thomas Fischer, Chairman of the Senate Natural Resources Committee opened the hearing HB 1216 relating to bonds for agents distributing hunting and fishing licenses.

All members of the committee were present except Senator Joel Heitkamp.

Representative David Drovdal of District 39 cosponsor of HB 1216 introduced the bill stating the bill deals with the bonding requirements that county auditors can require. Under current North Dakota law a \$5,000.00 bond is required for security costing them \$10.00. If there should be a loss the bond posted would cover that loss, but because of the increased hunting license fees there could be a larger loss so an increase would seem warranted. The bond would now be \$10.00 for every \$5,000.00 for coverage. There are three options of \$5,000.00, \$10,000.00 and \$15,000.00 per agent per year as determined by the county auditor. He also presented written testimony by two auditors Kevin Glass and Frances Olson (See attached).

Jeff Bitz. Administrator of the State Bonding Fund testified in support of HB 1216 clarifying that license venders must pay the \$10.00 for the \$5,000.00 bond. With respect to the state bonding fund as far as the fidelity blanket bond, if the fund maintains a balance of \$2.5 million, there is no charge to agencies or political subdivisions for those participating to in the state bonding fund. Currently there is a surplus in the fund.

Mike Conahue representing the Wildlife Federation testified in support of HB 1216.

Representative Drovdal,

I have reviewed the engrossed bills as they have come from the respective houses.

As I am not able to attend the hearings scheduled on these two bills, having prior commitments, I would like to offer this testimony.

Basically, both versions afford county auditors increased coverage, which is what we wanted originally.

However, I would prefer that HB 1216 would be adopted rather than SB 2187 as 1216 gives more flexibility to auditors. For most of my vendors, \$5,000 bond coverage is sufficient. For one, the \$15,000 bond would barely make it at the beginning of hunting season. With the changes in 1216, I would not have to under-bond some vendors and over-bond others.

Therefore, I would ask that you vote "no" on SB 2187, and continue to support Hb 1216.
