Minutes: Chairman Keiser opened the hearing on HB 1236.

Rep. Nancy Johnson introduced the bill on behalf of the ND State Board of Registration for Professional Engineers and Land Surveyors and spoke in behalf of this legislation.

Gary Arman, Chairman for the ND State Board of Registration for Professional Engineers and Land Surveyors, appeared in support of HB 1236. (See attached) This board maintains a legal reserve fund and is financially self sufficient.

Responding to Rep. Nottestad's question regarding Section 2 and why a specific dollar amount is not included, Arman said there was no way to anticipate what circumstances or hearings might be forthcoming. The board does not intend to use this for any punitive action. 90% of disciplinary actions are resolved by resolution rather than hearings.

Rep. Froseth questioned whether they have a formal procedure to follow when a complaint is filed for violation of ethics, to which Arman replied that yes, they have a very specific procedure, it provides as much protection as it possibly can. The complaint must be notarized

He stated that currently there are 2800-2900 registered engineers and land surveyors. 800 are residents of ND. At present they don't expect to increase registration fees.

Any present or future fiscal impact due to HB 1236 will affect only the North Dakota State Board of Registration for Professional Engineers and Land Surveyors. The Board of Registration operates on revenues collected from registered professional engineers and registered land surveyors and does not receive any general fund monies. The term future is being used because the bill does not call for any immediate action by the Board of Registration and the monetary measure of any future action taken by the Board of Registration cannot be determined at this time. The figures used in 1.A represent the amount of increased revenues if the Board increases registration fees by \$5.00 per registrant per biennium. The Board is only asking that the registration fee caps be increased and does not anticipate increasing registration fees during this biennial period.

 - A. Revenues: Explain the revenue amounts. Provide detail, when appropriate, for each revenue type and fund affected and any amounts included in the executive budget.

If the State Board of Registration raised registration fees, the increased revenues would be equal to the amount of the increase times the number of currect active license holders. In a hypothetical example, if the State Board of Registration raised registration fees by \$5.00 per biennium for each of its 2,589 active license holders the revenue increase would be \$12,945.00. The fiscal impact of recovering legal costs associated with a disciplinary action where an adverse finding has been made is impossible to determine at this time as it is directly related to Board costs. In the past, diciplinary actions have incurred costs of \$400.00 to \$8,000.00.

Minutes: Conference Committee Chair Klein called the meeting to order.

All appointed members of the committee were present: Senators Mutch, Kresbach and Every and Representatives Klein, Froseth and Zaiser.

Chairman Klein read the amendment and explained that the inherent logic was to bring the Board of Professional Engineers up to consistent standards with other state boards. Complaints cannot be hearsay and testimony must be submitted to the board in writing. Klein stated that there haven't been many formal complaints filed.

Senator Mutch asked that if a person is reprimanded and he challenges the complaint, who is responsible for legal fees for his case and his Board? Mutch thinks that is unfair.

Rep. Froseth: There is a formal procedure to follow when a complaint is filed for violation of ethics. Like the Podiatry Board, if they don't have something like this, they are responsible for the costs, it could basically ruin the board.

Senator Kresbach: Should it be on a reciprocal basis? If the actions are brought against a licensed professional, and the actions are proven invalid, then does the board cover the costs?

Representative Klein: My understanding is that in that case, the board does.

Senator Mutch: Lawyers are going to like this. There aren't going to be enough courthouses to handle all these cases with all these loser pays.

Representative Zaiser: But if he's not guilty, he's clear.

Representative Klein: Most of these complaints don't go so far as to get to court proceedings. A person has a chance to respond to the board during an administrative hearing and if there is not enough evidence, the board will dismiss the charges.

Senator Mutch: I thought of having a loser pay put in here. Instead they just deleted the whole section.

Representative Froseth: Does he have the right to counter sue?

Senator Kresbach: He still has to operate with a license, so good luck.

Senstor Mutch: We were pretty good to the engineers, we give them more schooling, went along with all that, they're looking for a tradeoff, that's it. Guess we're getting back into the medieval guild system.

Representative Klein: From a professional board standpoint, they haven't had that many problems. I visited with their state director. They just want to protect themselves, considering what happened to the Podiatry Board. I think it's a good idea to bring them up to the same standards and practices as the other state boards.

Representative Froseth: I think the state overseeing health and welfare issues and guidelines is a positive thing.

Senator Kresbach: How many cases have they brought forth in the last several years?

Representative Klein: I think three cases within the last eight years. But they are wary of getting into a bind. Gary Armand said that recovery costs only occur when there is significant finding adverse to the registrant through a formal hearing process. Full or formal hearings are used only when an equitable resolution between all parties cannot be reached. etc.

Senator Kresbach: I think there should be some recovery, but where does the person who is being called into question, where is his fair treatment? Other than to sue?

Representative Zaiser: I think there should be some standard boilerplate for all these boards.

Senator Kresbach: A reversal, if a person is found innocent and the charges are dropped, then the board should be liable for the legal costs. But if the person is found culpable, then the person should be liable.

Representative Froseth: In Armand's testimony he stated that the Board had spent approximately \$ 8000-\$10,000 a few years ago on a disciplinary hearing where there was an adverse finding. The board covered that, or more accurately the registered members did. It isn't fair to subject the entire membership for expenses that are the results of a few unethical registrants who run afoul of the standards for that profession.

Senator Kresbach: There could be some overly aggressive members on some boards, though.

Representative Klein: A formal hearing process only comes about when there is substantial allegations.

Senator Kresbach: This is pretty much standard language with a lot of the boards. If we are going to make changes, we have to be certain that it will be proper to assess on a reversal.

Representative Klein: We can always change things later. Let's see what happens under the existing system. Let's try it the way we sent the bill over to the Senate.

Senator Kresbach: We removed the new added language, we amended the change out, we didn't repeal anything. The cost incurred by the board, if there is a severe disciplinary action, that costs them a lot of money is born by the registrants. Is that fair? How often are licenses renewed?

Representative Klein: Every two years.

Senator Kresbach: So the only retort the board has now is to let them run rampant and then suspend the license when it comes time for renewal.

Representative Klein: They can revoke the license. But what usually happens is that a firm has a couple licensed guys and the guy with the revoked license can still do the work but he just doesn't sign any of it. Like attorneys do when somebody is disbarred. You don't get to the offender this way.

Senator Kresbach: The company still keeps an unregistered engineer on staff? Can we look up reciprocals? Can we track where registrants that pay fees, if a colleague is found guilty. Now what if that registered colleague is found innocent? Is there a reciprocal where the board is responsible for picking up the fees? Wouldn't that be fair? That's a compromise.

Representative Klein: I'll look that up. I'll check with Legislative Council and get some information. We can't finish this up today. We'll reschedule another conference committee.

Representative Klein adjourned the conference committee meeting.

Minutes: Conference Committee Chairman Klein called the meeting to order. All appointed members of the committee were present.

Representative Klein explained the additional information he and the intern researched at Legislative Council. Page 3 lists the boards with the clause we are talking about. This is standard terminology that is used now. (See attached) Chiropractors can assess court fees and a civil penalty too! Attorneys can assess fees and costs and then some. I looked at the information the board had given to us. One of eight to ten complaints ends up in a formal disciplinary hearing. At that point the investigative committee (two members plus the executive director) looks at it. If there is found to be just cause, a hearing is scheduled with an administrative law judge for due process purposes. There have been three complaints in the last five years. Two of those were deemed guilty. The penalties imposed were a letter of reprimand and a 30-60 day suspension.

30% of complaints are dismissed after preliminary investigation. The average cost of a disciplinary action that advances through the judge runs about \$7-10 thousand dollars. The

\$500-1200 cases are handled by the investigative committee. The board has had three complaints, one has been dismissed, the other two are still under investigation. In essence, this is the standard language for all boards. Any board coming up for review is putting this stuff in.

Chairman Kelser Members of the Committee, Ladies and gentlemen:

My name is Gary Arman. I am the chairman of the Board of Registration for Professional Engineers and Land Surveyors and I am here today to speak in support of House Bill 1236.

House Bill 1236 has two parts. The first is related to registration and renewal fees. At this time, these fees are at their statutory maximums. We are asking that the existing maximums be increased in order to give the Board the necessary latitude to adjust registration and renewal fees as needed to cover necessary Board expenses. As you can see from the written testimony, the last time the Board requested an increase in fee caps was 1957. Hopefully we will not have to ask for another adjustment for another 48 years. Even though the Board of Registration is not anticipating raising the registration fees this year, we are asking that the statutory caps be increased at this time so the Board can be proactive in its fiscal responsibilities. The current Board operating reserve is anticipated to fall below \$20,000 this fiscal year. Current accounting principles recommend that a responsible reserve would be 6 months of operating expenses. In the Board's case, that would be approximately \$100,000.

The second part of House Bill 1236 relates to recovery of legal costs associated with disciplinary matters that may come before the Board. The recovery of costs would only occur where there is a significant finding adverse to the registrant through a formal hearing process. Full or formal hearings are used only when an equitable resolution between all parties cannot be reached. Currently, the Board assumes all costs for any disciplinary matter. Even though an adverse finding may be made against a registrant, every registrant against whom an adverse finding is made has a right to appeal that finding to a court of appropriate jurisd@lon.

A few years ago the Board expended approximately \$8,000 to \$10,000 on a disciplinary hearing where there was an adverse finding. These costs were borne by the Board, or more accurately, by the registrants. Of greater concern was a disciplinary hearing that occurred approximately 20 years ago that cost the Board in excess of \$75,000. Can you imagine what those costs would be today? Basically we are asking for this authority in order to protect the Board and its registrants from unusual legal expenses. The Board maintains a dedicated legal reserve fund of \$100,000. At today's legal rates, that certainly won't last very long. One only has to look at the recent events associated with the Podiatry Board to see what potential negative impacts extensive litigation could have on the financial stability of any Board.

We are financially self sufficient and we would like to remain that way.

Again, there are more details contained in our written testimony. Additionally, included with our written testimony are letters of support from the Associated General Contractors, the North Dakota Society for Professional Engineers, and the North Dakota Council of Consulting Engineers.

Thank you for your consideration in this matter. If there are any questions, I will try and answer them.

I would like to thank each of you for your dedication and diligent work in support of efficient, locally controlled State Government.

Briefly I would share with you that I served 15 years on the State Board (1981-1996). President Elect, President and Past president of the National Council of Examiners for Engineers and Land Surveyors (1987-1989).

I'm proud to compare the dedication of the North Dakota Board members with some of the activities of other states and jurisdictions. These jurisdictions extend from Alaska to Puerto Rico and from Main to Guam.

The North Dakota Board has long used the entire first day of approximately nine face to face meetings each year to discuss issues of health, safety and public welfare issues affecting Engineering and Surveying. Their meetings are rotated around the state to provide convenient access for registrants throughout the state. They are generally two day meetings beginning early the first day extending into the night, Convening the second day at 8:00 AM and adjourning near mid afternoon to allow members to return to there homes. Telephone conference calls are used for selected items of business.

Review of all applications by individual board members generally takes 12 to 16 hours prior to each meeting. Financial compensation for these activities would be two days at \$25/day plus per diem of \$20 for those members who are away from their residence. This item is not expected to change. By Comparison as a member of the National Board that I served on a member from New York received \$100 per day on National business. I received none as I believe is appropriate. In conclusion we always like to contain costs and I believe the Board has done that effectively.

In reality we find that costs do escalate. May I urge you to look favorably on this legislation and recommend its passage.



Dear Chairman Keiser and Committee Members:

Before you, for your consideration, is a bill that will help the North Dakota Board of Registration for Professional Engineers and Land Surveyors (the Board) remain financially responsible to the professionals that the Board regulates and to the public it serves. My name is Kevin Nelson. I am a Professional Engineer and Land Surveyor Intern. I am in favor of this bill and I urge you to support it.

This bill addresses two financial issues for the Board. First, it increases registration fee caps that were established 46 years ago. Second, it provides the Board the authority to recover costs incurred during disciplinary proceedings when a registrant is found guilty of an action worthy of disciplinary action.

With its proven track record of being fiscally responsible, the Board is seeking an increase in the fee caps so it can continue to provide exceptional service to the public and to the registrants it serves. After operating within fee caps established in 1957, the Board only recently reached those maximums. Raising the fee caps does not necessarily, mean the Board will increase registration fees. It gives the Board the opportunity to keep revenue consistent with the necessary and prudent costs of conducting the business of the Board. Registration fees are the Board's predominant source of revenue. As business costs continue to rise, the Board needs to recover those increases in expenses. The most logical way to cover the increases is through small, incremental increases in registration fees. Since the current fees are at the current fee cap level, the fee caps need to be raised.

The Board has the duty and the authority to oversee Professional Engineers and Professional Land Surveyors licensed in North Dakota. This charge includes disciplining these professionals, when necessary. Through the disciplinary process, the Board can incur, and has incurred, costs to investigate and prosecute the misconduct of some licensed professionals. Presently, the Board has no direct way to recover these costs. Therefore, a part of each honest and honorable registrant's licensing fee must be used to pay the costs of investigating and prosecuting the wrongdoing of an occasional few registrants that get led astray. Costs to investigate and prosecute these infrequent events of misconduct can be exorbitantly high, possibly completely draining all of the Board's financial resources. Without a means to recover these costs, the Board could face financial hardship. Allowing the Board to recover reasonable and actual costs for investigating and prosecuting misconduct will help the Board address the North Dakota Legislature's concerns about the financial responsibility of boards and commissions, especially as they pertain to legal costs.

Thank you for considering my testimony on House Bill 1236. I strongly encourage you to give the bill a "Do Pass" recommendation.

Dear Chairman Mutch and Members of the Committee:

My name is Lawrence Woodbury. I am the Secretary of the Board of Registration for Professional Engineers and Land Surveyors and I am writing in support of House Bill 1236.

House Bill 1236 is divided into two parts. The first is related to registration and renewal fees. At this time, these fees are at their statutory maximums. We are asking that the existing maximums be increased in order to give the Board the necessary latitude to adjust registration and renewal fees as needed to cover necessary Board expenses. As you can see from other written testimony, the last time the Board requested an increase in fee caps was 1957. In addition, also as provided in the written testimony, there have only been two other occasions where the Board has had to increase registration and renewal fees for something other than normal inflation. One was related to litigation and the other was related to the change in the Board's operating structure.

Even though the Board of Registration is not anticipating raising the registration fees this year, we are asking that the statutory caps be increased at this time so the Board can be proactive in its fiscal responsibilities. At this time, the current Board operating reserve is anticipated to fall below \$20,000 this fiscal year. Accepted accounting principles recommend that a responsible reserve would be 6 months of operating expenses. In the Board's case, that would be on the order of \$100,000. Based on the past fiscal history of the Board, we are projecting a balanced budget for the current biennium. Hopefully we will not have to ask for another adjustment for the next 46 years.

The second part of House Bill 1236 relates to recovery of legal costs associated with disciplinary matters that may come before the Board.

The recovery of legal costs would only occur where there is a significant finding against or adverse to a registrant or firm or both through a formal hearing process. A full or formal hearing is used only when an equitable resolution between all parties cannot be reached. Even though an adverse finding may be made against a registrant, every registrant against whom an adverse finding is made has the right to appeal that finding to a court of appropriate jurisdiction.

A few years ago, the Board expended approximately \$8,000 to \$10,000 on a disciplinary hearing where there was an adverse finding. These costs were borne by the Board, or more accurately, by the registrants. Of greater concern was a disciplinary hearing that occurred approximately 20 years ago that cost the Board in excess of \$75,000. Can you imagine what these costs would be today? Basically we are asking for this authority in order to protect the Board and its registrants from unusual legal expenses. The Board maintains a dedicated legal reserve fund of \$100,000. At today's legal rates, that certainly wouldn't last very long. We are financially self sufficient and we would like to remain that way.

Again, there are more details contained in other written testimony. Additionally, included with our written testimony are letters of support and resolutions from the Associated General Contractors, the North Dakota Society for Professional Engineers and the North Dakota Council of Consulting Engineers.

Again, I ask you for your support of House Bill 1236. Thank you for your consideration in this matter.

Fee Cap Increase

The maximum biennial fee for professional engineers and land surveyors was established by action of the State Legislature in 1957. The North Dakota State Board of Registration for Professional Engineers and Land Surveyors is planning to have legislation introduced during the 58th session of the North Dakota Legislature to enable the State Board of Registration to raise the present blennial fee caps to 200.00. Raising the fee caps would allow the State Board of Registration to establish renewal fees on a level consistent with its costs of operations.

- The State Board of Registration is a special fund agency which uses the revenues its collects to pay for the its costs of operation. Renewals constitute 70% of the State Board's revenues.
- The State Board of Registration operates in accordance to annual budgets which are established by four engineers and one land surveyor who are appointed by the Governor and together constitute the North Dakota State Board of Registration.
- Annual audits of the State Board of Registration have been filed with the State Auditors office since the State Board was established.
- The presently enacted fee caps have been in place for nearly forty-five years and the State Board has used restraint in approving fee increases over that period.
- Increased costs in health insurance, legal costs, salaries and other general costs will make it impossible for the State Board of Registration to continue its high level of service to its nearly three thousand registrants and operate in a financially viable manner.

The basis of this proposal is predicated on the careful and restrained approach that the State Board of Registration has exercised in this area over the past years.

Legal Cost Recovery

The North Dakota State Board of Registration for Professional Engineers and Land Surveyors is seeking to have legislation introduced during the 58th session of the North Dakota Legislature to allow the Board to recover legal costs associated with disciplinary matters where there is a significant finding adverse to the registrant. Currently, the Board assumes all costs for any disciplinary matter.

- The North Dakota State Board of Registration for Professional Engineers and Land Surveyors is a self-funded board and receives no form of monetary contribution from North Dakota's general
- The Board is funded solely by payment of fees from registered Professional Engineers, registered Professional Land Surveyors, and engineering and land surveying firms.
- The North Dakota State Board of Registration for Professional Engineers and Land Surveyors has established a prudent and reasonable legal reserve fund but a significantly contested issue will scriously deplete or eliminate it.
- The North Dakota Legislature has indicated its concern with legal costs associated with boards and commissions.
- Because all of the Board's registrants pay equally, registrants requiring disciplinary action should pay for the legal costs associated with the prosecution of their misconduct.
- The Board has an established and published disciplinary procedure that ensures due process for any affected registrant.
- Every registrant against whom an adverse finding is made has a right to appeal that finding to a court of appropriate jurisdiction.
- Full hearings are used only when an equitable resolution between all parties cannot be reached. The cost recovery process would only be used when the full disciplinary process is used.

The North Dakota State Board of Registration for Professional Engineers and Land Surveyors believes this bill will correct a current inequity in North Dakota's registration laws. Please lend this proposed bill your full consideration.

The State Board has a history of restraint in implementing increases, and have based past increases on the funds needed for efficient operation and not merely the limit set by statute.
- > Increasing the limit will allow the State Board flexibility in maintaining the needed funding level without repeated returns to the legislature for requested increases.

The bill also incorporates the ability of the State Board to recover reasonable and actual costs in a successful disciplinary action. We feel this advisable to provide this power for the following reasons:

- The State Board is funded primarily from the fees collected from its members. All registrants through their renewal fees currently provide costs incurred in disciplinary actions even though the vast majority have never been or never will be involved in a disciplinary action.
- The requested power to allow recovery of reasonable and actual costs in a successful disciplinary action would properly transfer the cost to those parties or individuals that necessitate action. Note that recovery is only allowable if the action is successful and goes to a full disciplinary action.
- > Providing this authority will also allow the State Board to properly pursue the needed actions without placing an unnecessary burden on the Board or the registrants.

The two bills I mentioned at the North Dakota Museum of Arts Dinner, which involve engineering issues are; HB1236 and 1256 and were received by the Senate on January 31 and February 2, 2003.

HB 1236: A Bill for an Act to amend and reenact sections 43-199.1-18 and 43-19.1-25 of the North Dakota Century Code, relating to professional engineer and land surveyor registration fees and recovery of legal costs in disciplinary matter. It passed the House 78-10.

HB 1256, Which pertains to professional license "Retired Status," engineering licensing changes and continuing education, was considered by the House and passed the House 89-1.

These two Bills were sponsored by the North Dakota State Board of Professional Engineers and Land Surveyors and are strongly supported by the North Dakota Society of Professional Engineers (NDSPE). Currently I am the past President of NDSPE and during my four years as a state officer we have worked very hard with the Board of Registration, land surveyors, universities and other engineering groups to update our state registered engineering requirements, especially the continuing education provision which is now required in all adjoining states.

Dear Chairman Mutch and Members of the IBL Committee:

My name is Lawrence H. Woodbury, President of Houston Engineering, Inc. Our firm has offices in Fargo and Bismarck, and is engaged in the professional practice of engineering and land surveying in the state of North Dakota. We have 60 employees, 23 of which are licensed engineers and land surveyors. I am a registered professional engineer and I also serve on the Board of Registration for Professional Engineers and Land Surveyors. I am currently in my second term on the Board of Registration, having already served seven years. In the past seven years I have served as secretary, vice chairman and chairman.

HB-1236 is a modest bill, which provides for two significant changes in the current registration law in North Dakota for Professional Engineers and Land Surveyors. The first provision calls for an adjustment of the cap on registration fees contained in Section 43-19.1-18. The current law calls for fee caps that were established in the 1950's and they are long out of date. In addition, the Board of Registration's administrative costs have understandably increased over the last 50 years to the point where the Board must look elsewhere to its reserves to cover costs of operation. Our firm pays registration fees for all of our professional engineers and land surveyors. This modest proposal for increasing registration fees is definitely needed in order for the Board of Registration to adequately do its job in protecting the "health, safety, and welfare" of the citizens of North Dakota.

A second provision of HB-1236 provides a means for the Board to recoup legal and administrative costs in matters of disciplinary action where a registrant is found guilty. It is not fair to the vast majority of our registrants for them to have to pay legal and administrative costs for guilty parties involved in violations of our North Dakota Registration Laws. This provision is totally consistent with existing requirements of other boards and agencies in the State of North.

On behalf of our firm, I strongly urge you to consider a recommendation of "DO PASS" on HB-1236.





I would like to thank each of you for your dedication and diligent work in support of efficient, locally controlled State Government.

Briefly I would share with you that I served 15 years on the State Board (1981-1996). President Elect, President and Past president of the National Council of Examiners for Engineers and Land Surveyors (1986-1989).

I'm proud to compare the dedication of the North Dakota Board members with some of the activities of other states and jurisdictions. These jurisdictions extend from Alaska to Puerto Rico and from Main to Guam.

The North Dakota Board has long used the entire first day of approximately nine face to face meetings each year to discuss issues of health, safety and public welfare affecting Engineering and Surveying. Their meetings are rotated around the state to provide convenient access for registrants throughout the state. They are generally two day meetings beginning early the first day extending into the night, Convening the second day at 8:00 AM and adjourning near mid afternoon to allow members to return to there homes. Telephone conference calls are used for selected items of business.

Review of all applications by individual board members generally takes 12 to 16 hours prior to each meeting. Financial compensation for these activities would be two days at \$25/day plus per diem of \$20 for those members who are away from their residence. This item is not expected to change. By Comparison as a member of the National Board that I served on a member from New York received \$100 per day on National business. I received none as I believe is appropriate. In conclusion we always like to contain costs and I believe the Board has done that effectively.

In reality we find that costs do escalate. May I urge you to look favorably on this legislation and recommend its passage.

Before you, for your consideration, is a bill that will help the North Dakota Board of Registration for Professional Engineers and Land Surveyors (the Board) remain financially responsible to the professionals that the Board regulates and to the public it serves. My name is Kevin Nelson. I am a Professional Engineer and Land Surveyor intern. I am currently the Secretary/Treasurer of the North Dakota Society of Professional Engineers and I have served the Society in that capacity for eight years. The North Dakota Society of Professional Engineers is in favor of this bill and we urge you to support it.

With its proven track record of being fiscally responsible, the Board is seeking an increase in the fee caps so it can continue to provide exceptional service to the public and to the registrants it serves. After operating within fee caps established in 1957, the Board only recently reached those maximums. Raising the fee caps does not, necessarily, mean the Board will increase registration fees. It gives the Board the opportunity to keep revenue consistent with the necessary and prudent costs of conducting the business of the Board. Registration fees are the Board's predominant source of revenue. As business costs continue to rise, the Board needs to recover those increases in expenses. The most logical way to cover the increases is through small, incremental increases in registration fees. Since the current fees are at the current fee cap level, the fee caps need to be raised.

The Board has the duty and the authority to oversee Professional Engineers and Professional Land Surveyors licensed in North Dakota. This charge includes disciplining these professionals, when necessary. Through the disciplinary process, the Board can incur, and has incurred, costs to investigate and prosecute the misconduct of some licensed professionals. Presently, the Board has no direct way to recover these costs. Therefore, a part of each honest and honorable registrant's licensing fee must be used to pay the costs of investigating and prosecuting the wrongdoing of an occasional few registrants that get led astray. Costs to investigate and prosecute these infrequent events

of misconduct can be exorbitantly high, possibly completely draining all of the Board's financial resources. Without a means to recover these costs, the Board could face financial hardship. Allowing the Board to recover reasonable and actual costs for investigating and prosecuting misconduct will help the Board address the North Dakota Legislature's concerns about the financial responsibility of boards and commissions, especially as they pertain to legal costs.

The North Dakota Society of Professional Engineers represents the profession of engineering in our great state through 250 members, who come from a diverse array of engineering specialties. The diversity of our membership spans a variety of employment opportunities (government, industry, private practice, construction and education) and employment capacities (e.g., business owners, company presidents and CEO's, managers, and employees) as well as an assortment of engineering disciplines (e.g., mechanical, electrical, civil, chemical, etc.). We represent the professional side of engineering, leaving the business and technical aspects to other organizations.

In addition to this testimony, the North Dakota Society of Professional Engineers has adopted resolutions of support for this legislation. These resolutions come from the Board of Directors of the State Society and from the local chapters that form the "grassroots" of the Society. You have been provided copies of these resolutions.

Thank you for considering the North Dakota Society of Professional Engineers' testimony on House Bill 1236. We strongly encourage you to give the bill a "Do Pass" recommendation.

The IBL Committee is considering a bill that will aid the North Dakota State Board of Registrations of Professional Engineers and Land Surveyors to stay financially sound. My name is Larry J. Smith. I am a registered Land Surveyor, a principal at the surveying and engineering firm of Swenson, Hagen & Co. in Blamarck ND. I am in support of this bill and urge you to support it.

These are two financial items HB1236 addresses.

First the item of the registration fee cap and the second the authority to recover costs during a disciplinary hearing when the registrant is found guilty of a disciplinary action. The board is and has been fiscally sound. The bill will allow the board to raise the fees for registration and still provide the excellent service to the engineers and surveyors of North Dakota. The fee caps were established forty plus years ago. As we all know the cost of doing business has increased substantially over the past four decades. The board is currently at its maximum fees. Revising the fee cap will allow the board to continue providing the quality service to the surveyors and engineers in North Dakota.

The cost recovery is an important issue. The board has the responsibility to investigate complaints against surveyors and engineers. If the complaint progresses to the hearing process substantial, costs can be incurred by the board. If the registrant is found guilty and a disciplinary action is taken, the board should be able to recover the costs associated with the hearing. I believe we have and will have future boards that will be fair and just in their investigative and hearing process. The bill allows the board to be fiscally sound. By granting authority to recover legal costs, a large, complex investigation and hearing will not deplete all board funds.

I wish to thank the committee for considering my testimony on HB1236. I strongly encourage you to support the bill and give a "Due Pass" recommendation.

Each year the State Board of Registration receives 4 to 5 complaints

Disposition

About 1 out of 8 to 10 complaints end up at the formal disciplinary hearing stage. Over the past five years, three complaints have gone to the formal disciplinary hearing stage. Of those three, guilty conclusions were reached in two of the cases with an innocent finding in the third. In the two situations where guilty conclusions were reached, the penalties imposed included issuance of a letter of reprimand and 30 and 60 day suspensions.

Of those complaints that do not reach the hearing stage, about 30% are dismissed after conducting a preliminary investigation into the matter, with the balance of the complaints being further investigated and resolved prior to a formal disciplinary hearing. Some common disciplinary actions include; issuance of a letter of reprimand, establishment of a probationary period, satisfaction of the complainant's demand (i.e. - redo a survey).

Financial

The average legal/investigation cost for a disciplinary matter that advances to the formal administrative hearing stage is \$7,000.00 - \$10,000.00. This is the situation that HB 1236 addresses and the circumstances under which the State Board of Registration would have the power to assess legal and investigation costs.

For complaints that do not advance to the hearing stage, the legal/investigative costs range, on the average, from\$500.00 - \$1,200.00. HB 1236 does not address the authority to assess legal and investigation costs in those instances where the complaint does not reach the formal disciplinary hearing stage.

2003 Update

Thus far, the State Board of Registration has received three complainants. One has been dismissed and the other two are currently under investigation by the State Board of Registration.
