The CCWC strongly encourages hunters to harvest their own deer, however this bill does offer an option.

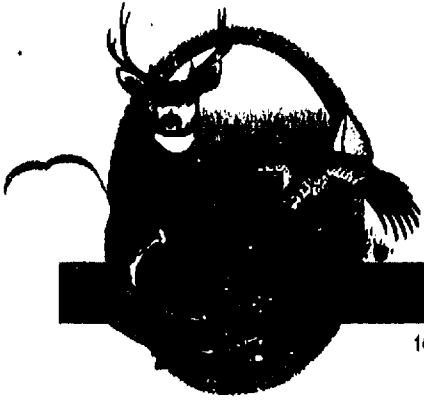

Currently there is no overall shortage of deer or total deer licenses in North Dakota, however buck deer can certainly be considered a limited resource. North Dakota has the highest deer hunting success rate in the upper Midwest, possibly the entire United States.

The concern is that the majority of sportsmen and landowners have a definite preference as to what type deer they want to hunt, that preference is for a buck. In fact when given the choice to take either a buck or a doe, as the current gratis system allows, 75% of gratis license holders harvest a buck. The application rate for the regular lottery confirms this preference as 85% of all lottery applicants' first choice is for a buck. At the present time it is much harder in many units to get a buck license than it is to harvest a buck. Even in whitetail deer units such as 2J1, northeast of Bismarck the average wait for a whitetail buck license is three years, for mule deer buck hunters the is 4-7 years. The lottery system and license allocation system has developed over the years bases on known and relatively stable hunter success numbers. At the present time this balance seems to be working quite well. Party hunting by it nature is intended to increase in the success rate of buck deer hunters and will result in a significantly fewer buck licenses being available. Eliminating a significant portion of the buck licenses available to sportsman certainly will affect this balance.

To analysis what effects party hunting could have on the availability of buck licenses we can make some conservative assumptions. The number one assumption is that hunter success will go up. The success rates for all buck hunters in 2001 were 77.9%. This is slightly higher than the long-term average. If the success rate for bucks were to go up an average of only 10%, buck licenses would have to be reduced by 12.5% to equal the same harvest of bucks. In relative numbers what would that have meant last year? To compensate for as little as a 10% increase in buck harvest, 5,911 fewer buck tags would have had to be issued to equal the same harvest.

From a management standpoint this law would confront the Department with significant challenges. We would have to withhold an additional number of buck tags from each unit prior to the lottery. Real challenges would be created for the department in the allocation of licenses type and numbers (deer sex and or species) and an overloading of the lottery preference system.

Minnesota Is often held up as a state with a successful party hunting law. Minnesota deer hunting is quiet a different hunting scenario than North Dakota. Because of Minnesota's heavily wooded terrain, low hunter success has been a problem. Even with higher deer populations than North Dakota and party hunting, Minnesota's hunter success rate is about one half of ours (40.6%).

I have only addressed the management considerations: - not the ethical implications - the disadvantages of getting a license for the hunter who wants to hunt alone or shoot his own deer - the increase in nonhunter applications to get licenses for others, and situations of game left behind because of accidental over harvest to mention a few.

For these reasons the North Dakota Game and Fish Department urges a **DO NOT PASS** recommendation on HB 1365.
