The question of what would be the effect of going from 1 AM to 2 AM was answered that there would be no effects and that irresponsible behavior can happen at any time of the day.

# TESTIMONY FOR HOUSE BILL 1395 Presented by Rep. Mike Grosz, District 42

Thank you Chairman Froseth. Members of the distinguished Political Subdivisions Committee, for the record my name is Mike Grosz, representative for District 42, the northwest portion of the city of Grand Forks.

House Bill 1395 would simply allow establishments that are licensed to sell alcohol the option to remain open until 2:00 am.

In the past few months we have had a "Youth Initiative" and a "Saving North Dakota" program which has spurred discussions on what we can do to retain or recruit people that are approximately 22 to 40 years of age. This bill of course is not the total answer; however, I believe it is a step in the right direction.

Many college students and younger people in the workforce are looking for more cultural and social activities. This bill will provide a social venue for this demographic population.

With that said, this bill does not reduce any of the laws that require our citizens to drink responsibly, nor does it require these establishments to remain open until 2 am. It just provides another tool to cities and communities to stimulate economic growth, and to serve the wants of its population.

If the fiscal note is accurate, not only will this bill increase the state treasury by almost \$900,000, but at a 7% sales tax, that would equate to an additional \$12.8 million circulating in our state. A large portion of those dollars, I would suspect would come from Minnesota due to our border cities.

Mister Chairman, this bill may not be the answer for some of our smaller, more conservative towns, but those establishments do not have to change their closing time. But, I know this will greatly help many of our cities.

The traditional 9-5 work day for everything may have worked in the past; however we are now in a society that doesn't sleep. There are stock market transactions happening 24/7 somewhere in the world. We have 24/7 convenience stores, restaurants, and super stores. We have given these options to business owners to meet the needs of a capitalistic society. Why are we unfairly regulating one segment of this capitalistic society?

I'm not sure of the answer to this question as there was no testimony provided in opposition during the hearing on this bill in the House Political Subdivision's committee. There was also no opposition stated on the House floor. I'm sure many are scared of change. Many may think that this change could cause an increase in alcohol related problems. This is the first question I had. But, from the research I have done, I have not found where a change in the closing time significantly affects alcohol problems. I believe that this shows the level of how far we have come in being a 24/7 society. We can move the closing time back to 7 p.m., but the shift worker that gets off work at 8 a.m. and goes to the bar to unwind, will still have the possibility of creating a problem. Also, we may move where people drink from a bar that could be held liable, and will have policies in place to deal with customers, to house parties where the level of liability is either not as great or not understood.

Mister Chairman, this bill requires you to think outside of the box and consider change.

Change can be scary, however take a look at North Dakota, and ask if we need change to survive. As supplemental information, I have provided a list of closing times by state and province.
