Pullen: Certainly accountability is one of the issues that need to be put on the table with each of these systems. Accountability in the largest sense, has many different facets, and so in terms of how the data is collected and what it is used for and why it is needed, are separate issues under the broad heading of accountability. I think all of those kind of things need to be considered if we are going to have some sort of a interagency approach to this. I agree with you.

Rep. Herbel Is there a wide range in what information is being requested by each of these agency or is it the case of duplication?

Pullen: There is some duplication. But the data that is being collected is voluminous. In other words the data is collected at many different times during the school year and so data does change over time, and the reporting requirements for data at different times during the year is supported by agencies needing to get that data for federal programs and other purposes at different times of the year. So there is some duplication, but by in large the issue is the breathe of the amount of information that is needed and then where that information is located within the school district systems and how hold the pieces they need for this particular report to this particular agency at this particular time in the school year. It is a very complex problem and it is getting worse.

Mary Wahl, North Dakota Council of Education Leaders

We support this resolution. No school district should be required to submit material that is either duplicative or has questionable value. It appears that this one of the main issues that this resolution is going to try to address. Secondly we feel it is very important that the submission format be as user friendly as possible and we have had some experiences with less than friendly submission requirements that you have already dealt with in this session. My name is Dan Pullen. I am the director of the North Dakota Educational Technology Council. I testify in support of HCR 3052.

As established by NDCC 54-59, the North Dakota Educational Technology Council is responsible for coordinating educational technology initiatives for elementary and secondary education. Since becoming the director of ETC in October 2001, I have continually heard from schools about this issue of data reporting requirement. In addition, the ND ETC has data collection requirements of its own and so I am increasingly sensitive to the burden being placed on schools by multiple state agencies, including the ND ETC.

The problem is already significant and I am certain it will only get worse. Some schools now feel so overwhelmed by the increase and complexity in data reporting requirements, that even systems that have potential to ease the overall burden over the long-term, such as the TetraData system being introduced by DPI, are viewed with skepticism even before they are implemented. So the time is certainly ripe to put all of these issues on the table and to get some inter-agency momentum started, so that discussions on this topic don't have to continue to take place only in front of legislative committees.

The ETC has established a data collection committee to begin looking at some of the issues identified in HCR 3052. That committee has met once and has modest plans to make some progress on a few data collection processes. The ETC data collection committee welcomes this study resolution as a way to get this issue positioned properly for a larger discussion of all data collection/reporting requirements in schools. For example, the ETC committee would like to see the establishment of guidelines with specifications for how reporting systems are developed. The committee also discussed a broad-based board with authority to act as a clearinghouse, developing guidelines, policies and procedures for school reporting requirements and then being able to represent the interests of all stakeholders (school districts, DPI, Voc Ed, ITD, ETC, and others) when issues arise within or between agencies or in the legislative process. Obviously this lofty goal is beyond the scope of the current ETC committee, but could be addressed as the result of HCR 3052.

So I support this study resolution and hope others will also. I hope we can do whatever it takes to get this resolution to rise to the top and actually result in an interim study.

Senate Education Committee:

My name is Dan Pullen. I am the director of the North Dakota Educational Technology Council. I testify in support of HCR 3052.

As established by NDCC 54-59, the North Dakota Educational Technology Council is responsible for coordinating educational technology initiatives for elementary and secondary education. Since becoming the director of the ETC in October 2001, I have regularly heard from schools about the issue of data collection/reporting requirements. In addition, the ND ETC has data collection needs of its own and so I am increasingly sensitive to the burden being placed on schools by multiple state agencies, including the ND ETC.

First let me say that this is not a Department of Public Instruction problem, even though they have taken some negative hits on this issue recently. This is a multi-agency problem - a problem that is already significant and I am certain it will only get worse. For example, just last week I had to send a letter to 186 school districts requesting that they send an updated technology plan to the ND ETC by the middle of April so that those plans can be approved as part of the state's E-rate application for the coming year. This is just one more example of the type of reporting requirement that is being placed on schools. Action by the legislature also causes increased data collection and reporting requirements as has been seen this year in HB 1295 and HB 1296.

Some schools now feel so overwhelmed by the increase and complexity in data reporting requirements, that even systems that may have the potential to ease the overall burden over the long-term, such as the TetraData system being introduced by DPI, are viewed with skepticism even before they are implemented. It seems that the time is certainly ripe to put all of these issues on the table and to get more inter-agency and legislative momentum generated, so that discussions on this topic don't have to continue to take place only in front of legislative committees. HCR 3052 could begin that process.

The ETC has already established a data collection committee to begin looking at some of the issues identified in HCR 3052. Represented on that committee are the ND ETC, ND DPI, ND ITD, ND SBVTE, a large school business manager, and a small school representative. That committee has met once and has begun work on some modest changes that we can make to streamline a few data collection processes. Most members of the ETC data collection committee welcome this study resolution as a way to get this issue positioned properly for a larger discussion of all data collection/reporting requirements in schools. This ETC committee could also be a valuable resource in the study process that could result from HCR 3052.

Some of the discussions by the ETC data collection committee so far have included the possibility of establishing guidelines with specifications for how school data reporting systems in North Dakota are developed. The committee also discussed the need for a broad-based board with authority to act as a clearinghouse, developing guidelines, policies and procedures for school reporting requirements. This broad-based board might also then be able to represent the interests of all stakeholders (school districts, DPI, SBVTE, ITD, ETC, and others) when issues arise within or between agencies or in the legislative process. Obviously these lofty goals are beyond the scope of the current ETC committee, but could be addressed as part of the study that could result from HCR 3052.

Another example of the type of issue that could be studied is a survey of what other states are doing. In my discussion with other state educational technology directors, I find that many of them are wrestling with similar problems. They also recognize that the problem is going to get worse. However, some states have comprehensive student/school information systems in place and most data collection and reporting is accomplished through a single integrated system. I believe North Carolina has taken this approach and Idaho is just beginning a multi-year project to develop such a system.

Alternative approaches could also be studied if HCR 3052 is passed, including development of some kind of background system that would be able to more efficiently pull data from all existing systems so that the same data does not have to be reported by schools in multiple reports in multiple formats. What little I know about the complexity of this problem, leads me to understand that there is no easy solution and certainly there is no silver bullet.

In conclusion, I support this study resolution and hope others will also. I hope we can do whatever it takes to get this resolution to rise to the top and actually result in an interim study.
