Confluence, where the Yellowstone river and the Missouri river come together, it is the footprints where Lewis & Clark walked. Under construction by the Federal government for a visitor center. Land is currently owned privately near this area, State is negotiating for this land. Would like to have it because of paddlefish and other birds that are endangered. The second piece of land is in the Killdeer mountains, wildlife management now, we have the opportunity to purchase some land next to it that is needed greatly. The 3rd area is the EWP (Emergency Water Projects). This is land along the eastern border of ND. You could put a canoe in the river at Wahpeton and go all the way up to Canadian, stopping along the way to hunt, fish, bird watch, etc. The Federal government (FEMA) has decided that this land can not longer be farmed (flooded so many times in the past). Senator Holmberg, chairman (#3258): One of the issues that has been a topic of conversation is access. One of the things that the subcommittee will be looking at is the reserves that you have in your funds.

Questions: (#3340)

---Regarding the budget request of \$39.7 million vs revenue of \$36.7 million. Is there money coming out of the Trust fund to make up the difference? Answer: (#3374) It is not a trust fund but a Game & Fish operating fund. There is a \$3million difference in our revenue and spending, revenues have been increasing. Actually taking in more than we are spending because of the healthy growth.

--Grants line item--were does the \$3 million dollars come from? (On SB 2019 --Line 13).

Answer: Fisheries division gets the largest share, some goes for boating projects.

-- Land acquisition: Is the land in the Killdeer mountains, land that no one wants? Answer: Land owners want it to go into being protected, but that the public has access to it.

---Comment regarding the private landowner vs the state or federal government purchasing land, the state or federal government can raise fees to purchase the land, but the private landowner cannot...this causes some problems between private and government. Answer: Make the agency accountable, make them go to the legislature for each land acquisition to get their approval, make them accountable, make them prove to the legislators that the land is good enough to buy.

- ---Questions regarding the Federal aid Answer: If we can come up with programs that follow these guidelines, then we can get federal matching money. Anywhere from 50% to 75% federal money and the rest from state money.
- ---Where in the statues are the guldelines for land purchases?
- ---Why the new 3 FTE's.? Answer: These are people that are already on board, and are located across the state. They aren't really new FTE's. They have been approved before.
- ----How many wardens are in the state? Do we have enough wardens? Answer: There are 32 wardens located across the state. We do see a need to increase wardens and we are working on it. Comment: Visibility is more important than enforcement....they need to be out in the public view.
- --PLOTS program--what is being down about habitat? Answer: PLOTS are conservation reserve land that are under contract with CRP and the landowner. Our department is not involved in the cover on that. Some days they are hayed, etc. We are just in the access. There are some programs that we are involved in that improves the habitat and some just access.
- ---Questions raised about the food that is available in the PLOTS for the birds, etc. Not just cover, but actual food.
- ---Question about no money in the water bank program, why? Answer: Our staff will be handling this instead of the Agriculture department. We aren't eliminating, just changing things around.
- ---Question about paying taxes on land. Answer: By law, Game & Fish pays the tax on the land, not the building, etc.

#### PROPOSED AMENDMENTS TO SENATE BILL NO. 2019

Page 1, line 2, after the semicolon insert "to provide a statement of legislative intent with respect to a short-term lease program;"

Page 2, after line 14, insert:

"SECTION 5. PRIVATE LAND OPEN TO SPORTSMEN. There is appropriated out of any moneys in the game and fish fund in the state treasury, not otherwise appropriated, the sum of \$3,000,000, or so much of the sum as may be necessary, to the game and fish department for the purpose of increasing funding for the private land open to sportsmen program, for the biennium beginning July 1, 2003, and ending June 30, 2005. The game and fish department is authorized an additional five full-time equivalent employees to carry out the private land open to sportsmen program.

SECTION 6. LEGISLATIVE INTENT. It is the intent of the fifty-eighth legislative assembly that the game and fish department use the funds appropriated in section 5 of this Act to create a new short-term lease program that targets the best access areas in portions of the state that are most impacted with hunting access problems within the private land open to sportsmen program."

A nonresident is entitled to purchase only one nonresident waterfowl hunting license per year."





### Major Related Legislation

House Bill No. 1050 - This bill establishes guide and outfitter licensing requirements and the license fees for hunting guides and outfitters.

House Bill No. 1122 - This bill establishes a mule deer license raffle and auction of one license per year by the mule deer foundation.

House Bill No. 1223 - This bill sets the opening date of pheasant season at not earlier than one-half hour before sunrise on the first Saturday of October and prohibits nonresidents from hunting for the first seven days of the pheasant season on land owned or private land enrolled by the department for the purpose of hunting or on land for which the department pays in lieu of tax payments.

House Bill No. 1343 - This bill provides penalties for the unlawful taking of big game animals.







in sedimentation and chemical and animal waste runoff while at the same time adding long-term, high quality wildlife habitat to the landscape.

This project unveils new producer incentives to participation in return for a 30-year use easement on the 20-acre CoverLock along with the right of public access on the entire quarter section on which the CoverLock sits for the same 30 years. CoverLocks answer to the concerns of private lands public access in exchange for realistic producer compensation for such rights along with the development of high quality wildlife habitat on private lands. It is the Department's view that the future of North Dakota's wildlife resources is on private lands.

The estimated \$44 million dollar project proposed by the ND Game and Fish Department - covering an establishment time line of 15 years - seeks federal cost-share dollars from USDA's Conservation Reserve Enhancement Program (CREP). We anticipate a post-tive decision on this CREP application prior to the start of the next legislative session.

The Department's request for a biennial appropriation of \$1,200,000 provides the match that we anticipate will be needed for the CREP funds. Financial commitments are subject to availability of both federal and state funds. Federal dollars continue only with the continuation of the CREP program in future farm bills, while state dollars can be appropriated only biennially by the ND Legislature.

The funds for this \$1,200,000 portion of the Private Land Habitat and Depredation program are to come from Game and Fish Department Fund, not the Private Land Habitat Fund. The Game and Fish Department Fund has a high balance. This is a good program for this funding.

2. Fisheries Division Budget - This program includes fish production and distribution, fishery research and surveys, and fishing area and boating facility development and maintenance. This division budget is increased by 3.3%. The increases are in the salary and operating expense lines. Most of these are normal inflation increases. Grants are used for cost sharing with local governments on fishing and boating facilities and to pay the department's share of costs for the Garrison Dam National Fish Hatchery. Grants are also used for creel survey and other fisheries management work. Capital improvements are used for fishing and boating facilities on Department managed lands. The Department receives 75% federal funding for most of the work in this division. In some cases the 25% match comes from local partners such as park boards.

### AQUATIC HABITAT/SAVE OUR LAKES

Budget = \$90,000 Salaries, \$35,700 Operating Expenses, \$5,000 Equipment, \$340,000 Capital Improvements, \$81,000 Grants, and \$400,000 in the Private Land Habitat & Deer Depredation line item.

### <u>Narrative</u>

Good fishing has been widespread across the state in recent years. Yet the long-term trend points toward deteriorating aquatic habitat and diminishing opportunities. The number one threat to sustaining quality fisheries is loss of aquatic habitat. As water bodies in North Dakota age, their ability to produce desirable fish declines. Accumulation of silt from the watershed, shoreline erosion, increased turbidity and excessive nutrients combine to limit desirable fish populations and in turn limit the quantity and quality of fishing. Approximately 75% of managed fishing waters in North Dakota have experienced a fish kill. These kills are largely a result of reduced volume attributable to sedimentation and high oxygen demand, due to high organic content caused by excessive nutrients.

Fishing is a \$360 million per year industry in North Dakota. While the number of anglers in the United States declined between 1991 and 1996 the number of anglers in North Dakota increased 58% between 1993 and 2001. Much of this can be attributed to new waters across the state but we must prepare for the future when we return to more "normal" conditions. The ability to sustain the state's fishery into the future lies in the ability to adequately address the issues negatively affecting those fisheries.

Fisheries staff identified issues suppressing recreational fisheries across the state and prioritized 55 lakes for potential action. The actions ranged from simple fencing and alternative water sources for livestock to dredging of lakes. The cumulative cost of corrective actions for these lakes exceeds \$36 million. Dredging is many times not a feasible alternative and when removed as an option the remaining actions still entail approximately \$6.5 million on the 55 prioritized lakes. Options such as buffer strips, sedimentation dams, bypass channels, low level evacuation tubes, etc. must be considered in lieu of expensive and infeasible methods such as dredging.

Funds for preserving and restoring aquatic habitats must be utilized in concert with other funding mechanisms and entities in order to truly be effective. This entails communication and cooperation with other entities and individuals. Some examples would be 319 projects administered by the State Health Department or Conservation Reserve Program or Emergency Watershed Program administered by the Natural Resources Conservation Service.

Funding at the requested level and personnel to administer and implement projects are required in order to proactively address the challenges. Not all issues can be resolved but a concerted effort will help in reaching our goal of sustaining quality fisheries into the future.

\$600,000 is budgeted as regular line items for work on public lands. Much of the land where lakes and reservoirs are is publically owned. \$400,000 is budgeted in the private lands line item. Dollars from this line item can be spent only on private land. A significant portion of our watershed work will be on private land. The dollars for this entire proposal, including the private land habitat portion, are to come from the game and fish operating fund, not the private land habitat fund. The game and fish operating fund is in excellent shape and can be used to fund this work.

- 3. Enforcement Division This budget supports a staff of thirty law enforcement employees. This program is increased by 6.2%. Most of this increase is related to a \$95,000 increase in travel. The budget includes operating expenses mainly for State Fleet and travel costs. Game wardens are very dependent on vehicles to do their work. Replacement boats, motors, campers, and computers are budgeted in the equipment line item.
- 4. Conservation and Communication Division Programs include aquatic and hunter education, ND Outdoors magazine, boating education, and supplying general information to the public. This Division's budget request is a 9.0% increase from 2001-2003. The increase is mainly in the salary line item to support current staff salary levels. Printing costs have increased and are needed for the ND Outdoors magazine and other publications. Funds are needed to replace and enhance computer systems and video production equipment. Grants are increased to provide funding for local shooting range projects.

Natural resource related reviews and recommendations are provided to private and government entities. This division also includes the nongame wildlife program. It is supported by an income tax checkoff and federal matching funds.

6. Wildlife Division - This budget includes private land habitat and deer depredation programs, operating costs for Department managed lands, and wildlife surveys and investigations. This Division's budget it increased by about 9.5% from 01-03. The Private Land and Depredation Program is increased by \$233,000 to enhance the regular habitat and access programs. This is in addition to \$1,500,000 added to this through the Emergency Commission and Budget Section in 2002. The Waterbank Program

line is not funded. This work can be done by Game and Fish staff, rather than ND Dept. of Agriculture. Salaries are increased to support current staff. \$400,000 is included to support Wildlife Services's animal damage control work. \$300,000 is requested for noxious weed control on Department lands. \$150,000 is included to reimburse the State Veterinarian for game and fish related work.

Lonetree Funding - A \$1,328,000 appropriation(+\$107,649) is requested to operate the Lonetree area. The Lonetree area consists of over 30,000 acres of land managed for wildlife purposes. The North Dakota Game and Fish Department provides technical services for this area for the State of North Dakota as laid out in the Garrison Diversion Reformulation Act. 100% of the funding for these services comes from the Bureau of Reclamation. This is the amount of funding anticipated for 2003-2005.

### Department Appropriation Increase (5.5% or +\$2,034,094)

The Game and Fish Department's budget request is a 5.5% increase over 2001-2003. Department funds and anticipated revenue are adequate to support this increase. Some key items follow:

### **PRIVATE LAND** INITIATIVE

Private Land Initiative (PLI) The North Dakota Game and Fish Department's mission is to protect, conserve, and enhance. fish and wildlife populations and their habitats for sustained public use. The Private Land Initiative is the Department's overall mechanism for applying this mission onto the private landscape of North Dakota

The PLI has 3 main goals:

1) Conservation of habituts for fish and wildlife

populations.

2) Provide landowners interested in wildlife conservation with cost-share assistance for developing and protecting wildlife habitat.

3) Provide the public with opportunities to access fish and wildlife resources on private land. The primary focus of this goal is hunting access.

The PLI is funded with revenue from the sale of Habitat Stamps and the interest accrued from the Department's general fundbalance. The PLI provides financial and technical assistance to private landowners through the following array of components and activities.

### Habitat Establishment/Enhancement Cost-sharing Programs

- **Grass Plantings**
- Wildlife Tree/Shrub Plantings
- Forest Management
- Wildlife Water Developments
- **Nesting Structures**
- Cooperative Projects

### **Specific Conservation PLOTS Programs** (Private Land Open To Sportsmen)

Habitat Plot Program multi-year rental contracts to create/ protect/enhance habitat and provide public access.

CRP Cost-sharing Program - assists in habitat establishment (grass, trees, and food) and provides public access on Conservation Reserve Program acres.

WRP (Wetland Reserve Program) Incentive is a partnership program between USDA and North Dakota Game and Fish Department, which provides additional incentives to producers enrolling their land in WRP. The primary purpose of WRP Incentive is to restore, protect or enhance wetlands on private property as well as provide for public access.

### **PRIVATE LAND** INITIATIVE

Free Planting Cost-sharing Program, provides assistance with the establishment costs of free plantings. The goal of this program is to enhance wildlife habitat and conservation on private land. This program provides higher meentives to producers who improve wildlife habital and provide public

Food Plot Program - single year establishment and rental contracts to provide wildlife food and public access.

Private Forest Conservation Program - multi-year rental contracts to protect/enhance unique forest tracts and provide public access.


CREP/CoverLocks - uses USDA's Conservation Reserve Enhancement Program (CREP) to establish 20-acre habitat complexes (10 neres grass, 5 neres trees and 5 acres food plots) along priority watersheds and provides public access to the 160 acres encompassing the complex for a period of 30 years.

### Cooperative Programs

State WaterBank Program provides funds for 10 year rentalcontracts for wetland tracts along priority watersheds through ND Department of Agriculture program.

North American Wetland Conservation Act - provides matching dollars for federal grants for waterfowl habitat projects in North Dakota contributing to the goals of the North American Waterfowl Plan.

Beginning Farmer/Rancher Program - provides up-front payment for long term rental contracts to producers purchasing land in exchange for conservation practices, habitat development and public access through Natural Resources Trust Program.

### **Habitat Plot Program**

The NDGFD Habitat Plot Program is a short term and multiyear rental of private land providing nesting, wintering, and other key wildlife habitat. The Habitat Plot can be newly established cover, existing cover, or a combination of both.

Goal: To provide and enhance wildlife habitat in locations most likely to benefit and sustain wildlife populations and to provide access to this habitat for the public utilization of the wildlife resource.

### **General Program Guldelines**

Tracts of newly established and/or existing habitat will be considered for enrollment.

### New Habitat Establishment


- NDGFD will provide 50% cost-share (up to \$30/ncre) to establish herbaceous cover on cropland. NDGFD will work with landowner to determine seed mix.
- Payment based on soil classification and regional location (see map opposite page):

Class II-III - \$24-\$34/nere Class IV - \$17-\$24/nere

Class VI-VII - \$9-\$12/acre (Existing Habitat Rate)

### Existing Habitat

- Areas for consideration include grasslands, wetlands, woodlands, and riparian zones.
- Existing habitat can be enrolled in combination with converted cropland.
- Rental payment same as Class VI VII (see above). Most existing cover Habitat Plots are in the \$9-\$12/acre payment russe.
- Priority for acceptance given to areas greater than 80 acres in size.



### **Habitat Plot Program**

### Short-Term Option

- Landowner receives an annual soil tental rate based payment ducing 6-year agreement period for new habitat establishment
- Landowner receives an annual existing habitat rate based payment during 3-year agreement period for existing habitat maintenance.


### Long-Term Option

- Landowner receives an upfront payment for a 10, 15 or 20 year conservation agreement.
- Compensation starts at 65% + 10-year agreement; 75% + 15-year agreement; 85% + 20-year agreement of the cumulative payment.

### Cooperators must agree to:

- Allow unrestricted walk-in public use of tract enrolled at program.
- · Not hay or graze the tract.
- Allow the NDGFD to sign and publicize the tract open to public use.

### **CRP Cost-Sharing Program**

The NDGFD CRP Cost-sharing Program offers <u>cost-share funds</u> to fandowners for establishing cover on acres enrolled in USDA Conservation Reserve Program (CRP) in exchange for public access to these truet acres.

Goat: To assist in the establishment of wildlife habitation CRP and to provide access to this habitat.

### General Program Guidelines

This program provides cost-sharing assistance to qualifying landowners for establishing three wildlife habitat cover types on Conservation Reserve Program (CRP) acres. These are grass, shrubs, and food plots. The guidelines for each cover type are as follows:

### Grass Seed Cost-share (statewide)


The ND Game and Fish Department (NDGFD) will provide up to 50% cost-sharing on grass seed for selected CRP grass plantings. This cost-sharing can be applied to new, established and renovation grass seedings.

Cost share rates vary depending upon the number of years remaining on the CRP contract:

8+ years remaining = full 50% cost share 6-8 years remaining = 40% cost share 6 years or less remaining = 25% cost share

To qualify, a landowner must:

- Have CRP acres, 80 acres minimum total acreage.
- Be willing to sign an agreement with the Department allowing access for walking hunting from Sept. 1 - April 1 on respective CRP and other ownership within the quarter section for the term of their CRP contract (does not pertain to motorized vehicle use, trapping, or any other nonhunting activities).
- Be willing to limit CRP haying to only maintenance manipulations specified by NRCS in CRP contract.
- Allow the NDGFD to sign and publicize the tract open to public use.



### **CRP Cost-Sharing Program**

CRP Shrub Planting Cost-share & Incentive Payment (statewide)

NDGI/D will provide up to 50% cost-sharing and a \$100/shrub acre incentive payment for CRP shrub plantings on a maximum of 5% of CRP contract acres statewide.

Cost share rates vary depending upon the number of years remaining on the CRP contract:

8+ years remaining = full 50% cost share 6-8 years remaining = 40% cost share 6 years or less remaining = 25% cost share

Assistance includes only the cost of trees not site preparation, chemical application, tree maintenance or weed barrier. To qualify, a landowner must:

- Be willing to sign an agreement with the Department allowing access for walking hunting from Sept. 1 - April 1 on respective CRP and other ownership within the quarter section for the term of their CRP contract (does not penain to motorized vehicle use, trapping, or any other nonhunting activities). Minimum 80 acre access area required.
- Be willing to limit CRP haying and grazing to only maintenance manipulations specified by NRCS in CRP contract
- Allow the NDOFD to sign and publicize the tract open to public use.
- Plant shrub planting according to NDGFD's standards specifying size, arrangement, species, and location.

### CRP Food Plots Cost-share (statewide)

The NDGFD Food Plot Program will provide an annual establishment payment for the planting of agricultural crops left unharvested for a wildlife food source on CRP acres statewide.

Establishment cost-share payment only, NO rental \$30/acre for small grains

\$50/acre for row crops To qualify, a landowner must:

- Be willing to sign an agreement with the Department allowing access for walking bunting from Sept. 1 - April 1 on respective CRP and other ownership within the quarter section for term of the CRP contract (does not pertain to motorized vehicle use, trapping, or any other non-hunting

### Wetland Reserve Program (WRP) Incentive

The North Dakota Game and Fish Department offers a one time incentive payment on WRP signups. The North Dakota Game and Fish Department will provide an additional 15% of the appraised land value (not to exceed \$700 acre) above the 75% of the appraised land value that would be paid for a 30 year WRP easement by the USDA. Producers enrolling their land in the USDA/NDGFD partnership would receive up to 90% of the appraised value of their land. This program can be applied to new WRP applications and current contracts and is only available for the 30 year easement feature of the WRP program.

Goal: The primary purpose of WRP Incentive is to restore, protect or enhance wetlands on private property as well as provide for public access.

### General Program Guidelines

To qualify, a producer or operator must:

- Be willing to sign an conservation easement with the Department allowing public access for walk-in hunting from Sept.1-April 1 on the entire WRP contract for the term of the WRP contract with USDA.
- Be willing to limit WRP haying and grazing only to maintenance manipulations specified in WRP contract.
- Allow the NDOFD to sign and publicize the tract open to public use.

The Department will select applications using a ranking system, which gives priority to:

- Size of Tract preference will increase with size (80 acres minimum).
- 2. Accessibility greater preference for road/trail access to the tract.
- 3. Upland/Wetland Ratio three or four acres of upland for each acre of wetland.
- Cost Rate greater preference for lower cost per acre ratio.
- Location preference for tracts close to public lands.
- Habitat Diversity- greater preference for habitat interspersion such as adjacent food sapplies and winter cover (brush, tree plantings, creek bottoms and cattails).

### Tree Planting Cost-Share Program

The NDGI-D Tree Planting Cost Share Program offers <u>cost-hare</u> fonds to landowners as an incentive for establishing wild-rie tree plantings on private land.

Goal: To establish and cohance thermal (winter) and forage habitat components for wildlife in locations most likely to benefit and sustain resident wildlife populations and to provide public access to this habitat.

### **General Program Guldelines**

### Option 1 (statewide)

- Requires 10 year access to planting and associated or detached legal subdivisions (80 acres or more).
- 25% -50% cost share on trees and shrubs, with NDOF criteria, standards, and specifications, in association with multi-year enhancement/protection programs or other federal cost-share programs (EWP,WHIP,319,Habitat Piots, EQIP, State Waterbank and/ or other ensement or term habitat programs.)
- 25% cost-share on weed barrier.
- Practice incentive payment: (one time up-front) \$100.00/planted acre.
- 10 row minimum (recommended minimum length of 400 ft.).

### Option 2 (statewide)

- Requires no access.
- 10 % cost share on trees and shrubs with NDGFD criteria, standards and specifications.
- 10 row minimum (recommended minimum length of 400 ft.)

### **Food Plot Program**

The NDGFD Food Plot Program provides an annual establishment and central payment for the planting of agricultural crops left unhancested for a wildfife food source during the winter.

Gual: To provide and enhance wildlife food sources in lications most likely to benefit and sustain wildlife populations and to provide access to this habitat for the public utilization of the wildlife resource.

### General Program Guldelines

Food Plots (cropland/non-CRP)

- Establishment
  - \$30/acre for small grains \$50/acre for row crops
- Rental-payment based on soll classification and regional location;

Class II-III - \$24-\$34/acre Class IV-V - \$17-\$24/acre Class VI-VII - \$9-\$12/acre

### CRP Food Plots

Establishment payment only, NO rental.
 \$30/acre for small grains

\$50/acre for row crops

### Terms of Agreement

- All food plots must be open to walking access and accessible to the public through adjacent land.
- CRP food plots-the entire field containing the food plot must be open to walking access and accessible to the public through adjacent land.
- NDGFD and landowner will work together to determine food plot locations that are proximate to winter cover (multi-row tree planting, natural woody areas, large cattail slough).
- The food plot must be planted by date specified by Federal Crop insurance. The cooperator must certify planting date.
- Cooperator must use a reliable seed variety which has dependable germination and vigor (corn must be 95 day or less variety).
- The food plot and other access acres will be posted with NDOFD Conservation PLOTS (Private Land Open To Sportsman) signs.

### Private Forest Conservation Program

The NDG(1D Private Forest Conservation Program provides a multi-year rental payment for maintaining and protecting native woodland habitat on private land.

Gond: Fo maintain and protect North Dakota's duminishing native forest resource in private ownership and to provide public access to this habitat for the public unfization of the wildlife resource.

### General Program Options

Landowners enroll in the PFCP through a conservation agreement and choose from two forest conservation options:

- Short term landowner receives an annual \$9 to \$12 per acre lease payment and has the option to renew annually within a 3-6 year contract period.
- Long term landowner receives variable annual payments based on forest acreage, land value, and term of conservation agreement. Agreement term ranges from 10 to 30 years. Compensation starts at 35% (10 year agreement) and increases 1.5% each successive year to a maximum 65% (30 year agreement) of the land value.

Cooperators must agree to:

- Prohibit permanent clearing of the forest.
- Prohibit grazing, forest subdivision, and agricultural use.
- Allow the NDGFD to sign and publicize the tract open to public walking access.

Eligibility:

A private landowner having a tract of continuous native forest that would:

- Abut existing public lands; or
- Be threatened by present or future conversion to non-forest
- Exhibit connective habitats between forested areas.


