Senate Political Subdivision Committee SB 2056 – Appointment of County Park Board Members

Senate Bill 2056 changes the appointment term for the non-commission members of the county park board. Currently, the county park board is made up of seven members in Cass County – five county commissioners and two residents of the county appointed by the county commission. This change in state law would allow the county commission to appoint park board members for a term of three years, instead of the current one year.

A longer appointment would make it easier for the county to attract park board members who are interested in seeing park district improvements made. Many times, these improvements occur over a period of several years due to planning, grant applications, and funding issues. The appointed park board members are usually the board members that bring forward new ideas for park improvements. These board members need to be assured that they will have a long enough term to see the projects completed. Currently, the two non-commission members must reapply each year and are generally reappointed, since we often have difficulty filling board positions. Increasing the length of terms would reduce the number of times a board member needs to reapply.

The county appoints members of other boards with longer terms, such as the Water Resource Boards – 3 year terms, Vector Control Board – 5 year terms, Weed Control Board – 4 year terms, Planning Commission – 4 year terms, and the School Reorganization Committee with a 3 year term.

Cass County does encourage citizen participation on boards by limiting successive appointments to two terms for boards of 3 years or more and three terms for boards of less than 3 years.

I urge you to support Senate Bill 2056.

Chairman and members of the House Political Subdivisions Committee. I am Tim Mathern, Senator from District 11 in Fargo.

Thank you for hearing **SB2056**. This bill simply changes the length of an appointed county park commissioner from one year to three years. Note the change on line ten. The other changes are regarding century code style only.

I introduced this bill at the request of my home county commissioners. The rationale is that a term of one year is too short to complete initiatives of a park commissioner, that projects taken on are generally longer than one year in duration, and that other commissioner appointed boards are for more years. This bill permits counties to support citizens willing to serve.

Others may be here to testify but I am happy to answer any questions you may have. I ask for a **DO PASS** recommendation from your committee.
