Amy Benz, Chairman, Educational Standards and Practices Board, presented testimony. (see attached). She explained what she went through to be a National Board certified teacher. She stated that through the process she found her weaknesses and strengths that she was using in the classroom and what she could do to correct them or expand them. She feels this is the most effective program for professional development.

Senator Flakoli asked how do those who become certified become mentors for others. Ms. Benz stated she has helped another teacher by reading over her materials; she has spoken at various meetings; and she has explained the program to various groups within the school.

Senator Cook asked if she received credit hours since no university system is involved. She stated she did receive 3 semester hours in the graduate program after she talked with UND and submitted some of her documentation. She also stated that Minot State has expressed interest in developing a program allowing those who complete this program some type of credit towards a masters degree. There are prerequisistes required before applying for National certification.

These are: 1. three years teaching in the classroom in area of certification, 2. a current ND teacher licence, 3. currently teaching. There is no financial reward for becoming certified.

Senator G. Lee asked if there is a recertification process. Ms. Benz stated that certification is for 10 years. She is not sure about costs associated with recertification. She further stated that you can bank your scores and pay \$300 per piece completed. There is not funding for this program at the local level.

Senator Taylor asked if there is a certain number of teachers ND hopes to have certified. Ms. Benz said there is no data on this but that local incentives may help in more teachers going through this process.

LeAnn Nelson, NDEA, stated it is an intense process to certify. This certification aligns well with the No Child Left Behind (NCLB) program. It would also help in retaining our rural professionals and would help them grow in their profession.

Jennifer Montgomery, Bd. member NDEA and Nationally Certified, testified and provided a handout aligning ESEA requirements with National Board certification. She is currently teaching in the Bismarck school system. She staed this is a rigorous process and is very important in professional development. This program helped her with how and why she teaches. It is a costly program if the individual had to pay for it all themselves. However, it could be used as an incentive in negotiations within local districts.

Senator Cook asked if Ms. Montgomery felt this program would benefit those who currently hold a Masters degree or PHd. She stated this program individually challenges each person on thier teaching methods, how their students are absorbing or learning what is taught, and it will cause one to push themselves to be better. The state offers incentives to pursue this program with scholarships. She hopes the local districts will come to the table with eincentives also.

There was no opposition to SB 2135.

Senator Flakoll asked Janet Welk, ESPB, if it would be possible to target teachers who don't teach in high performance schools to pursue this program. She felt that is not in this legislation and would have to be amended in. She thinks the applicants should be considered on a case to case basis.

The hearing was closed on SB 2135.

Senator Holmberg opened the hearing on SB 2135 (#168). This is a re-referral from the


Education Committee and put in by request of the Standards and Practice Board..

<u>Janet Placek Welk</u>, Executive Director of the Educational Standards and Practices Board wanted to testify in favor of SB 2135. Written testimony is attached, Exhibit #1.

Senator Holmberg wanted to know if a local school district could also reward a National Certification with extra compensation. Ms. Welk responded that they could. Senator Holmberg also added that under Title 2 Teacher and Principal training and recruiting, the \$13 million or so that come in every year, "Under No Child Left Behind", for the next 2 years, those funds could be used as a bonus for teachers who have attained National Certification. Ms. Welk stated that, that was correct, we would as a state though not have the commitment from the state level, because those are considered local dollars. We have received \$20,000 each year from the federal




government for state match for the assessment fee and that would allow us to have at the state level 17 educators. Yes the local can use their Title 2 dollars, which is approximately \$12.8 million dollars if they so choose for national boards, but that would not be a state commitment. A local commitment only. Senator Holmberg added that Ms. Welk was testifying that the state has to have a commitment of dollars in order to continue funding under teacher quality. Mrs. Welk agreed. Senator Bowman: (#577) Is this included in the Governor's budget, the money for this request? Ms. Welk stated that this was not included in the Governor's Budget. Senator Bowman wanted to know if this was discussed with the Governor about the responsibilities of the match? Ms. Welk discussed this with Mr. Bill Goetz and he thought this was the best way. Senator Holmberg stated that this was an issue that this committee dealt with 2 years ago, took all the money out and passed it and then the Senate Education committee put an appropriation in their bill to fund this and that did not come through appropriations. Senator Andrist: (#655) He wanted to know if he had this right, we are accessing \$2 million in federal funds and we need \$69,000 in general fund dollars to match that? Ms. Welk: That is part of the dollars, we are matching other dollars as well. Senator Andrist continued: \$69,000 is what would come out of the general fund? We don't have a fiscal note, so I was just wondering, Senator Holmberg stated that this is a direct appropriation, so it doesn't need a fiscal note. Senator Andrist continued: Is this what is coming out of the general fund? Ms. Welk responded, yes. I think it is more than \$69,000 (depending on the Attorney General's opinion), closer to \$82,000. Senator Holberg also stated that this bill will go into the DPI subcommittee. Senator Tallacker 12 2000) Is this part of the "No Child Left Behind", do they need this certification under that program? Senator Holmberg continued: One of the fears was that if it is a total state program, and we want to encourage someone in, say Carrington, to get that National Certification, and that person got the certification, then that person might be taken away by a larger school district that would pay more, maybe that small school might want to add to the pot to make sure that certified teacher stayed there. Another point that was talked about was if the teacher took the course, then that person could not move up to administration if she had been in the classroom before, and still receive the stipend from the state. Jennifer stated that the program is not set up for it to be a stepping stone but for teachers to become the best possible teacher they can be.

With no other testimony before the committee, the hearing was closed on SB 2135 (#2054), by Senator Holmberg, chair.

Kelsch We've been told it can take up to about 600 hours in order to complete the national board certification. It is basically a demonstration of the candidates teaching practice. The teachers that we have visited with about the national board certification basically said that they go back into their classroom and they feel as though they have increased their professional development. Along with other requirements, they have to take 4 tests, each taking about 1½ hours in order to become board certified. I spoke with one of the first teachers that became national board certified and she said if she had to do it all over again, while it was a rewarding experience, she said she is not sure that she would do it because it took so many hours in order to complete it and financially there isn't any real payoff.

**Rep. Monson** When they get this certification, does their school pay them more as far as a salary or does their school pay any of this expense for them?

Kelsch We asked around if there were any of the school districts that either paid out a bonus to these teachers for becoming board certified and basically we found out that in Grand Forks Public Schools, a certified teacher received a \$500 recognition gift from the school board during the recognition ceremony at a school board meeting. The district provides 3 professional leave days for teachers to complete their certification. We haven't come across any of the other school districts that have done anything for the teachers.

**Rep. Monson** Do they take classes for credit that move them across on the salary schedule or work toward a masters degree that would somehow down the road, if they took enough other classes along with this, move them across?

Kelsch I can tell you that one of the teachers had already received their masters degree and wanted to seek further professional development and that's why they had gone ahead and done

Welk I am not sure what the relationship is. I know that the state has many boards. We all participate in the health benefit and receive that. As far as an actual budget bill, we've never been asked for one, we've never done one and I sure hope we don't have to start.

Chairman Martinson Who do you get a check from?

Welk My board.

Chairman Martinson Is it a check from the state of North Dakota?

Welk No it is not. It is from the Education Standards and Practices Board.

After visiting with Gary Gronberg and Greg Gallagher, DPI, the House committee was assured that if a school requested NCLB funds for National Board Cert. for a teacher, it would be a first priority issue for DPI. If for some reason a teacher does not get the money on the first go around, many schools won't use all their NCLB money, the Title II portion of it, the school would then be required to return the money to the state. This creates a pool of money which then can be awarded to the schools who did not receive the money in the first go around. This would be used for grants or stipends, especially for Board Certification. The House then concluded the state did not need to fund the stipends with general fund money.

SENATOR FLAKOLL asked REP. MONSON about the number of available scholarships. He was under the impression there were only 17 scholarships over the biennium. REP. MONSON stated the number is 17 applicants for each year of the biennium and he said the fiscal note indicated such, as did Janet Welk, ESPB. SENATOR FLAKOLL asked about the stipend for those who have achieved the certification. Are those dollars included in NCLB. REP. MONSON stated he felt the money will be in NCLB. SENATOR FLAKOLL asked if we are totally reliant on the federal government to make sure NCLB stays in place and has the money in place. REP. MONSON also stated that those who have already gone through this process of becoming certified, have not received a stipend as yet either. He hopes NCLB works as we envision it. However, there is a potential the state may have to fund the program or address it if NCLB doesn't come through with the funds.

SENATOR TAYLOR asked about the flow of the money. Does it go to ESPB or DPI. REP.

MONSON stated that ESPB will be the one who will access the other \$40,000 from the National Education Board. They are the ones who set up the testing, etc. DPI can not directly pay the

REP. HERBEL asked if non public teacher are eligible for this also. REP. MONSON is not sure. JANET WELK, ESPB, stated that the understanding is for 17 applicants per year. ESPB has received an increase in the Federal allotment, up to \$20,000 per year. So they are asking for a state match. This would cover the costs for 17 per year or a total for the biennium of 34. WELK also stated their rules now state "public" school, so she feels teachers in "non public" schools would not be eligible. MS. WELK explained the funding again to the committee. ESPB receives \$40,000 from the Feds and they receive a match from the state of \$20,000 per year. This amounts to \$2300 per applicant. (She uses \$1150 state dollars and \$1150 Federal dollars for each applicant per year). SENATOR FLAKOLL asked about the appropriation on the bill as is. The committee feels the dollar amount is okay and the funding is okay.

SENATOR FLAKOLL feels there should be limitations and criteria in the bill. He feels two teachers per school per year would be adequate and of the 17 applicants, he would like to have 3 be from low performance schools. Regarding the mentoring the teachers who have completed the certification process can do, he feels it is important to spread this around to as many schools as possible in all parts of the state.

Good morning, Chairman Freborg and members of the Senate Education Committee. For the record, I am Janet Placek Welk, Executive Director of the Education Standards and Practices Board and wish to testify on SB 2135.

Senate Bill 2135 provides for one-half of the assessment fee for national board certification for seventeen North Dakota educators for each of the next two years, stipends for those educators who receive national certification and a one-time stipend for those educators who have achieved certification in the past. North Dakota received from the federal government an increase of \$10,000 a year, totaling (\$20,000) for each of the next two years, to pay for one-half of the assessment fee with North Dakota match for seventeen (17) educators. There were four educators who received national certification in November 2002 and are eligible for the \$1500 stipend for each of the next two years. This appropriation also includes stipends for the those educators who receive national certification in November 2003.



Good morning, Mister Chairman and Members of the Senate Appropriations Committee. For the record, I am Janet Placek Welk, Executive Director of the Education Standards and Practices Board and wish to testify on SB 2135.

Senate Bill 2135 provides for one-half of the assessment fee for national board certification for seventeen North Dakota educators for each of the next two years, stipends for those educators who receive national certification and a one-time stipend for those educators who have achieved certification in the past. North Dakota received from the federal government an increase of \$10,000 a year, totaling (\$20,000) for each of the next two years, to pay for one-half of the assessment fee with North Dakota match for seventeen (17) educators.

There were four educators who received national certification in November 2002 and are eligible for the \$1500 stipend for each of the next two years. This appropriation also includes stipends (\$6,000) for those educators who receive national certification in November 2003. Attached to this testimony is a copy of a letter to the Attorney General asking for an opinion. The \$6,000 requested may need to be changed to \$12,000 if the Attorney General's Office Opinion is favorable for the applicants.

### Q: Does National Board Certification really recognize accomplished teaching?

A: Yes, according to research conducted by the University of North Carolina at Greensboro, NBCTs significantly outperformed their peers on 11 out of 13 key dimensions of generally recognized measures of good teaching.

For example, NBCTs were better at understanding why students succeed and fail on a given academic tast, engaging students without overwhelming them, anticipating difficulties students might have with new concepts, and improvising when faced with the unexpected.

In addition to evaluating the teachers against the 13 dimensions, researchers examined samples of student work in classes taught by NBCTs and teachers who had sought National Board Certification but Ladn't achieved it.

Almost three-fourths of the work samples collected from students taught by NBCTs in the study reflected a high level of comprehension of the concepts being taught, compared to three in 10 of the work samples of students taught by teachers who hadn't achieved National Board Cartification.

Based on student work samples, the study's authors declared that National Board Certification "is identifying and certifying teachers who are producing students who differ in profound and important ways from those taught by noircertified teachers."

### **Q:** How does a teacher become a candidate?

A: A teacher who wants to become a candidate needs to complete an application.



Teachers may apply online by accessing the Candidate Application Form located at the Candidate Resource Center at www.nbpls.org.



The Guide to National Board Certification is available online. For a printed version, which also includes an application, call 1-800-22TEACH.

Part of the application requirement is payment of at least \$300 of the \$2,300 assessment fee. Once NBPTS processes a candidate's application and fee, the teacher's candidacy becomes active. The date when the initial \$300 portion of the fee is paid (by the candidate or another party) determines the candidate's portfolio deadline.

The chart below outlines the portfolio deadline dates for candidates in 2003, as determined by the reculpt of the initial \$300 toward the \$2,300 assessment fee.

## Q: How does a candidate achieve National Board Certification?

A: Candidates achieve National Board Certification after they successfully complete the assessment process. A candidate's efforts to achieve National Board Certification will likely take the better part of a school year and involve a total of 200–400 hours of work.

The assessment process consists of the following:

Portfolio Entries: Candidates submit four portfolio entries. Three of the entries are classroom-based and include videotapes that document the candidate's teaching practice and examples of student work. The videos and student work examples are supported by commentaries about the goals and purposes of instruction, analysis about what occurred and the effectiveness of the practice, and the rationale for the candidate's professional judgment. The fourth entry requires candidates to demonstrate their work with students' families and their community and collaboration with the professional community.

The work on portfolio entries usually takes at least four months to complete because it's designed to cover an extended period of a candidate's time in the classroom.

Once the portfolio entries and the assessment center exercises are submitted to the National Board, they're scored by teachers who have participated in intensive training and have qualified for scoring by demonstrating an understanding of NBPTS Standards, the directions to candidates and scoring guides.

Assessment Center Exercises: Candidates are presented with six computer-delivered assessment center prompts (each allowing up to 30 minutes for response) that are designed to elicit knowledge of subject matter content.



## Q: Where are the assessment centers?

A: There are more than 300 assessment centers across the United States.

A candidate's assessment center testing window is based on when the candidate's fee is paid in full and all eligibility requirements are met (see page 6).

## **Q:** How do teachers know if they are eligible?

Teachers are eligible to seek National Board Certification at the time they apply, they:

hold a baccalaureate degree;

- have completed three years of teaching experience prior to submitting an application; and
- have held a valid state teaching license for those three years, or where a license is not required, have taught in schools recognized and approved to operate by the state.

## Q: How do candidates know which certificate to seek?

A: The first step in deciding which certificate is appropriate for a teacher is to determine the age range of the students and subjects they teach. This is especially important, as candidates must be able to demonstrate content and pedagogical knowledge across the full age range of the certificate area they pursue.

### Q: What is a generalist certificate?

Generalist certificates are for teachers who develop student skills and knowledge across all areas of the curriculum. They do this by drawing on a broad and deep knowledge of pedagogy. Generalists may teach all subjects on an interdisciplinary team, or a single subject infused with ideas from other subjects.

## **Q: When** is a teacher ready for the process?

A: The best way to determine a teacher's readiness for National Board Certification is for that person to review the standards document for their certificate area. NBPTS Standard in each field form the basis for National Board Certification.

Candidate experience has shown that attempting to achieve National Board Certification will likely take a total time commitment of 200–400 hours during the school year.

Prospective candidates may also want to speak with National Board Certified Teachers.
