**Rep. Herbel** Do these people meet monthly, and length of the meeting

**Welk:** We have 2 day meetings during the session 8:30-3:30, because of NCLB. Our March meeting will be the first one day meeting we have had since Oct.

**Rep. Herbel** If you don't meet does the 62.50 apply **Welk:** We have to have the conference call or meet for it to apply. **Rep. Hanson** Are they double dipping

**Welk:** It is not considered double dipping. They are working in conjunction and above and beyond. They are taking phone calls at night on and on Saturdays.

**Rep. Herbel** Do you have any problems finding people for this board? **Welk:** No

**Rep. Mueller** The fiscal note on this indicates that we are going to fund, approx. 4200 additional pay from licenser fund. Do you anticipate licenser to increase to fund this.

**Welk:** We wouldn't raise fees for that alone. Licenser in ND will go up because of NCLB. I foresee huge changes in licenser in ND. Currently they pay 20 per year for their license. It may go up to 25. I have not done a five year projection, because we are waiting until after the session is over. But I do predict that within the next couple of years it will go up to 25. If 1489 passes, it will take additional work on staff and board to make this all happens.

**Nancy Sand, NDEA** We stand in support of this bill. We work with the board very well and they do indeed put in a lot of time and effort. This brings them into line with other boards like them. I urge your to support, NCLB will make their job much harder and become much more intense. **OPPOSITION none Close hearing (820)**

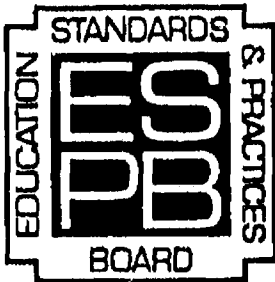

My name is Doug Johnson and I am a principal at Simle Middle School in Bismarck, North Dakota and former three term member of the Education Standards and Practices Board. I am here to express my support for Senate Bill No. 2136 which raises the compensation for ESPB board members from twenty-five dollars per day to six-two dollars and fifty cents per day.

This bill is needed to bring the ESPB board compensation into alignment with other boards in the state such as the State Board of Higher Education. Further, as a former member of the board, I feel that the increase is both needed and appropriate to fit the expanding involvement of the board members in meeting the demands of No Child Left Behind legislation.

My experience as a board member was that of a "working member". When issues such as determining just what a "highly qualified" teacher is and how will that teacher be licensed board members do more than just listen to recommendations from their executive director. There are many meetings that go for long hours as members wrestle with important decisions. In addition, board members receive numerous phone calls and letters from the field regarding proposed changes. Unfortunately, these calls and letters do not wait for a meeting. They are received at home and at work. As a former board member always took the time to respond to these calls and letters. I am certain current board members maintain the same dedication to professional responses to these types of inquiries.

For the above reasons, I encourage this committee to seriously consider the proposed change to SB 2136 and give it a do pass recommendation from your committee..
