

Tom Tupa. Board of Addiction Counselors appeared in support and proposes an amendment, stating that simply on line 15 changes and adds to the definition on professional conduct.

Rep. Weisz: What would fall under this new provision?

Answer: In the first part of the definition it says obtaining license by false means and violating the rules by the Board. In situations where a counselor has relapsed and started drinking, received a DUI or more than one, that sort of comes outside the jurisdiction of those other first 4 parts and then maybe entered a rehab facility and wasn't completely or sufficiently rehabilitated as the language states, that would be a scenario there. Since our legal counsel tries to work out arrangements and agreements with those kinds of people, he just felt it would be easier for him to state his case by adding those kinds of changes to the definition.

Chairman Lee and members of the committee, good morning. I am Edward Erickson and I am an Assistant Attorney General. The Attorney General is not taking a position on the substance of S.B. 2143. I am here to discuss a concern we have with the wording of this bill.

S.B. 2143 adds two new categories of unprofessional conduct to the licensing chapter for addiction counselors. The first category is of those persons who are guilty of an offense determined to have a direct bearing on the person's ability to serve the public as an addiction counselor. The second category is of persons guilty of any offense and who are not sufficiently rehabilitated as required under N.D.C.C. § 12.1-33-02.1, which is generally known as the rehabilitation statute.

I believe that the intent of this bill is to prevent the rehabilitation statute from applying to the category of offenses determined to have a direct bearing on the person's ability to serve the public as an addiction counselor. However, the rehabilitation statute applies to all state professional licenses, and requires the licensing board or agency to consider evidence of rehabilitation following conviction if the license holder is being disqualified from practicing due to the conviction. The rehabilitation statute, by its own terms, will apply to any license holder who is disqualified even where the rehabilitation statute is not mentioned in the licensing law, including this bill.

This problem may be resolved in two ways. The bill may be amended to allow license holders found guilty of either category of crimes to come under the rehabilitation
