Chairman Flakoll opened the hearing on SB 2201. All members of the Senate Agriculture Committee were present.

Dr. Larry Schuler, State Veterinarian and Executive Officer of the State Board of Animal Health testified in favor of the bill. (written testimony)

Senator Nichols asked what percentage of replacement females are calfhood vaccinated against brucellosis? (meter # 6145)

Dr. Schuler said roughly 150,000 females are calfhood vaccinated against brucellosis each year and he estimates half of those are kept for replacements.

Dr. Schuler said there was concern that Canada would accept our non vaccinates but not our vaccinates and that is dealt with in the bill. We would reciprocate with Canada only if they will accept both vaccinates and non vaccinates.

Senator Urlacher asked if females have to be calfhood vaccinated against brucellosis if there is a change of ownership?

Dr. Schuler said the requirement for females to be calfhood vaccinated against brucellosis is only for cattle entering the state.

Jeff Dahl, North Dakota rancher from Gackle, member of the Board of Animal Health and the President of the North Dakota Stockmen's Association, testified in favor of the bill. (written testimony) (meter #109)

Beatrice Wall, Vice President of the North Dakota Grazing Association, clarified every grazing association in the state requires calfhood vaccination against brucellosis for cattle grazing with their association.

Senator Nichols asked if that is a grazing association rule?

Ms. Wall said she thinks it is a state law.

Senator Klein asked for clarification from Dr. Schuler.

Dr. Schuler said it is not specific in the code, each grazing association has its own rules. Most do require calfhood vaccination for brucellosis.

Senator Flakoll asked if there were federal laws applicable in this case?

Dr. Schuler said no. The United States is nearing the completion of a brucellosis eradication program. There are only two states that are not brucellosis free, Missouri and Texas. There is also the brucellosis infection in Yellowstone that is still an issue. When the country reaches a free status, vaccination will be phased out completely but we are not to that point yet.

Senator Erbele clarified that since we are a brucellosis free state, as a producer you don't have to bangs vaccinate and you can freely move to other bangs free states?

Dr. Schuler said we are a brucellosis free state and most states recognize our status. Some western states have a vaccination requirement for females entering their state, Montana for example. As you move east, most states will accept our cattle, regardless of brucellosis vaccination status.

Chairman Flakoll closed the hearing on SB 2201. (meter # 699)

It was moved by Senator Erbele, seconded by Senator Seymour and passed on a roll call vote that the Senate Agriculture Committee take a Do Pass action on SB 2201. Voting yes were Senator Flakoll, Senator Erbele, Senator Klein, Senator Urlacher, Senator Nichols, and Senator Seymour. No negative votes were cast. Senator Klein will carry the bill to the floor.

Chairman Flakoll recessed the meeting of the Senate Agriculture Committee.

My name is Jeff Dahl. I'm a cattle rancher from Gackle. I'm a member of the Board of Animal Health and also the President of the North Dakota Stockmen's Association. I am here to testify in favor of SB 2201.

This bill has been in the making for several years. I've been involved in cross-border issues meetings for the past four years on trade with Canada. I've found that Canadians are good horse traders. They are also very protective of their markets. One of the ways they protect their cattle and beef markets is by using health issues as trade barriers. It has been very difficult for producers on this side of the border to send cattle north. In recent years, we've been working on a regionalization concept and North Dakota has been one of the lead states in proving that we are well within the health issue limitation set by the Canadians. It seems that every time we meet one criteria, another one is brought forward. This bill in effect puts the shoe on the other foot, by offering them the opportunity to enter North Dakota if they reciprocate with us. Also, over the past few years the Board of Animal Health has dealt with someone wanting to bring cattle into North Dakota from Canada at nearly every quarterly meeting. The only way that was allowed in the past was by the Board of Animal Health granting a waiver. This bill sets forth a standard procedure for this waiver to be issued which will streamline the process for a waiver to be granted.
