SENATOR JUDY LEE opened the Public Hearing for SB 2333 relating to reporting requirements for health care institutions.

Roll call was read.

ARNOLD THOMAS, President of the North Dakota Healthcare Association, asked to be introduced. Here with an offer, but an apology for SB 2333. It is a measure that we asked to be introduced based on an issue that we were addressing. Since the bill's introduction, we have found an alternative solution to the issue. Administration process already in place, so the measure could not be withdrawn. I respectfully ask the committee to put a DO NOT PASS on this bill. What this bill does ... addresses the regulation of the profession of medicine and the recording of information. Utilization committee now act as overseers of what happens medically in a facility ... reporting requirements in place ... more than adequate. (Meter # 54 - 345)
