Senator Holmberg, chairman, opened the hearing on SCR 4001 (#1928)

Yvonne Smith, Deputy Director of the Department of Human Services (#2033) provided the committee with information in regard to the benefits of the funding flexibility that has been granted to the Human Service Centers, as well as to the State Hospital and Developmental Center. (Her written testimony is Exhibit #1 which is attached) Since the 1995-97 biennium, the human service centers and the two institutions have operated under lump sum appropriations. In addition, the Department's appropriations bill has allowed the transfer of funds among the centers and the institutions, in response to client need. The combination of these two mechanisms has been instrumental in our ability to provide the right services in the right setting to meet the needs that arise. In the past several years, the Department has focused efforts on serving people as close to home as possible, and in the least restrictive appropriate setting. The Department has decreased the average daily census at the State Hospital from 228 in 1997 to 160 now. During the

1999-01 biennium, \$468,705 was transferred from the State Hospital budget to the human service center budgets to increase their capacity to provider community based care, including residential services, crisis residential services, short-term psychiatric hospitalization, medical detoxification, and other treatment and care services. The flexibility created by the "lump sum" budget has allowed the centers and the institutions to determine whether to purchase a service or provide the service directly, based upon the employee/provider market in their region. With this flexibility, they are able to address emerging needs more quickly. Through their strategic planning process, the Department has created a greater degree of alignment of services statewide. Through establishing our guiding principles and defining basic core services, we have been able to identify a base level of services that ought to be available to people statewide, regardless of the region they live in, however there is program flexibility from region to region which allows for determining the breadth and scope of service, based upon the unique demographic, geographic, and economic factors. In addition, operational flexibility allows each region to determine how the services will be delivered. In other words, consistency is applied to the "what" of services, and program and operational flexibility is applied to the "how". Funding mechanisms currently existing in the Department's appropriations bill accommodate and encourage this flexibility. The regulations governing some of the federal funding sources create exceptions and limitations for the use of the funds. These regulations must be adhered to if we are to continue to access those federal dollars. The Department is very interested in maintaining the level of funding flexibility granted in the past biennium and look forward to working toward identifying additional funding flexibility based upon performance outcomes that reinforce the statewide system of care for

Senator Kilzer: During the Human Service Center testimony, we heard that the center in the Williston area served 25% of the population, Minot under 10% and in Lake Region it was about 1/3 of the population. Could you comment on that, why the variance, services of other agencies like the State Health Department or is the social economics conditions, what are the factors? Ms. Smith responded, it is wide factor of reasons, in the rural regions there aren't private providers that are available to provide services, so the Human Service centers end being the only thing in town. For that reason some may serve more than others, also the demographics, like in the lake region where there is a higher degree of poverty.

Senator Tim Mathern, (#2723) Senator from District 11 in Fargo and he served on the budget committee in governmental administration that brought this bill before the committee. He felt that the testimony by Ms. Smith showed why this study is needed. As a legislature they had times had mandated that certain programs be added, only to find out that the need was not there or had changed, and was then not doing what it should be providing. That is where this bill came from, in fact Senator Nething and a number of other people brought forth this resolution in order to making an environment where there is flexibility that Ms. Smith talked about.. Senate Concurrent Resolution No. 4001 Senate Appropriations Committee January 24, 2003

Chairman Holmberg and members of the Senate Appropriations Committee, I am Yvonne Smith, Deputy Director of the Department of Human Services. I appear before you today to provide information in regard to the benefits of the funding flexibility that has been granted to the Human Service Centers, as well as to the State Hospital and Developmental Center.

Since the 1995-97 blennium, the human service centers and the two institutions have operated under lump sum appropriations. In addition, the Department's appropriations bill has allowed the transfer of funds among the centers and the institutions, in response to client need. The combination of these two mechanisms has been instrumental in our ability to provide the right services in the right setting to meet the needs that arise.

For example, for the past several years, the Department has focused efforts on serving people as close to home as possible, and in the least restrictive appropriate setting. As such, we have decreased the average daily census at the State Hospital from 228 in 1997 to 160 presently. During the 1999-01 blennium, \$468,705 was transferred from the State Hospital budget to the human service center budgets to increase their capacity to provider community based care, including residential services, crisis residential services, short-term psychiatric hospitalization, medical detoxification, and other treatment and care services.

The flexibility created by the "lump sum" budget has allowed the centers and the institutions to determine whether to purchase a service or provide the service directly, based upon the employee/provider market in their

region. With this flexibility, we are able to address emerging needs more quickly. In addition, when savings are generated in the operation of the center or institution, those funds can be re-directed to pay for direct client services.

Through our strategic planning process, the Department has created a greater degree of alignment of services statewide. Through establishing our guiding principles and defining basic core services, we have been able to identify a base level of services that ought to be available to people statewide, regardless of the region in which they live. However, there is program flexibility from region to region which allows for determining the breadth and scope of service, based upon the unique demographic, geographic, and economic factors. In addition, operational flexibility allows each region to determine how the services will be delivered. In other words, consistency is applied to the "what" of services, and program and operational flexibility is applied to the "how."

Funding mechanisms currently existing in the Department's appropriations bill accommodate and encourage this flexibility. The regulations governing some of the federal funding sources create expectations and limitations for the use of the funds. These regulations must be adhered to if we are to continue to access those federal dollars.

The Department is very interested in maintaining the level of funding flexibility granted in the past blennia, and will look forward to working toward identifying additional funding flexibility based upon performance outcomes that reinforce the statewide system of care for vulnerable people. We ask that you also consider including the State Hospital and the Developmental Center in this resolution.
