Chairman DeKrey: We will open the hearing on SCR 4014.

Bill Brown, Capt., Minot Police Dept.: Support. After reading this resolution, we are in favor of this resolution because dollars are short and law enforcement needs training more than ever. Our department alone experienced an increase in training dollars by 30% in 2002, this was due by and large to turnover from our department. Members leaving the department, getting out of law enforcement altogether and going to federal jobs, and we perceive this as going to be an increasing problem for law enforcement. As a result, we believe that we do need to find some alternative funding for training, and we do need to study the issue of training for law enforcement in this state.

Rep. Onstad: Currently the training that is provided now, is funded through what?

Capt. Brown: The training for our police department is provided through city funds. However, we do rely heavily on state training to provide training such as the fax machine, legislative
