SENATOR JUDY LEE opened the public hearing for SB 4021 requiring the Department of Human Services to contract with mental health care providers and up to four regional hospitals to provide for the care of individuals with mental illness and drug and alcohol addictions. SENATOR TIM MATHERN, from District 11 in Fargo, introduced the bill. There are three main parts with this resolution. One: Legislative Council study to consider changing the mission of the State Hospital from caring for individuals with mental illness and individuals with drug and alcohol additions, for persons referred by the community, to providing that sort of care for persons that are in the correction system. Two: Is to develop legislation to effect that purpose. Third: Requiring the Department of Human Services to contract with medical mental health care providers in up to 4 regional areas, four regional hospitals in the state, to care for individuals with mental illness and drug and alcohol additions. Clinical practices have changed. New and different approaches. Additional community based services. State Hospital patients have

Would we use those professionals best by bringing all the citizens needing those services to them in Jamestown? Geographic location should be considered. She is getting excited about what could be accomplished if it is done right. (meter # 3519)

Senator Lee said she will speak with Senator Stenehjem regarding the best way to proceed.

Chairman Lee and members of the Human Service Committee: my name is Carlotta McCleary. I am the chair of the North Dakota Mental Health Planning Council. On behalf of the Council, I am here to encourage the State to study alternatives to a shared campus between the State Hospital and the Department of Corrections and to develop a long-term plan for the State Hospital.

The council is concerned that the impact of prison facilities being co-located at the state hospital will only further increase the stigma associated with mental illness. With a combined campus, North Dakota will be perpetrating the false image that people diagnosed with mental illness are also criminals.

This study needs to look at the availability of community based mental health services to ensure that individuals have access to adequate and appropriate services. Without an increase in community based mental health services that truly meets the needs of individuals with mental illness, many individuals will fall through the cracks. Currently, we are seeing cuts to services in the community. The State Hospital provides a valuable safety net for individuals requiring a high level of care that is not available in communities across the state.

On behalf of the Council, we encourage the State to study alternatives to a shared campus between the State Hospital and the Department of Corrections and to develop a long-term plan for the State Hospital. During the interim, we encourage the Legislature to maintain the LaHaug and the Adolescent Center buildings exclusively for State Hospital patients.

Chairman Lee and members of the Senate Human Services Committee, my name is Bruce Murry and I am an employee of the North Dakota Protection and Advocacy Project (P&A). P&A supports SCR 4021.

People thrive best when they are included as equal members of their community. A move from a centralized state hospital to regional acute-mental illness centers would move people with mental illnesses closer to their communities, both geographically and functionally.

Home and community based services would allow people with mental illnesses increased dignity, personal responsibility, and economic participation. Facilitating people moving to private homes or apartments, buying from local businesses, and paying local taxes would help North Dakota. People with mental illnesses could influence the quality of their care through the exercise of personal choice.

Regional mental health hospitals with 16 or fewer beds are eligible for medicald participation. This would allow the state to simultaneously save money and use the remainder to increase the quality of care.

The strategic plan for the NDSH should be established by the Legislature and based first upon the needs of North Dakotans with mental illness. It should not be an executive decision that is reactive to the needs of corrections. If the Legislature finds the time is ripe to accelerate the move toward home and community based services, P&A would support such a move. If such a move cannot be made this blennium, this study would be appropriate.
