

HOUSE BILL NO. 1410

1 A BILL for an Act to amend and reenact section 16.1-03-03, subsection 2 of section 16.1-03-07,
2 and section 16.1-03-11 of the North Dakota Century Code, relating to political party
3 organization.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 16.1-03-03 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **16.1-03-03. Caucus business and elections - Political parties entitled to elect**
8 **committeemen.**

- 9 1. Each precinct caucus shall elect a chairman, committeemen as provided in
10 subsection 3, and other officers as may be provided by party rules. The caucus
11 may also discuss party policies, candidates, and any other business as prescribed
12 by party rules.
- 13 2. No political organization is entitled to elect a precinct committeeman at its precinct
14 caucus unless:
- 15 a. The organization nominated and had printed on the ballot at the last
16 preceding presidential election the names of a set of presidential electors
17 pledged to the election of the party's candidates for president and vice
18 president or a candidate for governor; and
- 19 b. The candidates provided for in subdivision a received at least five percent of
20 the total vote cast for presidential electors or governor within this state at that
21 election.
- 22 3. Each political party in each voting precinct of this state, otherwise qualifying under
23 subsection 2, is entitled to elect one precinct committeeman for each two hundred
24 fifty votes, or fraction thereof, cast for the party's presidential electors in the

1 precinct in the last presidential election. Each precinct is entitled to at least one
2 precinct committeeman for each party which qualifies under subsection 2. Each
3 precinct committeeman must be an elector of the precinct in which the
4 committeeman resides and must be elected for a two-year term.

5 ~~4. The caucus chairman shall notify the county auditor of those precinct~~
6 ~~committeemen elected.~~

7 **SECTION 2. AMENDMENT.** Subsection 2 of section 16.1-03-07 of the North Dakota
8 Century Code is amended and reenacted as follows:

9 2. ~~The newly elected chairman shall notify the secretary of state of the names of the~~
10 ~~party officers selected. The secretary of state shall certify the names of the party~~
11 ~~officers to the county auditors.~~ If the office of chairman becomes vacant, the vice
12 chairman shall hold the office until the next regular election for the office or until a
13 new chairman is selected by the district committee for the balance of the term,
14 whichever occurs first. ~~The secretary of state must be notified of any changes in~~
15 ~~membership of the district's committee officers by the district committee and must~~
16 ~~notify the county auditors of any changes.~~

17 **SECTION 3. AMENDMENT.** Section 16.1-03-11 of the North Dakota Century Code is
18 amended and reenacted as follows:

19 **16.1-03-11. State committee - Meetings - Organization - Vacancies.** The state
20 committee shall meet on or before July first of each odd-numbered year. The committee shall
21 organize by selecting a chairman, vice chairman, secretary, and treasurer and by adopting rules
22 and modes of procedure. The party's bylaws must be filed with the secretary of state. The
23 officers elected need not be members of the committee, but they shall become voting members
24 of the committee after their election. ~~The~~ Within thirty days following the state committee's
25 organization, the newly elected chairman shall notify the secretary of state of the names of the
26 party officers selected and the names and addresses of the party's district chairmen. These
27 officers, with any other persons provided for by the party's bylaws and as the state committee
28 designates, constitute the executive committee of the state committee. If the office of chairman
29 becomes vacant, the vice chairman holds the office until the next regular election for the office
30 or until a new chairman is selected by the state committee for the balance of the term,
31 whichever occurs first. A vacancy in an office of the state committee, other than chairman and

- 1 a party district chairman, must be filled upon a majority vote of the state committee. The
- 2 chairman of the state committee may temporarily fill any vacancy existing on the state
- 3 committee until the state committee convenes to fill the vacancy. The secretary of state must
- 4 be notified of any changes in membership of the state's committee officers or the party's district
- 5 chairmen.
