1 A BILL for an Act to amend and reenact sections 43-03-01, 43-03-02, 43-03-08, 43-03-09,

2 43-03-10, 43-03-11, 43-03-12, 43-03-13, 43-03-16, 43-03-17, 43-03-18, 43-03-19, 43-03-20,

3 43-03-21, 43-03-22, and 43-03-23 of the North Dakota Century Code, relating to the

4 registration of architects and landscape architects; and to provide a penalty.

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Section 43-03-01 of the North Dakota Century Code is
7 amended and reenacted as follows:

43-03-01. Definitions. In this chapter, unless the context or the subject matter
otherwise requires:

- 1. <u>"Architect" means an individual who is registered as an architect under this</u>
   11 <u>chapter.</u>
- 12 <u>2.</u> "Board" means the state board of architecture.
- 13 2. "Architect" means an individual who is registered under the provisions of this
   14 chapter.
- 15 <u>3.</u> <u>"Landscape architect" means an individual who practices landscape architecture.</u>
- <u>4.</u> "Landscape architecture" means a service in which landscape architectural
   education, training, and experience and the application of mathematical, physical,
- 18 and social science principles are applied in consultation, evaluation, planning,
- 19 design, and administration of contracts relative to projects principally directed at
- 20 the functional and aesthetic use and preservation of land. The term includes
- 21 investigation, selection, and allocation of land and water resources for appropriate
- 22 uses; formulation of feasibility studies and graphic and written criteria to govern the
- 23 planning, design, and management of land and water resources; preparation,
- 24 review, and analysis of land use master plans, schematic subdivision plans, and

1		preliminary plats; determining the location and siting of improvements, including	
2		buildings and other features, as well as the access and environs for such	
3		improvements; and design of land forms, landscape drainage, site lighting, water	
4		features, irrigation systems, plantings, pedestrian and vehicular circulation	
5		systems, and related construction details.	
6	SEC	CTION 2. AMENDMENT. Section 43-03-02 of the North Dakota Century Code is	
7	amended a	nd reenacted as follows:	
8	43-0	03-02. Persons exempt from regulations.	
9	<u>1.</u>	The architect registration provisions of this chapter do not apply to the following:	
10	<del>1.</del>	A $\underline{a}$ person making plans and specifications for a building to be constructed by or	
11		for that person <del>.</del>	
12	<del>2.</del>	A: a person supervising the erection, enlargement, or alteration of a building being	
13		constructed by or for that person <del>.</del>	
14	<del>3.</del>	A: a person preparing for a school board plans and specifications for, or	
15		supervising the erection or alteration of, one-room or two-room school buildings	
16		costing not to exceed five thousand dollars <del>.</del>	
17	<del>4.</del>	The; or an employee of an architect acting under that architect's instruction,	
18		control, and supervision in preparing plans and specifications for the erection,	
19		enlargement, or alteration of buildings.	
20	<u>2.</u>	The landscape architect registration provisions of this chapter do not apply to an	
21		architect, a professional engineer, or a land surveyor in the course of providing	
22		professional services for which otherwise licensed or registered; a nursery worker,	
23		gardener, landscape designer, or landscape contractor in the course of preparing	
24		planting plans or installing plant material, to the extent these activities do not	
25		impact the public health, safety, or welfare; or an individual in the course of	
26		planning or otherwise caring for that individual's property.	
27	SEC	CTION 3. AMENDMENT. Section 43-03-08 of the North Dakota Century Code is	
28	amended and reenacted as follows:		
29	43-03-08. Board to adopt rules and regulations. The board shall may adopt the		
30	following rules and regulations:		

31 1. To govern its board proceedings.

1	2.	For the examination of candidates for registration.	
2	3.	For the regulation of the practice of architecture and landscape architecture.	
3	Such rules	and regulations must be consistent with the provisions of this chapter and the laws	
4	of this state	. The board, from time to time, may amend, modify, and repeal such rules and	
5	regulations.		
6	<u>4.</u>	For education of registration applicants.	
7	<u>5.</u>	For continuing education of registrants.	
8	SEC	CTION 4. AMENDMENT. Section 43-03-09 of the North Dakota Century Code is	
9	amended a	nd reenacted as follows:	
10	43-0	03-09. Practice of architecture without a license Unauthorized practice	
11	prohibited.	A person may not practice architecture as a profession in this state unless that	
12	person has	obtained from the board a certificate of registration and is registered as an architect	
13	under this c	hapter or otherwise authorized by the board. A person may not practice landscape	
14	architecture in this state unless registered as a landscape architect under this chapter or		
15	otherwise authorized by the board.		
16	SEC	TION 5. AMENDMENT. Section 43-03-10 of the North Dakota Century Code is	
17	amended and reenacted as follows:		
18	43-0	03-10. Regulation of use of term licensed architects Terms.	
19	<u>1.</u>	A person may not use the title or designation "registered architect", "licensed	
20		architect" nor, any variation of the same those terms, nor or any other words,	
21		letters, or device to indicate that person is a licensed an architect, without being	
22		authorized to practice architecture in this state unless that person is registered as	
23		an architect in accordance with the provisions of under this chapter. In a	
24		copartnership of licensed architects, each member of the partnership shall hold a	
25		license certificate of registration to practice.	
26	<u>2.</u>	A person may not use the title or designation "registered landscape architect",	
27		"licensed landscape architect", any variation of those terms, or any other words,	
28		letters, or device to indicate that person is an architect authorized to practice	
29		landscape architecture in this state unless that person is registered as a landscape	
30		architect under this chapter.	

SECTION 6. AMENDMENT. Section 43-03-11 of the North Dakota Century Code is
 amended and reenacted as follows:

43-03-11. Application for examination - Fee. Before a person an individual may take
the examination for registration as an architect or a landscape architect, that person individual
shall make an application to the board submitting satisfactory evidence of having the required
qualifications and shall pay a fee of fifty dollars. When If reexamination is required, the
applicant shall pay a fee of twenty-five dollars for a reexamination. The fee for reexamination
may be waived in whole or in part by the board.

9 SECTION 7. AMENDMENT. Section 43-03-12 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **43-03-12. Board to issue certificates of registration.** The board, in accordance with

12 the provisions of this chapter, shall examine those desiring to use the title of architect or to

13 practice as architects in this state applicants for registration and shall issue certificates of

14 registration to those who are qualified. The board may administer an examination or may

15 recognize a board-approved examination of a nationally recognized entity.

SECTION 8. AMENDMENT. Section 43-03-13 of the North Dakota Century Code is
amended and reenacted as follows:

43-03-13. Qualifications. An applicant for registration as an architect shall have all of
the following qualifications:

20 1. Be Must be at least eighteen years of legal age-;

- 2. Be <u>Must be</u> of good moral character, with rejection possible on the basis of the
   following:
- a. Conviction of an offense determined by the board to have a direct bearing
   upon an applicant's ability to serve the public as an architect <u>or a landscape</u>
   <u>architect</u>, or the board determines, following conviction of an offense, that the
   applicant is not sufficiently rehabilitated under section 12.1-33-02.1-;
- b. Misstatement or misrepresentation of fact by the applicant in connection with
  that person's individual's application-; or
- c. Violation of any of the standards of conduct required of licenseholders and
   set forth in the statutes. registrants;
- 3. Have Must have successfully completed an examination for registration-; and

Have had what In the case of an architect, must have the practical experience and
 academic training as is specified in the current guidelines published by the national
 council of architectural registration boards.

SECTION 9. AMENDMENT. Section 43-03-16 of the North Dakota Century Code is
amended and reenacted as follows:

6 43-03-16. Certificates of registration issued by board - Result of examinations 7 recorded by secretary of board. The result of every examination for registration as an 8 architect, or a landscape architect and the evidence of qualifications, must be recorded by the 9 secretary of the board, and the. The board shall issue a certificate of registration to every 10 person individual who has passed passes the examination or otherwise is entitled to receive 11 the certificate. The secretary of the board shall maintain a list of architects and landscape 12 architects certified under this section. This list must contain the architect's registrant's name, 13 current business address, certification number, and the expiration date of the architect's 14 certificate.

SECTION 10. AMENDMENT. Section 43-03-17 of the North Dakota Century Code is
amended and reenacted as follows:

43-03-17. Certificates of registration - Term - Renewal. A certificate of registration
as an architect <u>or a landscape architect</u> must be issued for one year upon the payment of the
proper fee and, upon the payment of the proper fee, may be renewed without examination.

20 **SECTION 11. AMENDMENT.** Section 43-03-18 of the North Dakota Century Code is 21 amended and reenacted as follows:

43-03-18. Fees. The following must be the registration and renewal fees required to
 be paid by an architect apply to architects and landscape architects:

- 241.Following examination, a <u>an architect</u> registration fee of not more than one25hundred dollars, as set by the board.

   2. When examination is not necessary under section 43-03-15, a <u>an architect</u>
   27 registration fee of not more than one hundred dollars, as set by the board.
- 28 3. An annual <u>architect registration</u> renewal fee of not more than one hundred dollars,
  29 as set by the board.
- 30 4. Following examination, a landscape architect registration fee of not more than five
   31 hundred dollars, as set by the board.

1	<u>5.</u>	An annual landscape architect registration renewal fee of not more than five	
2		hundred dollars, as set by the board.	
3	SECTION 12. AMENDMENT. Section 43-03-19 of the North Dakota Century Code is		
4	amended a	nd reenacted as follows:	
5	43-0	03-19. Effect of failure to pay renewal fee.	
6	1.	If the holder of a certificate of registration as an architect or a landscape architect	
7		fails to pay the annual renewal fee when due, that person's individual's certificate	
8		must be revoked unless that person's individual's application for renewal is made	
9		within one year after the expiration of that person's individual's certificate. That	
10		person individual then shall pay the renewal fee set by the board under section	
11		43-03-18. If a former holder applies for renewal more than one year after the	
12		expiration of that person's individual's certificate, that person individual may, in the	
13		board's discretion, be reinstated upon payment of a fee of one hundred dollars.	
14	2.	No A certificate may not be revoked for nonpayment of fees unless the secretary	
15		of the board has first given at least thirty days' notice by certified mail to the holder	
16		of such certificate. The notice must be directed to the last-known address or place	
17		of residence of the delinquent.	
18	SEC	CTION 13. AMENDMENT. Section 43-03-20 of the North Dakota Century Code is	
19	amended a	nd reenacted as follows:	
20	43-0	03-20. Revocation of registration. The board, after a hearing upon thirty days'	
21	written notice to the certificate holder thereof, may revoke any certificate of registration of an		
22	architect or	a landscape architect upon proof that:	
23	1.	Such certificate has been obtained by fraud or misrepresentation;	
24	2.	The holder of such certificate has been guilty of malfeasance, fraud, gross	
25		incompetency, or negligence in connection with the holder's practice of	
26		architecture or landscape architecture;	
27	3.	The holder of such certificate has allowed <u>a</u> nonregistered persons or entitics	
28		person to practice as an architect by the device of permitting the holder's name or	
29		stamp to be placed upon drawings, or other contract documents, not prepared by	
30		the holder or under the holder's direct supervision;

2 board to have a direct bearing upon the holder's ability to serve the public as an 3 architect or landscape architect; or that, following conviction of an offense, the 4 holder is not sufficiently rehabilitated under section 12.1-33-02.1; or 5 5. The holder of such certificate has violated any provisions of this chapter. 6 SECTION 14. AMENDMENT. Section 43-03-21 of the North Dakota Century Code is 7 amended and reenacted as follows: 8 **43-03-21.** Penalty. Any person willfully violating the provisions of this chapter is guilty 9 of a class B misdemeanor. 10 SECTION 15. AMENDMENT. Section 43-03-22 of the North Dakota Century Code is 11 amended and reenacted as follows: 12 **43-03-22.** Stamp. At the time of the issuance of the certificate of registration, the 13 board shall furnish to the applicant, at the applicant's expense, a rubber stamp to be used by 14 the applicant in the conduct of the applicant's practice and to be impressed upon drawings and 15 other documents prepared by the applicant. The board shall prescribe rules governing the use 16 of such stamp and architect's applicant's signature. 17 SECTION 16. AMENDMENT. Section 43-03-23 of the North Dakota Century Code is 18 amended and reenacted as follows: 19 43-03-23. Architect not liable Liability for contractor's fault unless responsibility 20 assumed - Liability for own negligence. An architect or a landscape architect is not liable for 21 the safety of persons or property on or about a construction project site, or for the construction 22 techniques, procedures, sequences and schedules, or for the conduct, action, errors, or 23 omissions of any construction contractor, subcontractor, or material supplier, their agents or 24 their employees, unless the architect or landscape architect assumes responsibility therefor by 25 contract or by the architect's or landscape architect's actual conduct. Nothing herein may be 26 construed to This section does not relieve an architect or a landscape architect from liability 27 from the architect's or landscape architect's negligence, whether in the architect's or landscape 28 architect's design work or otherwise.
