1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of
2 human services; to provide for the transfer of appropriation authority between agencies and
3 institutions; to provide an exception; to provide for legislative council studies; to provide a
4 statement of legislative intent; and to declare an emergency.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
7 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
8 treasury, not otherwise appropriated, and from special funds derived from federal funds and
9 other income, to the department of human services and its various divisions, for the purpose of
10 defraying the expenses of that agency, for the biennium beginning July 1, 2003, and ending
11 June 30, 2005, as follows:

26 **SECTION 2. APPROPRIATION - HEALTH CENTER GRANTS.** There is appropriated
27 out of any moneys in the general fund in the state treasury, not otherwise appropriated, the
28 sum of \$50,000, or so much of the sum as may be necessary, to the department of human
29 services for the purpose of providing grants to community entities to support community
30 development and grant writing services for the purpose of health center grant application

1 submission, for the biennium beginning July 1, 2003, and ending June 30, 2005. The
2 department may not award an individual grant of more than \$10,000.

3 **SECTION 3. LEGISLATIVE INTENT - DEVILS LAKE CHILD SUPPORT**

4 **ENFORCEMENT UNIT.** It is the intent of the legislative assembly that the fifty-ninth legislative
5 assembly consider removing general fund support for the Devils Lake child support
6 enforcement unit reservation project if the project's performance results do not improve during
7 the biennium beginning July 1, 2003, and ending June 30, 2005.

8 **SECTION 4. LANDS AND MINERALS TRUST FUND.** The sum of \$3,261,556, or so

9 much of the sum as may be necessary, included in the developmentally disabled facility loan
10 fund line item in subdivision 1 of section 1 of this Act, may be expended by the department of
11 human services from the lands and minerals trust fund for the purpose of making payments of
12 principal and interest to the common schools trust fund on any loans made from it pursuant to
13 the developmentally disabled loan fund program nos. 2 and 3, for the biennium beginning
14 July 1, 2003, and ending June 30, 2005.

15 **SECTION 5. FUNDING TRANSFERS - EXCEPTION - AUTHORIZATION.**

16 Notwithstanding section 54-16-04, the department of human services may transfer
17 appropriation authority between line items within each subdivision of section 1 of this Act, and
18 between subdivisions within section 1 of this Act for the biennium beginning July 1, 2003, and
19 ending June 30, 2005. The department shall notify the office of management and budget of
20 any transfer made pursuant to this section. The department shall report to the budget section
21 after June 30, 2004, any transfers made in excess of \$50,000 and to the appropriations
22 committees of the fifty-ninth legislative assembly regarding any transfers made pursuant to this
23 section.

24 **SECTION 6. FEDERAL TANF BLOCK GRANT PROGRAMS - EXPENDITURE LIMIT.**

25 The department of human services shall make the changes necessary to programs utilizing
26 funding from the temporary assistance for needy families (TANF) block grant to provide that by
27 the end of the 2003-05 biennium, the cumulative funding anticipated to be spent for these
28 programs for each fiscal year does not exceed North Dakota's annual federal TANF block grant
29 allocation, including any incentive or bonus grants awarded to North Dakota.

30 **SECTION 7. MEDICAL SERVICES - COPAYMENTS AND SERVICE LIMITS.** The

31 department of human services shall establish a six dollar copayment for medical assistance

1 recipients for each emergency room visit that is not designated an emergency service by the
2 medical services provider. The department of human services shall establish other service
3 copayments or limits and make other programmatic changes within the medical services
4 program to operate the program within the funding levels approved by the fifty-eighth legislative
5 assembly for the biennium beginning July 1, 2003, and ending June 30, 2005.

6 **SECTION 8. NURSING HOME RATES - EXCEPTION - DIRECT CARE LIMIT.**

7 Notwithstanding subsection 4 of section 50-24.4-10, the department of human services shall
8 establish an eighty-five dollar per diem limit, adjusted for inflation under subsection 5 of section
9 50-24.4-10, on allowable operating costs for direct care services of nursing facilities for
10 purposes of determining nursing facility payment rates for the biennium beginning July 1, 2003,
11 and ending June 30, 2005.

12 **SECTION 9. SUPPORTED LIVING ARRANGEMENTS FOR INDIVIDUALS WITH**
13 **DEVELOPMENTAL DISABILITIES - LOCAL MATCHING FUNDS - FUNDING ALLOCATION.**

14 The grants - medical assistance line item in subdivision 2 of section 1 of this Act includes
15 \$200,000 from the health care trust fund for supported living arrangement services for
16 individuals with developmental disabilities. This funding may be spent only if local or private
17 funding of two dollars is provided for these services for each one dollar of general fund moneys
18 provided for these services. The department shall allocate the funding appropriated for this
19 purpose proportionately to each human service region of the state based on the number of
20 individuals with developmental disabilities seeking supported living arrangement services in
21 each region for the biennium beginning July 1, 2003, and ending June 30, 2005.

22 **SECTION 10. LEGISLATIVE INTENT - VOCATIONAL REHABILITATION - SURVEY**

23 **TIME PERIOD.** It is the intent of the legislative assembly that the department of human
24 services only survey vocational rehabilitation clients who become employed regarding job
25 retention and job satisfaction after three months of employment if allowed under federal
26 regulations for the biennium beginning July 1, 2003, and ending June 30, 2005.

27 **SECTION 11. LEGISLATIVE COUNCIL STUDY - HUMAN SERVICES**

28 **ADMINISTRATIVE COSTS.** The legislative council shall consider studying, during the 2003-04
29 interim, administrative costs of human service programs, including costs incurred by the central
30 office of the department of human services, human service centers, and county social services.
31 If studied, the legislative council shall review the effects of the 1997 "swap" legislation on state

1 and county human service program costs. The legislative council shall report its findings and
2 recommendations, together with any legislation required to implement the recommendations, to
3 the fifty-ninth legislative assembly.

4 **SECTION 12. LEGISLATIVE COUNCIL STUDY - CHILDREN WITH SPECIAL**
5 **HEALTH NEEDS.** The legislative council shall consider studying, during the 2003-04 interim,
6 programs providing services to children with special health care needs in North Dakota and
7 service needs of these children which are not available under current programs. The legislative
8 council shall report its findings and recommendations, together with any legislation required to
9 implement the recommendations, to the fifty-ninth legislative assembly.

10 **SECTION 13. LEGISLATIVE COUNCIL STUDY - MEDICAID ADVISORY COUNCIL.**
11 The legislative council shall consider studying, during the 2003-04 interim, the feasibility and
12 desirability of establishing an advisory council for the medical assistance program of the
13 department of human services. If studied, the legislative council shall consider including
14 representatives of private health care providers on the advisory council. The legislative council
15 shall report its findings and recommendations, together with any legislation required to
16 implement the recommendations, to the fifty-ninth legislative assembly.

17 **SECTION 14. LEGISLATIVE COUNCIL STUDY - LONG-TERM CARE CONTINUUM.**
18 The legislative council shall consider studying, during the 2003-04 interim, North Dakota's
19 long-term care continuum of services, including service delivery methods and payment
20 systems. If studied, the legislative council shall consider the cost-effectiveness of the programs
21 and the appropriateness of rate structures and the nursing home equalized rate policy. The
22 legislative council shall report its findings and recommendations, together with any legislation
23 required to implement the recommendations, to the fifty-ninth legislative assembly.

24 **SECTION 15. EMERGENCY.** The total all funds line item for the state hospital in
25 subdivision 3 of section 1 of this Act includes \$400,000 from special funds for capital
26 construction projects, and the appropriation of that amount is declared to be an emergency
27 measure.
