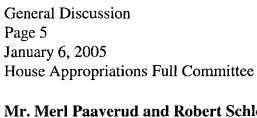

Mr. Merl Paaverud and Robert Schlobohm spoke for the State Historical Society. (handout #3-14, attached) (meter Tape #3, Side A, #46.8). Mr. Schlobohm discussed variances described in handout and noted that their only carry over authority was in capital assets within Lewis and Clark. The decrease is due to the fact that the project is complete. Mr.. Paaverud noted that services were needed throughout the state and that funding is being sought for FTE positions.

Mr. Wayne Stenehjem Attorney General, distributed handout #3-15 and discussed the 7 variances listed on page 2. (meter Tape #3, side B, #3.8) While discussing these, it was determined that the figures in the handout were in the wrong columns and would be corrected for the committee. (corrected version of handout is attached). Discussion ensued regarding "off Budget" positions in budgets and information was requested from Legislative Council concerning all agencies with off budget employees and whether or not these funds were included in the budgets and where.

Ms Teresa Larson spoke for Protection and Advocacy. (handout #3-16, attached) (meter Tape #3, side B, #15.5) Ms Larson read her written testimony and explained that this is the first time they have ever seen a decrease in federal dollars (mental Health Grant) which means an increase in operating expenses. Ms Larson continued by explaining their performance measurements listed on page 4 of handout.

Mr. Paul Shadwall from the Game and Fish Department reviewed the 8 variances listed on distributed handout #3-17 (attached). (meter Tape #3, side B, #33.2)

Mr. Sparb Collins from Public Employee Retirement System Distributed and reviewed handout #3-18 (attached). (meter Tape #3, side B, #44.7) Mr. Collins explained that the increase in Health Insurance is found in each agency's salary line and that the \$3000,000 increase is all

Minutes: Chairman Martinson opened the hearing on HB1019.

Merl Paaverud, director of State Historical Society of North Dakota. (See attached written testimony A1019). Gave a brief agency overview with some statistics from 2003-2005. Shared a general budget overview including projects completed in the last biennium. Addressed optional adjustments for operating. These included salaries and wages, operating expenses, capital assets and continuing appropriations. Continuing appropriations include the Concession Fund, gifts and bequests and archeological permits. Spreadsheets for these three areas are attached. (See attached written testimony A1019).

Chairman Martinson Last year we took some money from exhibits and you and your staff were very gracious when we wanted to move that up to Williston to the Confluence Center. The Williston Confluence Center is wonderful. The staff does a great job. Just wanted to say publicly that you guys did a tremendous job.

Merl Paaverud We understand that priorities pop up and you have to do something or it doesn't work out.

Chairman Martinson Another thing we did was give you a little money - \$75,000 - for grant money. You provided me with a list but could you provide that for the committee? I looked at it but what did you give out?

Merl Paaverud We gave out 21 grants for a total of \$75,000. We had 85 applicants that requested \$331,000 so you can see the need is definitely there. Wide scenario that we wanted to look at. It is a hit! People are really very happy about it. One of the criteria is that they have to recognize the Legislative Session for providing the funds.

Chairman Martinson Sometimes when we deal with large dollars and big projects, it gets a bit abstract. When you give a local community \$1500 or \$2000 it means a lot to them.

Merl Paaverud That had a one-to-one match. The money doubled.

Rep. Aarsvold You have the responsibility for reviewing construction plans. What is the threshold if I'm going to build a house in Greenvale County, do I have to come to you or is it only on government sorts of activities?

Merl Paaverud When there is federal money involved then we have a federal program that plugs in.

Chairman Martinson We will appoint a subcommittee on this.

Virginia Nelsen, executive director of the State Historical Society of North Dakota Foundation present her written testimony on the society's funding. (See attached written testimony B1019).

Chairman Martinson left hearing still open but end of testimony on HB1019.

Rep. Ken Svedjan, Chairman opened the discussion on HB1019.

Rep. Ole Aarsvold explained that this bill has an amendment #0102. This amendment reduced the compensation package to the 3 and 4, and we increased the funding for cultural heritage grants which are those grants given by the circle societies to local communities on a matching basis for carrying out local projects. We also added \$15,000 to update posters at the heritage center. We added \$400,000 of which \$200,000 are general funds, the balance are funds that are in jeopardy of being lost from the Save America Treasurer's Federal Grant that will be used to update and improve the interpretive center at Ft Abercrombie north of Wapheton. If this project is not finished in this biennium we will lose the \$200,000 grant. In total we have made a general fund adjustment of \$446,000 to this budget.

Rep. Ole Aarsvold moved to adopt amendment #0102 to HB1019.

Chairman Holmberg opened the hearing on HB 1019.

Robert Schloblohm, Assistant Director, State Historical Society of North Dakota, presented written testimony and testified in support of HB 1019. He introduced Jerry Newberg from the archives who displayed an 1804 book with Napoleon's annual message to the legislature describing the sale of the Louisiana Territory to the US. He then introduced Claudia Berg who displayed a bullet mold belonging to Theodore Roosevelt, a photograph of Theodore Roosevelt with his umbrella and a pipe bag belonging to Sitting Bull. Robert Schloblohm then testified, describing the State Historical Society, its functions, sites, numbers of visitors, numbers of volunteers, accomplishments during the past biennium. He indicated there are no additional positions or salary requirements in this bill other then the requested 4/4 percent. He continued reviewing budget request by line item and indicated the provides from the Historical Society store are used to purchase inventory.

Questions were raised regrding Ft. Abercrombie improvements, the receipts of money for cultural heritage and where that project ranked on the initial project projections, the grant program, and who presented the budget in the House.

Governor Arthur Link, former North Dakota Governor, Citizen, testified in support of HB 1019. He indicated that he and his wife are very interested in preserving the history of our state and country. He briefly described what historical boards he has been very involved with and indicated that the State Historical Society is one of the most highly visited tourist sites in North Dakota today. He commended the paid and volunteer staff of the Historic Society, indicating this is the most cost effective public institution he has seen. As a state that is in its 16th year of the second century he stated this is still a young state and it is important to honor this budget request.

Wally Beyer, Citizen, Trustee, North Dakota Historic Foundation, presented written testimony and testified in support of HB 1019. He stated the regrant program is important to fund local community projects, there were 85 requests, 21 grants were made.

David Borlaug, President, Lewis & Clark Fort Mandan Foundation, provided written testimony and testified in support of HB 1019. He discussed the impact heritage tourism is

testimony and testified in support of HB 1019. He discussed the impact heritage tourism is making in the state and how much sites such as this have relied on the State Historical Society for guidance and how they have worked together to properly catalog and preserve artifacts.

Chuck Esser, Docent State Historical Society, provided written testimony and testified in support of HB 1019. He indicated he was new to the state and the program at the Heritage Center but stessed the importance of expansion and needed storage space for artifacts not on display.

Virginia Nelson, Executive Director, State Historical Society of North Dakota Foundation, provided written testimony and testified in support of HB 1019. She discussed the role the Historical Society plays in ND economic growth, the meetings with business leaders throughout the state, the state historic sits throughout ND, the growth and development of Medora, Williston, the new projects at Fargo, Wahpeton with Ft Abercrombie, the Lewis and Clark Bicentennial and its continued draw for generations to come. She urged continued investment in the Historic Society for a more robust tourism.

John Wahl, District 25, Southeast ND, testified in support of HB 1019. He indicated that federal funding is available but this is the last year it can be accessed, it is important to use this to complete the remaining phases of Ft. Abercrombie. He then urged support of HB 1019.

Senator Thane commented about Ft. Abercrombie reason for existing was because of the New Ulm massacre. The monies appropriated will be used for Phase 3 completion of the storehouse, interpretative center.

There being no further testimony or questions, Senator Holmberg closed the hearing on HB 1019.

Senator Christmann indicated below that another \$400 thousand dollars and another \$250 thousand in the Governor's budget for capital assets and cultural heritage. When you think of the other issues we have, I don't think \$650,000 is properly prioritized.

Senator Andrist also has a concern about what the House wants but like the Parks and Rec has the \$100,000 grant added for the Lewis and Clark Bicentennial and all of our green sheets note that the Bicentennial is over; another \$50,000 for Indian Affairs Commission to celebrate First Nations Day and \$50,000 for Standing Rock tourism.

Chairman Holmberg indicated there was \$250,000 on the International Peace Garden Budget resolution that was removed, we don't need to go back on that unless someone else is interested.

Senator Mathern indicated this is a small piece as they are going to raise \$40-\$50 million dollars in outside state money.

Senator Bowman indicated if there is any question as to how efficiently the park operates, they should talk with Wally Owen from Medora as he has a good handle on some of the efficiencies they do there. You could review discussions on where we could same money and where it is wasted.

Chairman Holmberg indicated he had to talked to people along those routes.

Fort Ambercrombie has tremendous potential and we just did not want to turn down \$200,000 in matching money from the federal government. We could end this one rather quickly over \$100,000.

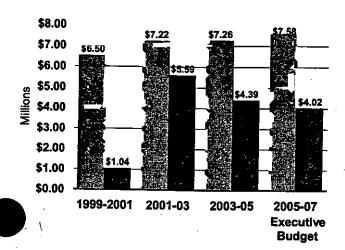

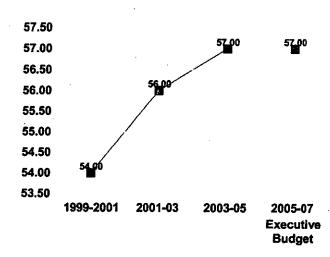

Explanation of Major Funding and FTE Variances for the 2003-05 Legislative Appropriation to the 2003-05 Current Estimates.

Capital Assets - Two million dollars in bonding authority will not be used due to lack of source of funds for repayment. Two Hundred fifty thousand dollars in federal Transportation funding will not be spent for the Gingras Historic site due to lack of general fund match

Grants - Approximately \$300,000 of authority will not be used in the federal historic preservation funds grant line item due to turnover of the Grants and Contracts Officer position. All federal funds will be spent in future federal fiscal years as authorized federal carryover.

Explanation of Major Funding and FTE Changes (Variances) for the 2005-07 Recommendation to 2003-05 Legislative Appropriations.

Salaries & wages - Salary increase based on Governor's recommendation for employee salaries.

My name is Virginia Nelsen, I am the executive director of the State Historical Society of North Dakota Foundation. Merl Paaverud and I have met with more than a thousand business leaders and supporters all across North Dakota. We have laid out the needs and the opportunities for heritage tourism for North Dakota. North Dakotans want to see investments in history.

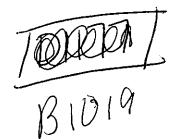
North Dakota leaders support the 10 Year Expansion Strategy in Support of Heritage Tourism growth as recommended by the State Historical Society of North Dakota Commission—a commission requested by the five former Governors and established by Governor John Hoeven."

The state of North Dakota has a rare opportunity. We are at a confluence of activities and circumstances that all point to the value of critical investments in tourism.

The long awaited "Lewis and Clark Bicentennial" is partially completed and a notable success we would all agree. Thousands and thousands of visitors, mostly from out of state, came, they saw and they loved North Dakota. The spent good dollars and they will come again. I heard a comment from Dave Borlaug, director of the Lewis and Clark Interpretive Center at Washburn...and he said is so many words...." when we look back on this event, the Lewis and Clark adventure, we will see this as the beginning, not the end, the turning point for tourism development in North Dakota....."

North Dakota now understands the value of Heritage Tourism---well educated and very curious travelers, with time and money to spend---came to North Dakota from every state in the union. Many of them proclaiming North Dakota was the last state they had left to visit. And, more importantly, they raved about the people, the landscapes, the cultural events, the history attractions and much more.

Williston is a prime example of a community that understands tourism. They made it a priority to build on their history---now showcasing three major state and federal historic sites. Visitation was up dramatically at the state sites and the community is buzzing with visitors, hotels remodeling and a real sense of accomplishment. They now have the "critical mass" of historic venues to be a "destination" in North Dakota.



Fargo and Wahpeton and surrounding communities deserve this same opportunity. A new interpretive center at Fort Abercrombie will add to the critical mass of history in that area.

We all agree that Medora is a shining star for tourism. Our most visited state historic site is the Chateau de Mores. Now we need to upgrade the existing interpretive center at this site. Devils Lake is a candidate for investment at Fort Totten, as is Cooperstown with a new cold war missile interpretive center. History continues in North Dakota.

What is the role of the state owned history sites for North Dakota? We are the anchor attractions that will allow county and regional history attractions grow and expand around.

The role of federal and state governments is to develop the history infrastructure of a state, creating a network of world class attractions in every region of North Dakota—anchoring tourism in that region.

There is no good reason to wait----historic attractions return 12-20 times their investment value, annually. Tourism advertising returns 83 times its value. It is foolish to wait on these investments. Stage the growth, make the investments, get on with the plans. If you delay, you are delaying growth, stopping potential income, wasting critical time. North Dakota needs a stable tourism industry to partner with the rocky agricultural industry and energy industry

In the January 2003 Interim Report to Governor Hoeven, the SHSND Commission recommended seven critical investments that need to be made in North Dakota to build a heritage tourism infrastructure:

- ✓ Invest in Regional Historic Sites
- ✓ Invest in the North Dakota Heritage Center as the Hub for History
- ✓ Invest in the Legally Mandated State Archives for the State's Records
- ✓ Invest in County and Tribal History Attractions
- ✓ Invest in State of the Art Technologies to Expand Access to History
- ✓ Invest in Professional Staff and Programs to Meet the Needs of Visitors
- ✓ Invest in Lewis and Clark a "Once in a Lifetime Opportunity"

The history agency and its supporters want to partnership with you to see this work is done for our state.

Testimony by Merl Paaverud, Director State Historical Society of North Dakota

Introduction

Mr. Chairman and members of the Committee, my name is Merl Paaverud and I am the director of the State Historical Society of North Dakota. I am happy to be here with you today to present the Society's Executive Budget Recommendation to you.

Agency Overview

The Society was established in 1895 as the primary state repository of artifacts, archival materials, and historic sites that are important to North Dakota's history. The mission of the state's history agency is to identify, interpret, preserve and promote the heritage of North Dakota's people.

- *We now have 57 full time staff, 40 seasonal staff, and 200 volunteers who work to support the Society.
- *We are responsible for 56 state historic sites, the newly completed Missouri-Yellowstone Confluence Interpretive Center, the Pembina State Museum, the State Archives and Historical Research Library, the State artifact Collection, the State Archeological Collection, and we operate the North Dakota Heritage Center.
- *We offer support to over 100 local historical societies and groups, provide technical assistance for museum operations, historic preservation, collections care and educational programs. The State Historical Society is the resource for genealogy and history of the state and Northern Great Plains.
- *We lead the way in historic preservation, history and education support for students and teachers. The Society partners with institutions of higher education for archeological field schools, internship opportunities, research assistance and recognized expertise.

2003-05 Statistics:

- *Over 450,000 people visited our museums and historic sites.
- *11,635 students from 49 different communities around the state accessed our SEND Trunks (Suitcase Exhibits for North Dakota).

Published "A Vast and Open Plain: the Writings of the Lewis and Clark Expedition in North Dakota, 1804-1806"

Installed a 2,000 square foot permanent exhibit and an 800 square foot temporary exhibit in the Missouri Yellowstone Interpretive Center.

Developed Lewis Clark posters series and distributed them to 4th and 8th grade teachers throughout the state.

Optional Adjustments - Operating

Salaries and Wages:

There were no additional positions or salaries recommended in the Governor's budget other than the basic salary increase of 4% and 4%.

Operating Expenses:

The Executive Recommendation included \$41,788 in operating expenses. This includes an increase of \$14,444 in federal authorization for the historic preservation program and \$27,344 in general funds for equipment under \$5,000. The general fund increase represents an adjustment from equipment over \$5,000 in the capital assets line item to the operating line item. The total funding for equipment is therefore maintained at the same level as the 2003-05 biennium. The budget also included an increase of \$9,000 for the purchase of "Past Perfect" artifact management software which will make better use of staff resources and provide better access to our collections that are not on display,

Capital Assets:

The Executive Recommendation for capital assets includes an increase of \$250,000 for compact storage systems for collections. This storage system makes the best use of available space and will allow the agency to continue its mission to store and preserve artifacts and archival materials. Also included is \$81,000 for equipment over \$5,000 including two Toro mowers, a Bobcat skid-steer loader, and two electric carts for historic sites use. The line item also includes an increase of \$36,914 for historic sites extraordinary repairs. The current formula developed by OMB to determine necessary fund for this purpose is at 23%. This increase will increase the general fund amount to 25%.

Continuing Appropriations Narrative:

Concession Fund

This continuing appropriation authority has been provided primarily for the operation of the Historical Society Museum Store operations for facilities at the North Dakota Heritage Center and State Historic Sites across the state. The Heritage Center Museum Store is viewed and operated as an extension of the overall State Historical Society education program. The store provides a forum through which museum exhibits and other aspects of North Dakota culture and history can be expanded upon for the benefit of the general public.

Although a profit margin is associated with all museum store items and is established by the director, profits realized from all sales are used to repurchase inventory and/or conduct other special educational projects through production of materials or publications for sale through the store. The emphasis of the store is not oriented toward large profits. Without the profits of the museum store, many publications and reproductions of exhibit related items would not be possible. All funds derived from the operation of the museum store are used for the purpose from which they were derived, namely the store operation and to supplement the publications activity of the State Historical Society. The Museum store aims to select quality items that meet specific criteria: Quality of work, whether in publications or crafts, must be professional; all items about North Dakota, its history, the culture of its people and its geography should be as accurate as possible; emphasis is

given to selling items produced in North Dakota thought exceptions are made. However, all items should pertain to North Dakota and the surrounding area; items sold in the Museum Store cannot be derogatory to race, creed, color, sex or religion; all items which are reproductions of artifacts from any museum will be labeled "reproduction" or "replica"; the Museum Store will not sell any items made of or containing fossils.

The other aspect of the concession fund relates to fees that are collected for the use of the facilities of the agency, fees for admissions, and use charges for services provided such as photographic, research and microfilm services. All these funds are used to offset the direct costs associated with providing these services and include supplies, materials, equipment and temporary staff for seasonal historic sites assistance.

Gifts and Bequests:

Historically, museum operations have depended greatly on the generosity of supporters of the humanities for their continued existence. The authority provided for the acceptance of gifts and bequests stems from this desired support. All funds are maintained in the state treasury. Most gifts are given for a specific purpose either to support a specific exhibit, collection or program and such gifts are restricted to the purpose for which it was given. Most gifts are small and come through the agency's donation boxes. There has never been a large enough donation to establish a trust which could produce significant income on a continuing basis.

Archeological Permits

Any individual, organization, institution or company engaged on one's own behalf or on behalf of another to identifying, evaluating, or mitigating adverse effects on cultural resources, historic buildings, structures, or objects on any lands in North Dakota must obtain an annual permit from the director of the State Historical Society. Such fees are deposited in the revolving fund and must be used by the director for making investigations of permit applicants and for management and analysis of records and artifacts submitted to the director under sections 55-03-01, 55-03-01.1 and 55-03-02.

Spreadsheets for these three areas are attached to this document.

Thank you Chairman Holmberg and members of the Senate Appropriations Committee for the opportunity to appear before you today in support of HB 1019.

The good work of the Senate Appropriations Committee and the House Appropriation

Committee is reflected in HB 1019 and other bills, and this work is generating a great amount of excitement in history circles in the state. We appreciate your insight and trust that HB 1019 will be supported in full by your committee.

The Historical Foundation is working hand and glove with the State Historical Society to build an informed and educated network of North Dakota communities and to promote additional tools to help them to grow their county museums and history attractions. The re-grant funding enhancement of HB 1019 is a very important and critical resource for funding for local communities. Published "A Vast and Open Plain: the Writings of the Lewis and Clark Expedition in North Dakota, 1804-1806"

Installed a 2,000 square foot permanent exhibit and an 800 square foot temporary exhibit in the Missouri Yellowstone Interpretive Center.

Developed a Lewis Clark poster series and distributed them to 4th and 8th grade teachers throughout the state.

Optional Adjustments - Operating

Salaries and Wages:

There were no additional positions or salaries recommended in the Governor's budget other than the basic salary increase of 4% and 4%.

Operating Expenses:

The Executive Recommendation included \$41,788 in operating expenses. This includes an increase of \$14,444 in federal authorization for the historic preservation program and \$27,344 in general funds for equipment under \$5,000. The general fund increase represents an adjustment from equipment over \$5,000 in the capital assets line item to the operating line item. The total funding for equipment is therefore maintained at the same level as the 2003-05 biennium. The budget also included an increase of \$9,000 for the purchase of "Past Perfect" artifact management software which will make better use of staff resources and provide better access to our collections that are not on display. An additional \$15,000 was included for educational and promotional posters to be printed and distributed to schools as well as sold in the Museum Stores. An additional \$250,000 was added to the Cultural Heritage Grants program for a total of \$325,000.

Capital Assets:

The Executive Recommendation for capital assets includes an increase of \$250,000 for compact storage systems for collections. This storage system makes the best use of available space and will allow the agency to continue its mission to store and preserve artifacts and archival materials. Also included is \$81,000 for equipment over \$5,000 including two Toro mowers, a Bobcat skid-steer loader, and two electric carts for historic sites use. The line item also includes an increase of \$36,914 for historic sites extraordinary repairs. The current formula developed by OMB to determine necessary fund for this purpose is at 23%. This increase will increase the general fund amount to 25%. \$200,000 was included to match the Save America's Treasures Grant for construction of a new interpretive Center at Fort Abercrombie.

Continuing Appropriations Narrative:

Concession Fund:

This continuing appropriation authority has been provided primarily for the operation of the Historical Society Museum Store operations for facilities at the North Dakota Heritage Center and State Historic Sites across the state. The Heritage Center Museum Store is viewed and operated as an extension of the overall State Historical Society education program. The store provides a forum through which museum exhibits and other aspects of North Dakota culture and history can be expanded upon for the benefit of the general public.

Although a profit margin is associated with all museum store items and is established by the director, profits realized from all sales are used to repurchase inventory and/or conduct other special educational projects through production of materials or publications for sale through

the store. The emphasis of the store is not oriented toward large profits. Without the profits of the museum store, many publications and reproductions of exhibit related items would not be possible. All funds derived from the operation of the museum store are used for the purpose from which they were derived, namely the store operation and to supplement the publications activity of the State Historical Society. The Museum store aims to select quality items that meet specific criteria: Quality of work, whether in publications or crafts, must be professional; all items about North Dakota, its history, the culture of its people and its geography should be as accurate as possible; emphasis is given to selling items produced in North Dakota, though exceptions are made. However, all items should pertain to North Dakota and the surrounding area; items sold in the Museum Store cannot be derogatory to race, creed, color, sex or religion; all items which are reproductions of artifacts from any museum will be labeled "reproduction" or "replica"; the Museum Store will not sell any items made of or containing fossils.

The other aspect of the concession fund relates to fees that are collected for the use of the facilities of the agency, fees for admissions, and use charges for services provided such as photographic, research and microfilm services. All these funds are used to offset the direct costs associated with providing these services and include supplies, materials, equipment and temporary staff for seasonal historic sites assistance.

The authority provided for the acceptance of gifts and bequests stems from this desired support. All funds are maintained in the state treasury.
