Current law provides that if such sales occur that these funds must be deposited in the state general fund. No funds have been deposited in the general fund for several years as there has been no incentive for Wildlife Services to take the time to skin animals for their furs and skins.

Minutes:

Senator Stanley Lyson, Chairman of the Senate Natural Resources Committee opened the hearing on HB 1094 relating to the disposition of furs taken by the United States department of agriculture wildlife services.

All members of the committee were present.

Wayne Carlson, Livestock Services Coordinator of the North Dakota Department of Agriculture testified in support of HB 1094 (See attached testimony). He also distributed to the committee a letter of support of HB 1094 from Rick Tischaefer of the North Dakota Fur Hunters and Trappers Association (See attached).

Senator John Traynor asked how it is that the North Dakota Legislature can tell the United States Department of Agriculture how to spend their money.

Wayne Carlson responded that the salary of \$800,000.00 that is paid to those doing the work of the program is paid by the state. Although they are federal employees they are doing the activities of the state.

**Senator Traynor** asked if it was the Department of Agriculture that is selling the furs and receives the proceeds, how can North Dakota tell them how to spend it.

Wayne Carlson confirmed this was the way the existing law is written and should be changed so the proceeds can be used for further duties.

Senator Rich Wardner asked how the proceeds are distributed.

Wayne Carlson as present time money has never gone into the general fund.

Senator Lyson asked for opposing testimony.

Gary Jesper representing the North Dakota Fur Takers Association testified that he did not want to go on record as being opposed to HB 1094, but very much support the wildlife services and the use of problem animals they take. He requested an amendment that would put a limit of \$15,000.00 per year on the amount of fur that they can sell. Conferring with the Wildlife Services, they have agreed the cap to be acceptable.

**Senator Joel Heitkamp** asked why there needs to be a cap.

Gary Jesper answered that in some states, the Wildlife Services went into the fur business.

Large numbers of coyotes were harvested by helicopters with hired skinners in the harvest. This is not fair to private fur hunters.

Senator Michael Every asked if they tried to amend the bill in the house hearing.

Gary Jesper told the committee the amendment was discussed in the house hearing and it was suggested the bill be corrected in the senate hearing.

Senator Wardner asked what was presently being done with the furs.

**Gary Jespers** responded that he thought they were not harvesting at the present time but asked that the question be referred to the proper people.

**Phil Mastrasgelo** (49.6) with the United States Wildlife Services Program stated that to answer the question, the department is not doing anything with the animals at this time. He further stated there is a value to these animals and would like not to waste this an important resource. He reported there were not a lot of these animals and would be surprised if passage of HB 1094 would generate \$3000.00 under the \$15,000.00 cap.

**Senator John Traynor** asked if the United State Department of Agriculture was comfortable with the language to direct their department what to do with the funds.

**Phil Mastrasgelo** told the committee the department was very much comfortable with the language.

Senator Lyson closed the hearing on HB 1094.
