Minutes:

Chairman Kelsch opened the hearing on HB 1234.

Rep. Hawken, District 46, introduced the bill. This bill deals with all day kindergarten and those people who testified before me on HB 1230 and who spoke to the importance of the availability of kindergarten programs did a marvelous job of telling you why this is an important thing for us to look at. Many experts will tell you that the beginning time of education is the most important time. Many school districts are already offering all-day kindergarten and doing it with local dollars. This bill says we will pay for all day kindergarten.

**Rep. Norland:** Is it fair to say that kindergarten is the wrong name, that it should be grade one.

The curriculum for kindergarten expects whatused to be expected at grade one.

**Rep. Hawken:** At least junior first grade. Things have absolutely changed. I think we will soon see early childhood education in our schools because it is so necessary. Every bit of research talks about quickly young children learn.

**Rep. Mueller:** There was reference made in some earlier testimony on the previous bill that talked about the impact on day care center issues. Have you thought about that? Positive? Negative?

**Rep. Hawken:** You really can't give a definitive answer on that. I know there are a number of people who feel that all-day kindergarten is nothing more than day care. I don't believe that.

There is a working relationship between day care providers and schools now.

**Rep. Hunskor:** Prorated payments? If a school district was to receive a \$1000 for each student in full-time kindergarten, for a school district offered half time, would that mean \$500. Is that the proration.

**Rep. Hawken:** There is a weighting factor for kindergarten students and this would them a 1.0 as well if it's a full day program.

**Sen.. Every, District 23,** testified in favor of the bill. Spoke to the experience of his granddaughter who was deaf and success she had because of the effect of the full-day kindergarten. It is important we provide that opportunity to all of our kids.

Sen. Flakoll, District 44, spoke in favor of the bill. There was another bill like this one in the Senate and was withdrawn to provide support for this one. Look at if this should be mandatory for all at risk students. There is research that shows it does make a significant difference. When you look at equity and true need across the state, I think we need to look at insuring that those individuals really have what they need to achieve and stay with the rest of the class. The weighting value for half-day kindergarten is currently .6.

**Rep Mueller:** About the 15 mil issue, there is some part we don't cover. How is the school district going to pick up the cost. It helps those districts that are at the mil cap. This may drive us further away from equity.

Bev Nielson, ND School Board Association, testified in support of the bill, but asked that the legislature not mandate full day kindergarten. Cost should come from the state, but should allow some local way of funding.

Barb Arnold-Tengesdal, Voices for North Dakota's Children, testified in support of the bill.

(Testimony attached.)

Chuck DeRever, assistant superintendent of Fargo Public Schools, testified in favor of the bill. The point of having kindergarten is to provide students to be prepared for compulsory education. I am concerned that we continue to piece meal the educational plan in this state. I find it interesting that we don't talk about preschool kids unless they are handicapped, but we don't, if they have other deficiencies, provide them an opportunity to be ready. This bill doesn't go far enough.

**Rep. Norland.** Early development is where we should put money. Suppose we turn around and drop funding at second semester of grade 12 if they don't want to stay in school? Just as with foreign language. Research shows that that should start long before high school. What are your thoughts on that?

**DeRever:** There is no question that putting the money early is the best investment we can have. For every \$1 invested in early childhood education, and that goes way before kindergarten, you get a \$7 - \$9 return that you don't have to put into kids later on. My contention is if we did a better job up front, we'd have much less problem at the end. There are a lot of ironies in

discussion.

education. Colleges are all willing to take students who have AP credit. My question to colleges is: If we are teaching your course, why can't our students get the same college credit for the same price at your institution? There are two reasons students don't go to college, one is convenience, one is cost. We've entered into an agreement with Whapeton Junior College where we offer two of their classes at our institution for the \$85.

**Doug Johnson, ND Council of Educational Leaders,** testified in support of the bill. Their assembly voted unanimously in favor of full-time kindergarten.

Gloria Lokken, NDEA, spoke in favor of full-day kindergarten. She said the state needs to stop forward and fund it.

Vivian Schafer, ND Children's Caucus, spoke in favor of the bill. It should be a part of a child's life.

**Chairman Kelsch** asked **Jerry Coleman** to come forward for some questions regarding funding. She asked why there was no fiscal note with the bill.

Coleman: There was one for a previous bill that was withdrawn and he shared the cost on that one which was basically the same as this one. Cost estimates were based on 03-04 school year was \$30 million. Of that amount, \$12 million was identified as direct classroom expenditures. If 100% of the districts went to full-time kindergarten we would expect that cost to double.

Chairman Kelsch closed the hearing on HB 1234. She appointed a subcommittee: Rep. Hawken, Rep. Horter, Rep. Mueller to look at the fiscal note and some possible amendments and investigate whether or not we need to look at including other alternative programs in this

**Rep. Mueller:** I don't know how we can do this. There's no way we can tell how many students will attend full day kindergarten if it was available.

**Rep. Haas:** Does the fiscal note assume that all those schools currently operating a half day program would go to a full day?

**Chairman Kelsch:** They estimated that 50% of all kindergarten students would attend full day programs.

**Rep. Hawken:** It's our responsibility to set policy and let appropriations pay. We need to pass this or kill it.

**Rep. Mueller:** We don't know who is going to do full day. Those who now do it will continue. I think this is on the high side.

This bill expands the per student weighting factors to allow state aid for full day kingergarten (KG). The current per pupil payments for KG is based on half day programs with no additional funding for longer days.

Total Expenditures for KG programs were \$30 million in 2003-04 of which \$12 million were identified as direct classroom expenditures. If all school districts went to full day KG, we would expect classroom costs to double increasing costs by another \$12 million annually.

Using a weighting factor of 1.1095 for full day KG and estimating that 50% of all KG students would attend full day programs, weighted pupil units would increase 1,311 each year. Estimating the base per student payment at \$2,775, the annual cost in state aid payments would be \$3.7 million annually (1,311 wpu x \$2,775) or \$7.4 million for the biennium.

For the purposes of this note, we estimate that 25% of all KG students would attend full day programs in the first biennium and that 50% would attend full day KG in the following biennium.

The appropriations line for per student aid and transportation payments would require an additional \$3.7 million for the current biennium to fund the change in factors under this bill.

Voices for North Dakota's Children is a collaborative advocacy effort of early childhood education professional organizations. It is made up of the North Dakota Head Start Association, North Dakota Association for the Education of Young Children, Child Care Resource & Referral Network and Children's Caucus.

We urge your support of HB 1234.

At a time when the emphasis is on school accountability and increased student achievement, we are challenged to find ways to deliver educational programs that will help children learn in a developmentally appropriate and culturally sensitive way (Young Children, Nov. 2003, pg. 54). We believe the best educational start available would be to allow school districts to adopt full-day kindergarten. The state would see economic, social and educational benefits such as reported in the research tracking full-day kindergarten.

The research reflects the effects of full-day kindergarten as positive, with studies documenting improved language development, social skills, and academic achievement. When implemented with a developmentally appropriate curriculum and quality teaching practices, full-day programs allow for more relaxed instructional pace, time for children to reflect on their learning, and more classroom involvement (Young Children, Nov. 2003, pg. 55). Statistics on academic gains have been reported locally and around the state by Fargo, Bismarck and Devils Lake.

The research on the benefits of early childhood education is overwhelmingly positive. The most significant gains are seen in children of low-income families. The High/Scope Perry Preschool Project recently reported findings showing participants have higher income earnings, more likely to hold a job, commit fewer crimes, and graduate from high school (High/Scope Educational Research Foundation, Nov. 2004).

Will this decision affect the child care industry? It will at first. Many districts already provide kindergarten, and caregivers work around a variety of schedules creating difficulties arranging for children's off-days. Will we have enough kindergarten teachers to fulfill a full-day option? Yes! Those who choose to work in early childhood education often leave the state for other jobs or take on positions in other grades in which they never intended to work in.
