Madam Chairman and committee members the language before you in the bill 1247 would adjust those boundaries to more accurately represent the planted acres distribution across the state of North Dakota. Minutes:

Chairman Flakoll opened the hearing on HB 1247, a bill relating to the dry bean council and dry bean districts; and to provide for application. All members were present.

Representative Aarsvold introduced the bill. (written testimony) (meter 4292).

Representative Munson testified in favor of the bill. (meter 4292) The members of the Dry Bean Council will be able to answer any questions.

Mike Beltz, Hillsboro farmer and chairman of the North Dakota Dry Bean Council, testified in favor of the bill. (meter 4390) The bill makes three changes in current statute, a change in boundaries of districts, adding a sixth district and changing the term limits. He distributed a map showing the current and proposed districts. (attached) The opportunity to serve a third term helps because it takes a while for board members to get up to speed on the work of the council.

Senator Flakoll asked how the group decided on the changes together.

Mr. Beltz said yes.

Senator Klein asked if we are adding a member by adding district 6.

Mr. Beltz said 75% of the acres in district 6 are in Wells, McLean and Benson Counties, that is where the concentration of dry bean acres are.

Senator Klein asked if this will create an even amount of acres in the districts.

Mr. Beltz said yes.

Representative Aarsvold said he will be giving up the distinction of having 3 separate bean districts in his legislative district. (meter 4741)

Chairman Flakoll closed the hearing on HB 1247.

Senator Klein moved a do pass on HB 1247.

Senator Erbele seconded the motion.

The motion passed on a roll call vote 6-0-0.

Senator Erbele will carry the bill.

HB 1247 comes to you at the request of the North Dakota State Dry Bean Council. It makes two changes in existing law.

First, if passed it would change the eligibility for service on the Bean Council form two (2) to three (3) terms. The terms will remain at the present three (3) years.

Secondly, the districts that each council member represents would be redrawn to reflect the ever changing distribution of dry edible bean planting in North Dakota. The advent of irrigated acreage in the central and western counties has resulted in dry bean production shifting to the west. The proposed districts in HB 1247 will more accurately represent each district's actual planted acres as its share of total planted areas.

There are representatives of the North Dakota State Dry Bean Council present to address any technical questions the Committee may have.





Testimony HB 1247 February 25, 2005

HB 1247 comes to you at the request of the North Dakota State Dry Bean Council. If passed, it would make three changes in current statute.

First, if passed, it would change the eligibility for service on the Bean Council from two (2) to three (3) terms. The individual terms would remain at the present three (3) years.

Secondly, the districts that each council represents would be redrawn to reflect the ever changing distribution of dry bean planting in North Dakota. The advent of irrigated acreage in Central and Western North Dakota plus the growing population of corn and soybean production in the eastern countries have shifted dry bean production to the west. The proposed districts in HB 1247 will more accurately

represent each district's actual planted acres as its share of total planted acres.

Thirdly, the Bean Council proposes the addition of a sixth district to represent the new and unique growing area in Central and Western North Dakota.

There are representatives of the North Dakota Dry Bean Council present to address any specific concerns you may have.

I encourage the committee's favorable recommendation to the Senate on HB 1247.
