I am here to testify in favor of FHB 1253 which would provide for annual reporting of agricultural land ownership by limited liability partnerships.

Minutes:

Chairman Flakoll opened the hearing on HB 1253, a bill relating to the registration of limited liability partnerships; relating to the registration of limited liability partnerships.

Representative Onstad introduced the bill. (written testimony)

Senator Seymour asked why the bill was introduced, it seems like a minor issue. (meter 2482) **Representative Onstad** said the examples listed in his testimony are two of the smaller reasons for the bill. His main concern is to require LLP's to report their members so it can be determined if they are compliant with our corporate farming law.

Senator Taylor asked the difference between LLC and LLP, why are these structures chosen.

Representative Onstad said LLC's were chosen initially because it was the only option available. The difference is the income tax structure, the LLC pays the tax and file to the members, in the LLP everything is transferred to the partners.

Senator Flakoll said in another committee there was talk on a bill about land ownership and it was said that 12% of land in North Dakota was owned by out of state or other interests. Would this help us get a handle on this.

Representative Onstad said this will help. The managing partner is the only one listed now and we don't know if there are out of state or non-related partners. The Attorney General's office has been somewhat concerned about this. Paul Germolis who is no longer with that office was always concerned about it.

Senator Flakoll asked if there was any discussion about listing the percentage of ownership among the partners so that we might be aware of out of state interests percent of land ownership.

Chris Friesz, legislative intern, distributed the written testimony of Woody Barth, North

Dakota Farmers Union, in favor of the bill.

Clara Jenkins, Business Division Director, Secretary of State's Office, testified in favor of the bill. (written testimony) (meter 3019)

Senator Erbele asked what in the chapter that would a red flag, who is not qualified. (meter 3221)

Ms. Jenkins said they would be looking to see if there are any corporate or LLC members, if so they have to look further. It would save some litigative process in the Attorney General's office. Some LLP's have acquired land and there has been memberships by corporations in other states and the Attorney General's office has pursued them and they have had to divest themselves of the land and have probably incurred some considerable expenses in that regard.

Senator Flakoll asked if this will change who can and who can't be a part of LLP's.

Ms. Jenkins said this will not impair the ability of LLP's who are qualified to own farm land, it will serve as a red flag for those who cannot. This would stop those situations before they happen.

Senator Flakoll said this is no Pandora's box.

Ms. Jenkins said this does not affect the corporate tax law, it helps with the enforcement.

Chairman Flakoll closed the hearing on HB 1253.

Senator Taylor moved a do pass on HB 1253.

Senator Erbele seconded the motion.

The motion passed on a roll call vote 5-0-1.

Senator Erbele will carry the bill.

The Secretary of State does not have a position on the merits of this bill.

Nevertheless, to make the bill compatible with existing law related to Limited Liability Partnerships and with the procedures within the Secretary of State's office, the attached amendments are offered for the committee's consideration.

For example, Chapter 45-22 of the North Dakota Century Code already includes an annual reporting requirement for Limited Liability Partnerships with the Secretary of State under N.D.C.C. § 45-22-21.1. It would make the law clearer if the land description requirement in the bill were added to the reporting requirement in the existing section of law rather than creating a new section, as this bill would do.

In addition, the first annual report for a Limited Liability Partnership is not due until the year following that in which the LLP was registered with the Secretary of State. Therefore, the Secretary of State is recommending that N.D.C.C. § 45-22-03(3) be amended to include a requirement on the original registration of the LLP to disclose if there is an intention to purchase or lease land to be used for farming or ranching. By including this disclosure, it will make it easier for the Secretary of State to identify those Limited Liability Partnership's that may have corporate partners and who need to comply with Chapter 10-06.1 of the North Dakota Century Code.

We are just saying to be more uniform with all Entities that have to report to the Secretary of State's office. Let's have the same rules for all. When it pertains for agricultural ownership we have to pay more attention, because of our current Corporate Farming Laws.



The Secretary-of State supports Engrossed HB 1253.

As Engrossed, the bill includes amendments requested by the Secretary of State and approved by the House, which now make the bill compatible with other farming and ranching provisions of the Century Code as they pertain to other organizational structures, e.g., corporations and limited liability companies, and with the processing procedures within the agency.

When a Limited Liability Partnership files its initial registration with the Secretary of State's office, this bill requires it to disclose whether it intends to own or lease land that will be used for farming or ranching.

In addition, if it is disclosed that the Limited Liability Partnership does intend to own or lease land for farming or ranching, the bill then requires that they must disclose the names of all partners.

By including this disclosure, it will enable the Secretary of State to determine if all of the -partners in the Limited Liability Partnership are in conformance with the provisions of Chapter 10-06.1 of the Century Code. This chapter pertains to the Corporate and Limited Liability Company Farming Act.

If the Limited Liability Partnership is not in conformance, then, under N.D.C.C. § 10.6.1-21, the Secretary of State must inform the Attorney General and the Governor.

In addition to including on its annual report a description of the land owned by the Limited Liability Partnership (as is now required of corporations and limited liability companies engaged in farming or ranching), they will also have to annually disclose the names of all partners. This is to ensure continued compliance with the Corporate and Limited Liability Farming Act.

Testimony in Support of HB 1253

Good Morning Chairman Flakoll and members of the Distinguished Senate Agriculture Committee. I am Representative Kenton Onstad, District 4.

HB 1253 addresses an issue of proper reporting of Limited Liability Partnerships when it involves agricultural land to the Secretary of State. The legislation in front of you would make the reporting requirements uniform for LLP's as they currently are for LLC's

LLC's currently have to list all of the members involved, purpose for establishment and other general information. LLP's only have to list the Managing Partner. The number of LLP's are increasing, furthermore, realizing the need to disclose the entire partnership.

LLP's ,as well as LLC's , may have several members and with our current Corporate Farming laws the proper reporting is necessary.

ND Game and Fish has an immediate concern of ownership when applying for a gratis permit.

Oil and Gas Leases find the need and the difficulty to identify the owners.

You might be well aware of other situations, when multiple owners of a certain property.

HB 1253 allows for uniform reporting to the Secretary of State's office.
