CHAIRMAN NICHOLAS: Committee Members, we will open the hearing on HB 1272.

Representative Headland, we will start with your testimony.

REPRESENTATIVE HEADLAND: I represent District 29. I am here today to ask your support on HB 1272. The intent of this bill, we are just asking that we straighten the code. To make sure that the make up of the wheat commission board is made of people who are raising wheat. Not refunding on the check off and are raising wheat. Not refunding on the check off and that they are living here and not going south for the winter. And they are attending the meetings. Having hands on will strengthen the commission. It is the right direction.

CHAIR: Any questions?

CHAIR: Other testimony in support of HB 1272?

REPRESENTATIVE BRANDENBURG: I support the bill. You need to be a wheat producer, go to meetings and pay the check off. I think this bill will address this.

CHAIRMAN NICHOLAS: Other support.

HARLIN KLEIN, CHAIRMAN OF THE NORTH DAKOTA WHEAT COMMISSION. I AM HERE TO TESTIFY IN SUPPORT OF HOUSE BILL NO. 1272. [PLEASE SEE ATTACHED TESTIMONY OF HARLIN KLEIN] At the end of printed testimony Harlin read the statement that says. ""Other commodity groups have language which does not allow producers who seek refunds to he check-off to participate in the election process. Similar language in the Wheat Commission law may also have merit. Any questions.

CHAIR: Any questions from Harlin.

REPRESENTATIVE BRANDENBURG: What about farmers raising wheat in two different counties and actually are voting twice for two different people. I think there should be lone vote. What your place of residence is, that is where you should be voting.

HARLIN KLEIN: I have no problems with that. I have land scattered around.

REPRESENTATIVE MUELLER: Those eligible to participate in the county elections

Process. I am not sure I know. Is that something the commission could do or dose it have to be done legislatively.

KLEIN: I am not sure. It still comes back to producers in the county making the decisions. How restrictive do we want to get with that. I feel they should be wheat producers if they are going to represent wheat. One year you grow wheat, one year you don't because of whether conditions. How do we draw the line if disease conditions take over the crop..

CHAIR:

HEADLAND: I am not sure of the election process and how it goes. Are wheat producers voting..

KLEIN: I think the last election there were like ten producers that stayed for the election.

BOE: What if no one shows up.

NEIL FISCHER:. I can remember this happened twice in a county. County Agent is in charge of voting. Where wheat producers live they vote. By and large where we have wheat producers live and raise wheat we have a good participation at meetings. 50 to 60 people vote. The extension service is in charge of elections.

CHAIR: F.S.A. OFFICE. You have a list of all the people that pay tax, they are the ones that should be voting. I have heard what you said about a short crop and they cut it for hay but Perhaps they could be allowed to vote for one or two years that they don't pay the taxes if they have a record that is positive for past years. Send a ballot from the commission. This way everyone will get a ballot. What would be the problem with this.

FISCHER: We don't have a list. Of payors. We have a list of those who do not pay the tax. List of names of refunds.

BOE: How do we compare to other states?

FISCHER: Some boards are appointed by the Governor. Most states are similar. It is a major undertaking to send out refunds. You have to keep track of every producer.

UGLEM: Who got refunds. What was the reason for the refunds.

CHAIR: Any other testimony?

LOUIS CUSTOR NORTH WEST WHEAT COMMISSIONER BOARD: Serve on board Producers should be part of county in which they live to vote. That is consistent with state law. It is logical. As to mail order votes I can see that but there would be considerable cost in that.

The language as I see it they vote only in there own county.

I think those are tough word there and I would resist the amendment if that is the way it is going to be.

REPRESENTATIVE HEADLAND: We have commissioners that go south for the winter And I donut think they are participating and I don't think that is what producers want.

It may seem harsh but I saw no other way to state it.

REPRESENTEE MUELLER The words MAY AND SHALL don't seem to be getting along. Is it possible that it could be a MAY INSTEAD OF SHALL.

REPRESENTATIVE HEADLAND: I think MAY opens up a gray area. What is ligament reason for absence.

REPRESENTATIVE BRANDENBURG: There are only seven members on the commission.

Thousand of wheat farmer in state. I think it is an honor and privilege to serve on board.

I hope no misses two meeting in a row. They are representing thousand of growers in the state.

You have to be able to take the time.

REPRESENTATIVE MUELLER:: I would like to heart the wheat commission thought on this.

Chairman Flakoll opened the hearing on HB 1272, a bill relating to membership of the wheat commission; and to provide for a legislative council study. All members were present.

Representative Headland introduced the bill. It was introduced to strengthen the qualifications for the Wheat Commission. If a person has requested a refund of the wheat checkoff in the prior three years, the are ineligible to serve on the Wheat Commission, if they do not grow wheat, they are ineligible and they must attend the meetings in order to remain in the Wheat Commission.

Senator Klein asked if they meet four consecutive meetings, out of the four meetings per year,

Representative Headland said yes.

they may not serve.

Representative Headland said what is right for the Wheat Commission is right for the district representatives too. There has been some confusion in where producers vote and this bill clarifies they vote in the county of residence. They wanted to provide for producers to participate

in the elections by mail but they didn't have time to devise a system for it so they provide for a legislative study in the bill.

Senator Flakoll asked about a producer who lives in one county but grows wheat in another.

(meter 393)

Representative Headland said they would vote in the county where they lived.

**Senator Klein** asked if you can vote if you don't plant wheat for a year but not be a representative.

Representative Headland said that is correct, the election process has not been changed.

Senator Erbele asked if a producer gets a refund can they still vote.

Representative Headland said yes.

**Senator Flakoll** asked if a member of the Wheat Commission misses two consecutive meetings and is removed from the board, is there a provision to get back on the board.

Representative Headland said there was a lot of discussion about this and the language is harsh. It is the same language as the Beef Commission. He thought there was language in the bill that would provide for extenuating circumstances but its not in the bill now, he is not sure why.

Senator Flakoll asked what is the term of a member of the Wheat Commission.

Representative Headland said four years.

**Senator Urlacher** asked if a Wheat Commission member is ineligible after a year, would there be an election to replace him.

Representative Headland said yes.

**Senator Taylor** asked if the Wheat Commission could take care of this through rule making and not go through the legislature.

Representative Headland said the qualifications of the Wheat Commission are in code now.

The Wheat Commission can't make their own rules on it.

Senator Seymour asked if the Wheat Commission has its own bylaws and constitution.

Representative Brandenburg testified in favor of the resolution. If you play, you should pay.

You vote where you live. Some farmers have voted in more than one county. Regarding missed meetings, there are four quarterly meetings per year plus special meetings. It is an honor and privilege to serve on the Wheat Commission. The Beef Commission has a phrase about undue cause that is not in the bill now. This means you cannot spend the winter in Arizona and serve on the Wheat Commission. It is happening. We also need to study the election process.

**Senator Seymour** said he has mixed emotion about this, if a producer who gets a refund, they are not eligible to serve on the Wheat Commission. In a democracy, everyone should have their voice.

**Representative Brandenberg** said he had the same feelings. However, when you pay the checkoff you are part of the process.

**Senator Flakoll** asked if you can be on the board of the Dickey County Rural Telephone Cooperative if you do not use their services. (meter 1341)

Representative Brandenberg said no.

Representative Headland said you cannot be a member if you don't use the services.

**Harlan Klein**, Chairman of the North Dakota Wheat Commission, testified in favor of the bill. (written testimony) (meter 1418) It is important to update the qualifications. The board is required to meet quarterly but it is usually 6 - 9 meetings per year. In his county they rotate the county elections between three towns. In Carson, the attendance of wheat producers in less, it is

more livestock country. You never know where the meeting will be in the rotation when a commissioner is elected. In Elgin and and New Leipzig, more wheat producers attend.

Senator Flakoll asked if attendance has been a problem.

Mr. Klein said some people think it is but he doesn't.

Senator Flakoll asked how much notice is given before meetings.

Mr. Klein said two or three weeks.

**Senator Flakoll** asked if the legislative intent is to include special meetings in the two consecutive meetings clause.

Mr. Klein said that is a good question.

Senator Flakoll asked if meetings can be at the call of the chair.

Mr. Klein said yes.

**Senator Flakoll** said a chair could attempt to get someone off the board who had missed a meeting by calling another at an inopportune time.

Mr. Klein said that is possible.

**Senator Flakoll** asked if a farmer rents out his land, is he eligible to serve on the Wheat Commission.

Mr. Klein said if they pay the check off, they are a producer so if they crop share, they can serve, if they cash rent, they cannot.

**Senator Klein** asked why there were only 7 people at the election in Mr. Klein's county, didn't they serve a free meal.

Mr. Klein said they served lunch.

Senator Klein asked if the county agent determines who the wheat producers are.

Mr. Klein said yes but at the county meeting, everyone knows their neighbors.

Louis Custer, a durum producer from Montrail county, testified in favor of the bill. (meter 2160) He is the district 2 commissioner on the Wheat Commission. He has some concerns. He is testifying as an individual because the Wheat Commission does not have a position on the bill. He initially supported the refund clause but he can see the other side of the issue. It might insulate the Wheat Commission from change and dissent. The bill has no prohibition regarding county representatives and refunds. It could shrink the pool of participants, of eligible board candidates. If a producer feels the Wheat Commission hasn't heard their grievances, they may feel the refund process is their only way to be heard. We need to be careful about limiting their ability to refund. He has no problem with the Wheat Commission members not refunding because they have a seat at the table and can affect change in that chair. The three year restriction should be reconsidered. Election participation is small sometimes, large sometimes. It there is a hot issue, there is a good turnout. He supports the requirement to raise wheat. If a farmer is renting his land, he doesn't belong on the board because he doesn't feel the results of board action.

Senator Klein asked if he has concerns about a county representative not seeking a refund.

Mr. Custer said there is only one chance in four years to serve on the Wheat Commission. If a producer refunded just one load of wheat within three years they would not be eligible. Refunds are requested every 60 days.

**Senator Taylor** asked if he fears the Wheat Commission could get too chummy, too yes oriented.

**Senator Flakoll** asked if the refund rate is 6 -7%.

Mr. Custer said it is about 6.5%, based on money, not on producers.

**Senator Klein** said with 6 - 7% refunds, there is still a base. 6% of the dollars is different than 6% of the producers.

Mr. Custer said he thinks it would be less than 1% of producers.

Senator Klein said that is not hurting the pool of candidates very much.

Mr. Custer said some of the more outspoken candidates tend to be good in these positions.

Jim Diepolder, Willow City farmer, testified in favor of the bill. (meter 3364) He would like to see the refund clause changed from three years to one year. Three years could take someone out of the whole election cycle. The Wheat Commission should be limited to hands on farmers, they should be listed as operators at their county FSA office. This is a problem. The Wheat Commission hasn't taken a position on this. One member of the Wheat Commission only raises one quarter of wheat and one is semi retired and one has not been an operator for four years. November to March is the time to participate on the Wheat Commission and a member can't be in Arizona. Elections are a problem, producers don't show up. Five or ten might show up in when there are 3000 wheat producers. Maybe mail in ballots are a good idea.

**Senator Klein** asked if a farmer renting his land on a crop share basis is OK to serve.

Mr. Diepolder said they would be eligible to vote and maybe serve as county representative but not the Wheat Commission. They need to be hands on farmers to serve on Wheat Commission. If their primary function is not farming they should not be on the Wheat Commission. They need to be an operator.

Senator Seymour said sometimes active farmers don't have time to serve.

Mr. Diepolder said that is correct but priorities need to be set.

Josh Kramer, North Dakota Farmers Union, testified in favor of the bill. He sees a problem with the three year refund clause. If a producer doesn't agree with the mandated 2 mils, you can't refund and have a voice on the Wheat Commission.

Senator Taylor asked what his position would be on a one year refund clause instead of three.

Mr. Kramer said he would have to refer to the policy manual but one year would be better than three.

Chairman Flakoll asked Neal Fisher to appear for informational purposes.

**Neal Fisher**, administrator of the North Dakota Wheat Commission, appeared to answer questions. (meter 4161)

**Senator Flakoll** asked if he supports the study resolution.

Mr. Fisher said yes.

**Senator Flakoll** asked if they had considered pilot projects in an individual district to try voting by mail.

Mr. Fisher said it had not been discussed or suggested.

**Senator Flakoll** asked if the refund rate of 6.5% based on dollars, 1% based on producers seems accurate.

Mr. Fisher said the rate is 6.9% of dollars. He could get a document on the number of individuals. Because the refunds are not applied for annually but rather every 60 days, it varies throughout the year. The number of annual applications does not equal the number of individuals requesting a refund annually.

**Senator Flakoll** asked if he were a member of the Wheat Commission would it be permissible for his wife to get a refund.

Mr. Fisher said that is his understanding.

**Senator Flakoll** asked about the language that would be removed by the bill that refers to substantial income in five years, on page 1. Was that removed because it was nebulous.

Mr. Fisher said that was the original language, drafted in 1959. It is time to review the language, things change, the industry changes.

Senator Taylor asked about attendance at last years meeting.

Mr. Fisher said the Wheat Commission is required to meet a minimum of 4 times per year. It is common for them to meet much more often. They sometimes have conference calls. Attendance has varied. A recent vote on the national merger was 6-0 because one member was missing.

Senator Flakoll asked what is his interpretation of "each member is actively engaged in the production of wheat".

Mr. Fisher said the will behind this bill is to address this issue. There is something very right about being an active producer, you need to be to know the challenges of banking, of crop insurance. There are some folks who share crop wheat who are paying a substantial level of check off.

**Senator Flakoll** asked what his recommendation would be regarding share cropping, line 22 and 23.

Mr. Fisher said it would depend on the definition of active farmer, that is a judgment call.

Senator Klein asked if actively engaged means being out there everyday, having your livelihood depend on it. Actively engaged does not mean driving out to check on the farmer renting the property. To him actively engaged means out there fueling up and in the field.

Mr. Fisher said he agrees.

Senator Flakoll asked his opinion on one year vs. three years for the refund.

Mr. Fisher said he doesn't. He thinks the language may have come from the barley commission.

The Wheat Commission has the oldest language and some of the other commodity groups have modified the language as they have been formed.

**Senator Klein** asked if other commodity groups have a three year refund provision as a part of their board requirements.

Mr. Fisher said yes, the barley producers, he doesn't know about peas and lentils or oilseed and of course beef has no refund.

Chairman Flakoll closed the hearing on HB 1272.

Chairman Flakoll said he would prefer not to act on the bill today, he anticipates there will be some amendments.

Senator Klein said on page 2, apparently the sponsors thought there was verbiage included that would excuse a reasonable absence. Maybe we should look at the language in the other groups requirements. The other thing he heard was maybe some stronger language should be added to the actively engaged requirement. Also the three year period may need to be changed, a compromise could be reached. If 6% of the money is being refunded but only 1% of producers, are we really holding anybody up here. (meter 1119, side B)

Senator Flakoll said the compromise on three years could be one year.

**Senator Klein** said whether it should be one, two or three years, do we need to find some common ground.

Senator Seymour said one year would be a good compromise.

Senator Klein said we can certainly take a look at that as we move along.

Senator Taylor said he would like to see it at one year or not at all, there could be producers that might refund a small portion. There are not always a large group of people willing to serve.

**Senator Flakoll** said when do we get big crowds, its when people are mad. When do the wheat growers get large crowds at their meetings, its when there is a problem.

**Senator Klein** asked if you are a refunder, do you need to pay your own way to the Wheat Commission meetings, since you have not contributed to their funds.

**Senator Erbele** said if you are not a payer, you have to become one when you sit on the Wheat Commission.

Chairman Flakoll asked if Senator Klein will bring amendments on page 2, lines 7 and 8. We will need at least 3 amendments on various topics. He asked Senator Seymour to work on amendments for the three year refund clause. Perhaps Senator Klein will work on the actively engaged section.

**Senator Klein** said he may have a comprehensive set of amendments.

**Senator Flakoll** said the sharecropping issue is murky.

**Senator Erbele** said it is hard for us to micro manage, it is up to those producers at the local meetings.

Senator Urlacher asked if you are leaving out active.

Senator Erbele said no, just not further define it.

**Senator Klein** said they need to be actively engaged. Can you load the local convention and get someone elected that is not actively engaged.

Senator Flakoll said the answer is probably yes. The elections are all posted and published.

**Senator Erbele** said even if you could stack the local meeting, it would be difficult to stack the district.

Senator Klein said it could be argued that in a district a long time representative was ousted.

We can't legislate that.

**Senator Urlacher** said one of his concerns is about missing 2 meetings when you are also including special meetings.

**Senator Klein** said his amendment will address this.

Senator Klein and Senator Seymour said they will sit down and work on amendments together.

They may visit with the sponsors on the house side as well.

**Senator Taylor** said there are some good changes in this bill but he doesn't think it has been a state of anarchy without it.

Chairman Flakoll closed the discussion on HB 1272.
