

HB 1432 - Campaign Finance RE:

The 2003 Legislative Assembly adopted SB 2403, which was a comprehensive revision to the laws related to campaign finance reporting. After experiencing one election cycle with its accompanying reporting requirements, several areas of the campaign finance chapter were identified as needing clarification or improvement, which is the purpose of this bill.

Section 1: On page 1, line13, the word "direct" is added to clarify the definition of expenditure.

Section 2: On page 2, lines 1 through 3, the change clarifies for statewide and legislative candidates that contributions received from the same source are to be aggregated from the beginning of the calendar year through the end of the reporting period and that the date reported is when the most recent gift in the aggregated amount was received.

On page 2, lines 13 through 16, the change simplifies the wording that requires statewide and legislative candidates to submit a year-end report whether they sought election or not.

Section 3: On page 2, lines 19 through 31, the change is for the same purpose stated in Section 1 except that it applies to a political party and also applies to expenditures.

Section 4: On page 3, line 3, the change adds the words "or measure committee" that were inadvertently omitted from SB 2403 adopted last session.

Section 5: On page 3, line 21, the change requires all statewide candidates to register with the Secretary of State even if they have not formed a political committee.

Section 6: On page 4, lines 5 through 10, the change is for the same aggregated purpose stated in Section 1 of this bill except that it applies to a multi-candidate committee.

Section 7: Beginning on page 4 and throughout this section, there are changes removing all references to county and city candidates and making the entire section only applicable to judicial district candidates since this bill creates separate sections in the Century Code for county and city candidates.

On page 4, lines 25 through 28, the change is for the same aggregated purpose stated in Section 1 of this bill except that it applies to judicial district candidates.

On page 4, line 29 through line 4 on page 5, the changes establish the identical reporting periods for a judicial candidate that are required now of statewide and legislative district candidates.

HB 1432 January 27, 2005 Page two

Page 5, lines 5 through 9, the change requires a judicial district candidate to file a year-end report in those years in which they sought election to office.

Page 5, lines 14 though 17, this change requires a judicial district candidate to file a year-end report for any year in which they receive a contribution whether or not they sought election to an office during that year.

Page 5, lines 18 through 30, these changes make it clear that the Secretary of State is the filing officer for campaign contribution reports from judicial district candidates.


Section 8: This section creates a new section in this chapter of the Century Code, which pertains only to candidates for county office. It establishes the same requirements as in Section 7 of this bill except it identifies the county auditor as the filing officer, authorizes the county auditor to request duplicate report if original is not received, and establishes a four-year retention period for the reports.

<u>Section 9</u>: This section creates a new section in this chapter of the Century Code, which pertains only to candidates for city office in cities with a population of 5,000 or more. It establishes the same requirements as was done in Section 8 except, as they are applicable to a city election.

Section 10: On page 8, line 25, this change makes it clear that contributions received from a single source within the 20-day period before an election must be reported within 48 hours if the aggregate amount exceeds \$500. The change in line 29 extends the same requirement to judicial, county, and city candidates.

Section 11: On page 9, lines 5 through 9, the change authorizes all filing officers (Secretary of State and County Auditor) to charge and collect late filing fees and to request amended reports.

On page 9, lines 13 through 21, the change authorizes all filing officers to assess a fee if a requested amendment is not filed within ten business days after the amendment has been requested in writing by the filing officer. If the amendment were filed after the due date but within six days, the late fee would be \$50. If filed after six days but within eleven days, the late fee would \$100, and if filed thereafter, the fee would be \$200.

After experiencing one election cycle with its accompanying reporting requirements, several areas of the campaign finance chapter were identified as needing clarification or improvement, which is the purpose of this bill.

Section 1: On page 1, line13, the word "direct" is added to clarify the definition of expenditure.

Section 2: On page 2, lines 1 through 3, the change clarifies for statewide and legislative candidates that contributions received from the same source are to be aggregated from the beginning of the calendar year through the end of the reporting period and the date reported is when the most recent gift in the aggregated amount was received.

On page 2, lines 13 through 16, the change simplifies the wording requiring statewide and legislative candidates to submit a year-end report whether they sought election or not.

Section 3: On page 2, lines 19 through 31, the change is for the same purpose stated in Section 1 except that it applies to a political party and also applies to expenditures.

Section 4: On page 3, line 3, the change adds the words "or measure committee" inadvertently omitted from last session's SB 2403.

Section 5: On page 3, line 21, the change requires all statewide candidates to register with the Secretary of State even if they have not formed a political committee.

Section 6: On page 4, lines 5 through 10, the change is for the same aggregated purpose stated in Section 1 of this bill except that it applies to a multi-candidate committee.

Section 7: Beginning on page 4 and throughout this section, there are changes removing all references to county and city candidates and making the entire section only applicable to judicial district candidates. Other sections of this bill create separate sections in the Century Code for county and city candidates.

On page 4, lines 25 through 28, the change is for the same aggregated purpose stated in Section 1 of this bill except that it applies to judicial district candidates.

On page 4, line 29 through line 4 on page 5, the changes establishes the identical reporting periods for a judicial candidate that is required now of statewide and legislative district candidates.

Page 5, lines 5 through 9, the change requires a judicial district candidate to file a year-end report in those years in which they sought election to office.

Page 5, lines 14 though 17, this change requires a judicial district candidate to file a year-end report for any year in which they receive a contribution whether or not they sought election to an office during that year.

Page 5, lines 18 through 30, these changes make it clear that the Secretary of State is the filing officer for campaign contribution reports from judicial district candidates.

<u>Section 8</u>: This section creates a new section in this chapter of the Century Code, which pertains only to candidates for county office. It establishes the same requirements as in Section 7 of this bill except it identifies the county auditor as the filing officer, authorizes the county auditor to request duplicate report if original is not received, and establishes a four-year retention period for the reports.

<u>Section 9</u>: This section creates a new section in this chapter of the Century Code, which pertains only to candidates for city office in cities with a population of 5,000 or more. It establishes the same requirements as was done in Section 8 except, as they are applicable to a city election.

Section 10: On page 8, line 25, this change makes it clear that contributions received from a single source within the 20-day period before an election must be reported within 48 hours if the aggregate amount exceeds \$500. The change in line 29 extends the same requirement to judicial, county, and city candidates.

Section 11: On page 9, lines 5 through 9, the change authorizes all filing officers (Secretary of State and County Auditor) to charge and collect late filing fees and to request amended reports.

On page 9, lines 13 through 21, the change authorizes all filing officers to assess a fee if a requested amendment is not filed within ten business days after the amendment has been requested in writing by the filing officer. If the amendment were filed after the due date but within six days, the late fee would be \$50. If filed after six days but within eleven days, the late fee would \$100, and if filed thereafter, the fee would be \$200.
