Minutes:

Vice Chairman Johnson opened the hearing on HB 1434.

Rep. Kelsch introduced the bill. It requires that before the DPI can make any amendments to the state accountability plan under the NCLB Act, they shall provide Legislative Council written notice of the proposed amendment. Legislative Council may assign responsibility to hold a public hearing to a committee designated by them. The Interim Committee on NCLB would be the ideal vehicle to hear these amendments. It would allow the Interim Committee to have input to the process.

Rep. Sitte: As a point of clarification are we protecting individual student data or can it be tracked under NCLB.

Rep. Kelsch: It is my understanding that individual data was not being tracked, it was cumulative data that was being tracked.

Bev Nielson, ND School Board Association, testified in favor of the bill. The only suggestion I would make is in the wording. In line 14, it would be nice if we could say, "the committee may direct the superintendent as to the disposition of amendment of the plan."

Chairman Kelsch: There will be advice given.

Nancy Sand, NDEA spoke in support of the bill. I have a question regarding timeliness to allow the committee to be called together.

Chairman Kelsch: If there is an amendment proposed during the session, then it would come before a joint meeting of the House and Senate Education Committees. The Interim Committee would be the vehicle when we are not in session.

Greg Gallagher, DPI, provided information on behalf of DPI. (Testimony attached.)

Rep. Sitte: Is it your understanding that no individual data is being tracked.

Gallagher: It is a federal law that no individual data may be reported.

Rep. Sitte: I scanned the ND accountability workbook and see on page 67 (attached) that ND has contracted with TetraData Corporation. (She read the underlined part.)

Gallagher: The linkage of individual students an essential element of any data base system for the purposes of rolling up. The end result is that no individual is able to be tracked.

Rep. Haas: I cannot for the life can't how that line of questioning has any relation to the bill in front of us and I object to that. I would like to ask a question of Mr. Gallagher. Do you consider an amendment to the state accountability plan synonymous with rule making?

Gallagher: The term rule making in Century Cole is a delimiting term. It's too limiting. It must be more robust and open so we interpret this as a policy statement saying that before any amendment occurs there needs to be notification to Legislative Council so they can exercise its

right to conduct a hearing if it wants. It may serve the purposes of consolidating Century Code to take the language of this bill and insert it where #4 is and I believe the true intent would be there then. We see that as a friendly amendment.

She took these two concepts into the last session wondering how it would all play out and was surprised to discover they were on opposite sides of the Dept. Of Public Instruction. As the session unfolded she became aware of how much stress was involved. She said it became apparent to her they were not working together as a team, meaning the Dept. of Education and other entities that are involved in education. She suggests that maybe some of that has improved somewhat but there is still stress and there still is not the trust and cooperation

Senator Freborg: Call the meeting to order on HB 1434

Senator Flakoll: I met with LC representative this past week with the intent to try and accomplish what we hope to with the studies in the interim but tried to pair them down to make them a little more watchful and fitting with the relationships one to another. We had at least 11 live study resolutions or bills that require study resolutions, these two specifically deal with NCLB act. That being 1038 and 1434 that we thought would be the better vehicle, in respect with concerns, to 1038 this is a little too much specificity in some areas that would set us up for sure fired failure b/c of all the things that the committee needed to do. We would have to meet on a near weekly basis to accomplish those and we though rather than deal with that we left it a little more open ended so they can go through and be a little more flexible in their responses. Also taken out of 1038 we added some language as far as the stakeholders on the amendments, that

were included in the 1038 bill section 1. Also with the amendments we paired down the committee and made it a smaller committee in terms of legislators changed it from 5 to 4 members from the Senate and 6 to 5 members from the House, as far as the NCLB committee goes. The thinking is by allowing by them to be the head group responsible for this, they could set up a round table type format and go off and do their work.

Senator Taylor: Senator Flakoll has explained this pretty well, the guts of the bill as we added to it of course is still the legislative review of the accountability plan of NCLB, then leaving the interim committee b/c that is the legislative vehicle, legislators who are responsible to submit legislation for the next session. Working with ESPB, NDEA, and SBA etc, having them listed here is a good effort to make sure they are in the process, I think we would expect the committee to, if it is a matter of whether or not these folks are at a podium VS a table that they are at a table when testimony is taken to help the legislators in their recommendations for the accountability plan. Pairing down the committee, is looking at who are the real players in either body. One other thing that maybe came into play, we looked at the 11 or 12 study resolutions and quite a few of them had committees assigned, to be mindful of LC's staffing. They can only do so much also.

Senator Freborg: I know you referred to one other bill, will you make any recommendations on any of the other bills?

Senator Flakoll: I think with what happened yesterday with the two bills before us, and the Erbele, Seymour subcommittee that we will be dealing with it eventually, with the exception of the delayed bill that Senator Cook has brought in, that deals with some of the 1512 information. So essentially we will have taken three bills and taken it down to one bill.

Before the superintendent of public instruction may submit to the United States secretary of education any proposed changes in the state accountability plan required under the No Child Left Behind Act of 2001 [Pub. L. 107-110; 115 Stat. 1425; 20 U.S.C. 6301, et seq.], the superintendent shall present the proposed changes to the interim no child left behind committee. The committee shall review the proposed changes; accept testimony and documentary evidence regarding the impact of the proposed changes on the students, schools, school districts, and taxpayers of this state; and provide advice and recommendations regarding the proposed changes to the superintendent.

SECTION 2. AMENDMENT. Section 54-35-21 of the North Dakota Century Code is amended and reenacted as follows:

The legislative council shall appoint a select an interim committee consisting of five four members of the senate and six five members of the house of representatives for the purpose of investigating the adoption of. The committee shall study the No Child Left Behind Act of 2001 [Pub. L. 107-110; 115 Stat. 1425; 20 U.S.C. 6301 et seq.], its rationale, the promulgation of any including amendments to the Act, changes to federal regulations implementing the No Child Left Behind Act of 2001, the direct and indirect impact of the Act and its regulations on the school districts of this state, and the financial impact of the Act and its regulations on the budget of this state and on the taxpayers of this state. Act, and any policy changes and letters of guidance issued by the United States secretary of education.
- 2. The legislative council shall designate the chairman and vice chairman of the committee.
- The committee shall operate under the rules applicable to other legislative council committees, except that the committee has the power to may communicate directly with the United States secretary of education, employees of the United States department of education, and any other federal officials, both elected and appointed, regarding implementation of the No Child Left Behind Act of 2001.
- 4. When an agency files a notice of proposed rulemaking with the office of the legislative council under subsection 1 of section 28 32 10 on any matter governed by the Ne Child Left Behind Act of 2001, the agency shall provide a copy of the notice to the chairman of the committee. The chairman shall convene the committee within sixty days of receiving the notice, or as soon thereafter as practicable, for the purpose of receiving a presentation by the agency regarding the nature and scope of the proposed rules and for the purpose of receiving presentations by members of the public regarding the nature and scope of the proposed rules. The committee shall work with and encourage the testimony of public and private officials, including the

superintendent of public instruction, the education standards and practices board, the state board of higher education, the North Dakota council of educational leaders, the North Dakota education association, the North Dakota school boards association, and the North Dakota Indian affairs commission. In addition, the committee shall actively seek the participation of students, parents, classroom teachers, school administrators, and other citizens of this state. The committee shall direct its efforts to ensuring that no child in this state is left behind and to further ensuring that no law or rule, be it federal or state, hinders or otherwise impedes the ability of this state's teachers, schools, and school districts to achieve this goal.

5. The committee shall report to the fifty ninth its findings and recommendations, together with any legislation required to implement the recommendations, to the legislative assembly if the committee determines the state is not in compliance with any requirement of the No Child Left Behind Act of 2001."

Sen. Lee: We did have a subcommittee that looked at this bill, 1434, and 1038. Senator Taylor was a part of that subcommittee and he can certainly fill in the gaps from the level I offer. We used 1434 to be the vehicle in combining those two bills. Section I is essentially 1434 in its original form except that have the accountability and review reporting to the Interim No Child Committee rather than the Legislative Council as in the original bill. Section 2 is parts of 1038 and in what's left there is the Interim Committee on No Child as was formed in the 2003 session. I think much of the responsibilities of that committee are still there. We did reduce the numbers of that committee to four members of the Senate and five members of the house. We did take out the portion that had to do with the Advisory Commission of NCLB, thinking that the mission and strategies and goals of the Interim Committee were similar to that group but did recognize the importance of those groups and individuals in participating so included them in Subsection 4 by title and group and some of the parents and teachers, etc., that were expected to give input to the Interim Committee. So those are the high lights of the changes and Senator Taylor wants to fill in some of the gaps as he worked with Senator Flakoll in pulling these two together. Sen. Taylor: As Senator Flakoll worked with Council in drawing up these amendments we were being faced with a number of study resolutions and different groups being proposed and we knew we were only going to get so much done in the interim so we thought it wise to bring these two bills together. We named the Committee instead of having Legislative Council name a committee to hear the changes to the accountability plan for NCLB seemed to make sense in that Interim NCLB Committee would have the most background on the topic. We did decrease the number on the NCLB Committee from 11 to 9. In looking at how many legislative members really have a background in education and in NCLB we're going to be spread a bit thin when

members of our committee that would want to be on the Education Interim would also want to be on the NCLB Committee so there are only going to be so many of us to go around. That was our main reason to go to 9 from 11.

Chairman Herbel: Is it possible that they could serve on both or is that going to be too much of time commitment?

Sen. Taylor: In the last session I served on the NCLB but not on Education and I think a couple of the others from the Senate side did serve on both. It would depend on what gets assigned to the Education Interim. I think this interim is going to have a lot going on with funding issues and lawsuit type issues to where they are going to have a heavier workload than they did last interim. It may get tough to be on both. Rather than having an official advisory commission named that would require its own set of Legislative Council staff, we thought that the NCLB Committee could take testimony from those groups. We would hope that the chairman and vice chairman of the NCLB would make a spot at the table for the stakeholders: the associations, the parents, the teachers and they convene meetings in a way that would put them at the table with legislators and then at a session afterwards, the legislators would get together to actually discuss legislation that may arise from their recommendations.

Rep. Hunskor: Reducing the number from 11 to 9, what's the rationale?

Sen. Taylor: In the last interim it wasn't exactly a committee that people were dying to be on already. We have 6 education Senate members and you have 14 so maybe there's a little more latitude in the House committee. Pulling five members from our committee that would have some background with NCLB is not going to be easy to find. Four would be easier to find.

Outside of the Education Committee within the Senate chambers there's going to be a handful of

folks that have some interest but pretty much you are going to be pulling folks from the Education Committee to serve on NCLB and it just gives you a smaller number because it's going to be hard to recruit.

Rep. Hunskor: I also think we sometimes can get too many on committees. They function better often with fewer.

Rep. Taylor: I always think groups work best if they all fit in one van.

Chairman Herbel: Would you have any objection to going with 4 members from the Senate and leaving the House at 6? From our standpoint going to the summer interim committees that we have about 10-20% that don't show up and perhaps even with 11 of them, they may all fit in van because there are other commitments and when you schedule meetings like this, you can't always schedule for everybody to make it. Would that be a consideration?

Rep. Lee: I would hope we don't get outnumbered too badly on the committee. I would like to see it in the ratio that it is.

Rep. Meier: Did you discuss at all if you should move the number for Senators to 4 and keep the House members at 6?

Sen. Taylor: We actually had not discussed it. We just looked at paring it down and we had 5 and 6 so we just subtracted one from each group. If we had gone to 4 and 6 then you have an even number that may or may not be an issue on a committee like this. We wanted to have an odd number.

Rep. Meier: In the last interim I served on both committees and I found it no problem.

Chairman Herbel: For your interim committee on NCLB did you find that the attendance was very high or was it down some. My question is related to the number that may be there because

Madam Chair and Members of the House Education Committee,

I am Greg Gallagher, Director of Standards and Achievement within the Department of Public Instruction. I am here on behalf of the Department to provide background information regarding HB 1434.

HB 1434 requires the State Superintendent to provide to the Legislative Council written notification of any amendments to the state's accountability plan under the No Child Left Behind Act prior to its submission to the U.S. Department of Education. In the event that the Legislative Council determines that any amendment may significantly impact the state or any political subdivision, the Legislative Council may hold a public hearing in order to provide advice and recommendations to the State Superintendent.

The identified purpose of HB 1434 currently exists as the stated responsibility of the No Child Left Behind Committee as provided in NDCC 54-35-21. State law currently requires the State Superintendent to report any amendments to the state's accountability plan to the No Child Left Behind Committee in a similar manner as that presented within HB 1434.

The Department of Public Instruction supports the reporting of any amendments to the state accountability plan and has done so under current law. The Department will continue to honor this obligation by submitting a complete report regarding all aspects of any amendments to the No Child Left Behind Committee specifically and the Legislative Council generally.

This Committee has reviewed HB 1038, which contains many of the same provisions of NDCC 54-35-21. It is a procedural goal of the Legislative Council to avoid redundancy in Century Code. Regardless of the manner or placement of any reporting requirement in Century Code, every effort should be made to place the provision in a single, appropriate section of Century Code. Duplicate or related citations should be avoided.

On behalf of the Department of Public Instruction, I pledge our cooperation in supplying the Legislative Council with the most current and complete accounting of all activities associated with the administration of the No Child Left Behind Act. This



commitment is consistent with the tone and governance within the state accountability plan.

so requires a data analysis and reporting tool capable of managing such linkages among different databases.

The State of North Dakota has never possessed the ability to track the performance of individual student or system performance levels in a meaningful manner based on quality disaggregated data analysis. The State has never owned, developed, or accessed a single, statewide student data system. This absence of a statewide data system has resulted in an inability to access accurate, meaningful information regarding student demographics, student achievement levels, school performance, teacher quality indicators, systemic improvements, or statewide systems monitoring. In the area of assessment, this absence of a statewide data system has resulted in an inability to sufficiently study correlations of student achievement among assessment tools or instructional methods of varying quality.

To eliminate these deficiencies and to advance meaningful school improvement measures, the Department of Public Instruction has contracted with TetraData Corporation, in October 2002, to develop and administer a statewide data analysis and reporting system. This data analysis and reporting system will allow for the linkage of various databases in order to track individual student, staff, and institutional achievement levels, including the correlation of student achievement across different assessment tools.

Included in this capability, is the capacity of the State to compile, compare, and validate student achievement on all grade-level State assessments and to compare these with other assessment tools or classroom grading. Official student files will be linked to State Assessment files that will, in turn, be linked to other assessment tools and classroom grading in order to conduct correlation studies. This will offer the State an auditing capability that will approach 100% accuracy, thereby ensuring a high degree of confidence in any correlation study. Refer to **Appendix R: TetraData Data Analysis and Reporting System Summary** for an overview of the project. The system will be functional statewide by March 2003.

With the development of this statewide data analysis and reporting system, the State will be able to monitor and confirm the contextual validity of its State Assessment.

(d) Consequential validity.

The fundamental purpose for the administration of any assessment is to learn how well individual students and populations of students perform against a standard. The intended consequence of such learning is to apply this knowledge to the improvement of instruction for each student individually and for all students collectively and by subgroup. Consequential validity means that the State Assessment is designed in such a manner as to accomplish this aim with end users. Does the assessment lend itself to reaching correct conclusions from the data?

North Dakota has never conducted follow up studies to record the application of its assessments to enhance instruction. This analysis has never been attempted because of the difficulty in accurately measuring the effort of schools to integrate assessment data into school improvement or, more importantly, measuring the effect of such improvement efforts on students' achievement. Beginning with the 2001-02 baseline data generated through the first administration of the standards-based North Dakota State Assessment, the State of North Dakota will begin a process of confirming the contextual validity of its State Assessment.

The Department of Public Instruction has contracted with TetraData Corporation, in October 2002, to develop and administer a statewide data analysis and reporting system. This data analysis and reporting system will allow for the linkage of various databases in order to track individual student, staff, and institutional achievement levels, including the correlation of student achievement across different assessment tools. Additionally, the Department of Public Instruction will contract with an independent, outside contractor to conduct a study of how well schools use the data from the State Assessment to improve standards-based instruction.

This study will use survey tools with teachers and administrators to assess the degree that data from the state assessment are used for overall school improvement, especially instruction. This study will also
