

The history of the advisory council was started in 1981, there were 5 mental health centers around the state, and they had governing boards. When the Human Services center became part of government, there was a feeling that there should be some way of having local policy direction. Prior to that, the county commissioners were directed to make policy decisions, budget, decided what programs that would be offered. The advisory council was established at that time to be able to incorporate community support.



TESTIMONY HB 1442

MADAM CHAIR AND MEMBERS OF THE HOUSE HUMAN SERVICES COMMITTEE.
MY NAME IS ALON WIELAND, REPRESENTATIVE FROM DISTRICT 13, AND I AM
HERE TO INTRODUCE HOUSE BILL 1442.

THIS BILL RELATES TO THE HUMAN SERVICE ADVISORY COMMITTEE, OF WHICH
I BELIEVE THERE IS ONE IN EACH OF THE EIGHT DISTRICTS. THESE COMMITTEE
WERE SET UP TO PROVIDE ADVICE AND COUNSEL(NOT LEGAL) TO THE HUMAN
SERVICE DISTRICTS. COUNTY COMMISSIONERS APPOINT THESE COMMITTEES
WHICH COMPRISE OF 13 MEMBERS FOR A TWO YEAR TERM. THE DUTIES OF
EACH COMMITTEE MAY PARTICIPATE IN ANY ONE OR ALL OF FIVE
SUGGESTED AREAS. THE PURPOSE OF THE BILL IS NOT TO UNDO THE
COMMITTEES, BUT TO ELIMINATE THE COST OF THE COMMITTEE TO THE
STATE HUMAN SERVICE CENTER. CURRENTLY, THE COMMITTEE MEMBERS ARE
ENTITLED TO \$45.00 PERDAY, AND BE PAID FOR MILEAGE. WHILE THE
AMOUNT OF TOTAL DOLLARS IS NOT LARGE, MOST OF THE MEETINGS
ARE INFORMATIONAL, AND NO BUSINESS PER SE, TAKES PLACE. I SERVED ON
THE SOUTHEAST HUMAN SERVICE ADVISORY COMMITTEE FOR 2 YEARS,
AND ONLY ONE MOTION WAS MADE, AND THE CENTER TOTALLY IGNORED THE
MOTION. WHILE THE INFORMATION GLEANED WAS INTERESTING, IT TOOK
TIME FROM DEPARTMENT HEADS, THE DIRECTOR, AND SECRETARY, AND COULD
HAVE BEEN PROVIDED IN OTHER WAYS.

MADAM CHAIR, MEMBERS OF THE COMMITTEE, I HAVE NO PROBLEM

ALLOWING THE COMMITTEES TO CONTINUE TO MEET WITHOUT PAY OR MILEAGE. IF THERE ARE SOME COMMITTEES WISHING TO CONTINUE TO MEET BECAUSE THEY ARE INTERESTED, THIS BILL DOES NOT REMOVE THAT OPTION.S

Testimony HB 1442 Rep. Alon Wieland

Madam Chair and members of the ^{Senate} ~~House~~ Human Services Committee:

My name is Alon Wieland, Representative from District 13, and I am here to introduce House Bill 1442.

This bill relates to the Human Service Advisory Committee, of which I believe there is one in each of the eight districts. These committees were set up to provide advice and counsel (not legal) to the human service districts. County commissioners appoint these committees, which compromise of 13 members, for a two-year term. The duties of each committee may participate in any one or all of five suggested areas.

The purpose of the bill is not to undo the committees, but to eliminate the cost of the committee to the State Human Service Center. Currently, the committee members are entitled to \$45.00 per day and to be paid for mileage. While the amount of total dollars is not large, most of the meetings are informational, and no business, per se, takes place. I served on the Southeast Human Service Advisory Committee for two years, and only one motion was made; the center totally ignored the motion. While the information gleaned was interesting, it took time from department heads, the director and secretary, and could have been provided in other ways.
