Minutes:

Rep. Ruby (Acting Chairman) opened the hearing on HB 1450 A Bill for an Act to amend and reenact subsection 39-06-06-14 and subsection 6 of section 39-06-19 of the North Dakota Century Code, relating to fees for a driver's license.

Rep. Hawken I am here today to speak in favor of HB 1450. It has been at least 30 years since we have changed what we charge for driver's license fees. We go once every four years and we pay \$10. Remember it is a privilege to drive on our roads. All other expenses have gone up so it is time to increase our fees to cover these costs. This bill is a 100% increase; from \$10-\$20; which means we are paying \$5/year. Homeland security has caused come increased costs in addition to every thing else.

**Rep. Hawken**: There are a couple things we should also change in this bill. We need to take the word replacement out and we need to look at what we would do with cost of replacement license and permits as well.

Rep. Schmidt (3.5) I noticed on the fiscal note that the drivers license all goes into the general fund. Is there anyway way that counties and cities could get some of this?

**Rep. Hawken:** I am not nearly as knowledgeable, but with what we pay there wouldn't be allot to go there.

**Rep. Delmore:** (4.0) I think I can understand and I might even like this bill to do the \$20. I think \$5 a license isn't bad. Would you have problems with the renewal of the license not being quite so much fee?

**Rep Hawken:** Certainly that is open for discussion. Right now in this bill it does not change at all.

Rep. Delmore On section 2 line 8 on page 2 it goes to \$20 as well.

Rep. Ruby: (4.8) Anyone else in support of HB 1450?

Marcia Lempke, Drivers License Division: (sp?) (5.6) We do have future needs at drivers license and traffic safety in regard to just issuing drivers licenses that we are concerned about and that we have recommended. One of them is our system that provides excellent technology for use to give instant issue; that will have a renewal on the contract. We will not be sure with the new additional standards with homeland security, we think and biometrics perhaps coming in, we don't know where those costs are going. The other situation we are looking at with technology is right now all the drunkard drivers are on our main frame. As you are aware with technology everything is moving fast. Main frame stores confidentiality's and records and as well it stores anything that happens to your drivers record.

**Rep. Hawken**(8.3) To clarify what Rep. Delmore asked. In the amendment it does say the fee for renewal or replacement is \$20. If that different than a duplicate?

Syndi Worrel: (sp?) Chief Examiner for ND Drivers License: Replacement and duplicate means the same thing. So by sticking the replacement from your bill the fees for duplicate would stand. A duplicate is \$8 is your replace your license; \$3 if all you need to do is a name or address change. So by removing the word replacement, the duplicate fees would stay the same. Renewal fees would be the one that would go to \$20. If I were to get an original license if I came from another state that would be \$20 because it is an original license. The CDL Chapter which is 39-06.2-08 that specifically states that a commercial license is \$15.; so that would contradict this specific piece unless we could include that \$20 fee in that section as well.

**Rep. Price** How much to you pay for the satellite thing? Are they all the same? Is there a set fee that you pay them?

**Syndi Worrel** As far as what we charge for the license or if I walk in to renew my license in Minot. The fees are all the same. The fees all go to the general fund; there is no one entity that keeps the fees. All our offices have state employees.

**Rep. Weiler**(11.0) Marcia \$3,200,000 in taxes; does that all go toward technology. If we are going to double our fees are there any other services that we would provide or get for this additional money?

Marcia Lempke: Hopefully the earlier things I talked about could be made better with the additional funding. The other point is right now we have no way of expanding for example in Fargo. We actually need to be able to treat our customers better. The lines are intolerable. I have had a number of people call and say you need to get more help .I don't believe any of the operational costs; has nothing to do with the \$2.21 for a card itself.

Rep. Kelsch (12.7) In the fiscal notes you state that perhaps you should address permits and how the permit system would work. They would pay \$20 also and once they road test they pay no more.

**Syndi Worrel:** That is correct. They pay for the permit at the time they get it and that makes it go to go.

**Rep. Thorpe**(13.4) Commercial cost of \$15 now is that adequate?

<u>Chairman Weisz</u>(14.7) With the hazmat requirements the new laws require background check. Who is paying for that? Sindi said the CDL drivers themselves.

**Rep. Delmore** Marcia, you have mentioned enhancement several times. What are you looking at for enhancements that are going to be increased? Give us some specifics.

Syndi Worrel: (16.6)I cannot give you exact specifics. We are saying that the AMVA and Homeland Security has increased our costs. Enhance the photos for drivers licenses People are asking for on line registration Security is a big factor. Illegal Aliens is also a new higher priority. Our pictures are stores on digital imaging and we can transfer pictures around and see the picture. Automotive knowledge testing; which they need to be automated. So they can not cheat when taking a test. Federal Motor Carriers for CDL want them beefed up. The impostors are getting better.

<u>Chairman Weisz</u> Sindi, what do the states do now to get a new license to insure they are who they say they are?

Syndi Worrel: (18.3) We require a certified birth certificate from the US or Canada. If you can not provide one of those documents you need to provide an immigration document. There are about 8 different immigration documents that we would accept at this time.

Chairman Weisz(18.7) What kind of costs are we looking at? They are looking at asking for a whole lot more than a birth certificate to insure because of the fraud going on. Is that a time consuming process.

Syndi Worrel: (19.0) It is becoming more time consuming for the examiners at the front counter. We have law training that was developed by AMVA that we have all our examiners go through and that is 24 hour training. New immigration stuff is going on all the time. So right now it is time at the front counter and training to do a manual investigation. The Williston office just caught a false social security card and residence card. So our training is paying off. They did get out the door on us, but they did not get issued a drivers license.

**Rep. Kelsch** (20.3)Do you have a number that tells us actually what it costs to issue the license including the notifications for renewal and everything?

Marcia Lempke: I do not have that figure today. We do have portions in the budget like the printing costs, the cost of salary and budget and those kind of things. We know it will be higher than \$2.21 for the cards. It costs around \$10,000 for a program change of minimal proportions. I can get those figures.

Rep. Kelsch: It would be nice if we could have some ball park figure on your costs. If you could provide that, I would appreciate that.

<u>Chairman Weisz</u> I would think you have to have a budget line for each of your satellites. There we should have your complete costs. Even if it is a total cost for the satellites.

Marcia Lempke: Will put those costs together and get them to the committee.

**Rep. Schmidt** Is some of these excess funds going to be used to purchase good cameras?

Rep. Owens (23.0) What do the non-driver photo ID cost?

Marcia Lempke: I believe those are \$8; the same as a duplicate. Beside the impostor, which is a hugh issue, I can't tell you the number of times, that we have been able to intercept impostors. We want to keep the satellite offices open just as an economic development issue.

Dave Sprynczynatyk: DOT, (24.5) We are just here to provide information; not in support of HB 1450. There was a question regarding where the funds went that we collected from the drivers license fees. Those funds go into the highway fund and that goes toward supporting the department and its operation. The fiscal note shows that. Secondly, we do actually have 44 sites where we provide drivers licenses services across the state. They are not all full time sites; many are only one day a week or every other week. We have found that for serving ND it works out very well because people like to be able to drive just a short distance to renew their license etc. The enchantments are really because of the security issue and recently Congress passed a law called the Intelligence Reform and Terriorism Prevention Act. We know that will require more on our part for training plus now we need to deal with the security aspect of things.

<u>Chairman Weisz(26.5)</u> So you think we will have to eliminate some of these satellite sites just because of the costs?

<u>Dave Sprynczynatyk:</u> At this point we don't see that happening. The rules are yet to be developed so we hope we can continue to provide the same level of service or better. That could change depending on what comes out in rules.

**Rep. Delmore** What is the cost of licensing in our neighboring states?

Marcia Lempke: I don't know. We will provide that along with the cost of licensing.

Rep. Thorpe If pass HB1450; does that mean we don't need HB 1458?

This bill would double the fee for new driver licenses, renewals, and duplicates. There is a contradiction with the \$8 and \$3 duplicate section in law and the section pertaining to licenses and "replacement" licenses. This bill does not affect the non-driver photo ID card. Also, there is no set fee in the law about what to charge for permits, which may need to be increased to \$20 followed by the no-fee license. Currently, the initial permit fees are \$10 because that initial license has been a no-fee license following a road test. It would follow the same rationale if the permit fee was increased to \$20. This bill does not address commercial license fees. It also overlooks 39-06.2 which states that a commercial fee is \$15. This bill will no doubt need to be amended.

We process approximately 104,540 renewals, 23,870 new licenses, and 32,392 duplicates per year. Doubling these fees increases revenue to \$3,216,040 per biennium.

Programming changes will be required in all licensing and financial areas, which we are rough-estimating at \$10,000.

Minutes:

Chairman Carlisle opened discussion on HB 1450 regarding changing license fees. The

Committee with the help of Legislative Council and OMB determined that this bill doubles the
fee for licensing from \$10 to \$20 for four years to help offset the cost of the drivers' license
computer system. The bill passed from the Transportation Committee with a DO PASS
recommendation, 8-1-6. The fiscal note was attached and referred to Government Operations.

Chairman Carlisle called Rep. Robin Weisz, Chairman, House Transportation Committee
to assist the Committee. When he arrived he explained that the original bill did not have an
appropriation. The cost of \$10,000 was added later. Rep. Williams noted that the fiscal note
showed a collection of \$2.4 million in revenues. Rep. Weisz said it's \$3.2 million, according to
the latest fiscal note. Rep. Timm said this is actually a revenue enhancing bill for the Highway
Department and Rep. Weisz confirmed.

**Rep. Timm** asked if during discussions there was any talk about need. **Rep. Weisz** said that the fee of \$2.50 has been in place since 1963 and that it's time to raise that to \$5 a year. The Department claims that actual cost to process fees is closer to \$20. He also informed the Committee that there will be an increase in commercial license fees from \$15-\$20. Everything is now at \$20. The cost to replace a license remains the same, \$8.

Rep. Weisz said the rest goes into the State Highway Fund. Rep. Williams asked who determines how that money is to be used and Rep. Weisz responded, the Legislature. Chairman Carlisle explained that Government Operations will work on the DOT budget after crossover. At that time the Committee will examine formulas as to how the money will be disbursed among the DOT, counties, and cities.

**Rep. Timm** asked how many of the absent people would have voted for raising these fees and **Rep. Weisz** said it was a split, basically.

**Rep. Kempenich** asked if there where other appropriation bills. **Rep. Weisz** said HB 1458 concerning revenues from gas tax is on the House floor.

Chairman Carlisle suggested that the Committee could send HB 1450 to the Full Committee without recommendation. Rep. Timm so moved; Rep. Kempenich seconded.

Under discussion, **Rep. Kempenich** requested a new fiscal note. **Chairman Carlisle** requested that legislative council talk with the Department of Transportation to correct the fiscal note. He also said that someone from DOT should be present when the Full Committee meets to discuss the bill. **Rep. Kempenich** noted that this bill should be part of a package presented to the Senate

by DOT. The Governor's budget called for a \$15 registration. Chairman Carlisle stated he'd

have a hard time supporting this bill on the floor. Rep. Thoreson concurred.
