Minutes: HB 1452 Relating to the central voter file; and to repeal section 16.1-02-08 of the North Dakota Century Code, relating to the central voter file.

14 members present, 0 absent.

Rep. Horter-District 42-For-Introducing the bill.

Alvin A. Jaeger-Secretary of State-Testimony Attached. A record of who has voted, it is not a record of who can vote. That is a very important distinction, because a record of who has voted is a lot different then who can vote, because who can vote is voter registration and North Dakota just does not have that.

Chairman Haas: Those unique numbers are assigned by your office, is that correct?

Al: We are working with DOT and probably going to be basing it off there data base. This is suppose to be for facilitating the system, making it work, not to become general public knowledge, just like social security numbers were used for years to facilitate the system and now in they are re-dock everything. This is anything but a record that already exists in 53 counties, put

in one central place, where all the auditors can then take the information, print out the poll books, so on a election day everything works quicker and faster.

Chairman Haas: When the data is collected at the state level, before the county auditors have access to get it back and it is printed in a new format is it then alphabetized.

Al: We are still working on that.

Chairman Haas: It sure would be quicker for election workers to find a name in a poll book, if it was alphabetized.

Al: After the election the county auditor has a period of time, where they have to input the updates, so the list becomes current.

Rep. Boehning: Do all the counties currently have everything computerized, is there still a few doing things manually?

Al: There are poll books that are still maintained by writing and of course they are difficult to read. One thing that is and advantage to the system is jury duty records are pulled from the machine. We want to make it uniform across the state.

Rep. Klemin: A question on this unique identifier, section 7, is there any other purpose for the unique identifier other than for voting and how much trouble is it for the county auditor to retract all those numbers, if that is only thing it is used for.

Al: The reason for the identifier is to make sure there are not two of you, the one that lives here and the one who lives else where, that it is kept separate. They will be able to print out a poll book, without the identifier.

Rep. Klemin: Is there any other reason for this identifier other then this, not the social security number is it?

AL: It is just to make the system works.

Rep. Klemin: If it wasn't an exempt record, what can anybody do with it?

Danette Odenbach-North Dakota Association of Counties-For-The unique identifier is going to be that number that is on your drivers license.

Rep. Klemin: That number on my drivers license, is exempt over at the DOT?

Danette: My understanding is yes.

Rep. Klemin: If they got that list of drivers, for example, they don't have that identifier number on that list.

Danette: My understanding is an exempt record.

Rep. Klemin: I guess I am still confused what anyone else, **for id**entity theft purposes use this unique identifier number use for voting, what good is it for anyone else.

Danette: I guess I couldn't presume to know what sinister idea people have to use that, I request of DOT, they want to keep that as an exempt record and to be consistent with the laws.

Rep. Conrad: What is taking so long with this system and how did we get Association of Counties involved.

Al: The Help America Vote Act was signed in October 2002 and we have been working since then to secure over six million dollars of voting equipment and doing some other things. This is a massive program, this is got to be done right the first time. We have an agreement where entered in, where the HAVA coordinator is an employ of the Association of Counties, they provide the services. She works for HAVA at my direction.

Rep. Boehning: Does that number get cross referenced from the DOT, so when I die that number disappears from the voter list, so we don't have a bunch of cemeteries voting again.

RE: HB 1452 - Central Voter File

The 2002 Legislative Assembly adopted Senate Bill 2394 authorizing the creation of centralized statewide database, which is to contain the information from the poll books from every precinct in each county. It is only a record of who has voted. It is not a record of who can vote.

The county poll book lists the names of those individuals who voted in the most recent election. After the election, each county will update the data in the database. Known as the Central Voter File, the database then allows the County Auditors to pre-print updated poll books for the succeeding election, which increases poll worker efficiency and accuracy and shortens the time a voter must wait for his or her ballot. The Central Voter File is also intended as a post-election means to identify voter fraud.

At our recommendation, SB 2395 contained certain timelines by which the project would become functional. Although a committee has been working on it, this is a major project and it must be carefully planned and developed. In this bill, I am requesting the timelines be changed.

Section 1: On page 1, the changes move the timeline from 2009 to 2011.

Section 2: On page 1, line 19, the timeline is changed from 2006 to 2008.

<u>Section 3</u>: On page 2, lines 2 and 3, changes the requirement from "all" to at least 10% the number of notices that a County Auditors must send to those voters who were challenged on election day and who as a result signed affidavits.

<u>Section 4</u>: On page 2, lines 13 through 27, removes requirement of the state court administrator to report any individuals placed under guardianship or the names of those whose voting rights have been restored. Since the Central Voter File is only a record of who has voted and not who can vote, the voter eligibility requirements should not be referred to in this chapter because they are covered in other sections of the Century Code.

Section 5: On page 3, line 10, the date is changed from 2008 to 2010.



Section 6: On page 3, lines 27 through 31, the changes remove the requirement for a designation within the Central Voter File for those individuals who are incarcerated, have guardianships, or who were challenged when appearing to vote. Again, since the Central Voter File is only a record of who has voted and not who can vote, the voter eligibility requirements should not be referred to in this Chapter because they are covered in other sections of the Century Code.

<u>Section 7</u>: On page 4, line 12, the change allows the County Auditor to generate a poll book on the day before the election rather than having to do it by the fifteenth day before the election.

In the same section, lines 26 and 27, the change makes it clear that the unique voter identifier in the county's poll book is an exempt public record, which cannot be revealed.

<u>Section 8</u>: On page 5, this section repeals the section of this chapter pertaining to the State Department of Corrections and their reporting of incarcerations. This is for the same reason as the changes made in Section 4 with the court administrators.

RE: HB 1452 - Central Voter File

The 2003 Legislative Assembly adopted Senate Bill 2394 (2003 Session Laws, Chapter 172) authorizing the creation of centralized statewide database, which is called the Central Voter File. It is to contain the information listed in the poll books from each voting precinct in the state. The Central Voter File is to be a record of who has voted. It is not a record of who can vote.

Each precinct poll book lists the names of those individuals who voted in the most recent election. After the election, each county will update the data maintained in the Central Voter File, which will then allow the County Auditors to pre-print updated poll books for the succeeding election. This updated poll book will increase election worker efficiency and accuracy, shorten the time a voter must wait for his or her ballot, and serve as a post-election record to identify voter fraud.

At our recommendation, SB 2395 contained certain timelines by which the project would become functional. Several months ago, I appointed a committee to develop, procure, and implement the Central Voter File. And, while they have been faithfully working on it, this is a major project and it must be carefully planned and developed. Therefore, in this bill, I am requesting the timelines be changed.

Section 1: On page 1, the changes move the timeline from 2009 to 2011.

Section 2: On page 1, line 19, the timeline is changed from 2006 to 2008.

<u>Section 3</u>: On page 2, lines 3 through 17, the stipulation is removed that required the state court administrator to report the names of any individuals placed under guardianship or the names of those whose voting rights have been restored. Since the Central Voter File is only a record of who has voted and not who can vote, the voter eligibility requirements should not be referred to in this chapter because voter eligibility requirements are contained in other sections of the Century Code.

Section 4: On page 2, line 31, the date is changed from 2008 to 2010.

<u>Section 5</u>: On page 3, lines 17 through 21, the stipulation is removed that required a designation within the Central Voter File for those individuals who are incarcerated, have guardianships, or who were challenged when appearing to vote. Again, since the Central Voter File is only a record of who has voted and not who can vote, the voter eligibility requirements should not be referred to in this Chapter for the same reasons stated in Section 3 above.

Section 6: On page 4, line 3, the change allows the County Auditor to generate a poll book on the day before the election rather than having to do it by the fifteenth day before the election.

In the same section, lines 3 through 5, the change makes it clear that the unique voter identifier listed in the precinct poll book in the County Auditor's office is an exempt public record, which cannot be revealed.

Section 7: On page 4, this section repeals the section of this chapter pertaining to the State Department of Corrections and their reporting of incarcerations. This is for the same reason as stated for Sections 3 and 5.

Finally, we request that the amendment be adopted.
