Minutes:

Vice Chairman Johnson opened the hearing of HCR 3053.

Rep. Wrangham introduced the resolution. We all know the power of the printed word so I would like to start out by reading a couple of lines from the actual resolution that I think would be fitting. Line 10: Many adult learners are seeking specific skills for particular job or positions. Line 12: Many specific skills can be taught by individuals and entities other than traditional colleges and universities. I think we can all agree with that. Line 17: The state should not necessarily assume that it has a role in regulating all forms of skills development programs. As we all know we live in an ever more rapidly changing world. People's jobs, vocations, careers are changing like never before in history. I think we need to insure that new skill and improved skill training is available to all who want to improve their place in the workplace and who want to advance themselves. This change should be available without undue encumbrances while still providing regulation necessary to protect the public. Many of

these training programs do not fit well into the regulations that are set forth for conditional colleges and universities. I'm confident this study will result in a better training environment for our skill-seeking adults. With that I encourage you to pass this resolution and hopefully it will be one that will be studied because I'm confident that to this question there are positive answers and we will find them.

Rep. Horter: Under line 12, you said that they might fit well into a traditional college or university. Would you give me an example of something that would not fit well or would not fit well.

Wrangham: I don't want to limit the scope of the study by suggesting that they are necessarily specific things but there are many things such as horse shoeing to many, many different skills that are used on used on computers. Medical transcription would certainly fit in as one of those. There are many training programs that don't involve your traditional education. They are skill development rather than a general education. Of course there are absolute necessity for regulation in our colleges and regulation and most all secondary education programs. However, there are some areas out there of skill development that may be better addressed by the business community as is recognized in our administrative rules that regulate these things. It's noted that if a business conducts training within its own facility for a program that does not fall under the necessary requirements of postsecondary education; however, if that same training is offered by a company for it's employees within the company is being offered by Lisa in an office setting for several different companies, Lisa would have to be recognized as a postsecondary education facility. I don't have all the answers I'm just saying I think we need this study. I think it would improve our workforce and after all that's what's makes us great.

Rep. Wall: Do we have something like this in place now. I'm thinking of the skills center in Fargo. Don't we have things like this operating now?

Wragham: I'm not aware of anything like that that is available.

Wayne Kutzer, director of the department of Career and Technical Education, DPI spoke in the "middle of the road" for the bill. One of the responsibilities of our department is to oversee the authorization of private postsecondary schools to operate in the state. While there is always room for a study to see if things or a process can be done better there are some concerns that I have with this resolution. One of them is on line 2 and also line 22 where it talks about approving various postsecondary skills development programs. I do believe they are actually talking about private or proprietary postsecondary skill development programs. When Rep. Wrangham was talking about training programs, currently under the law if a business decides if they want to train their employees there is no oversight. They do not go through our office to receive authorization. If a business or a labor union decides that they want to hire me to teach their employees computer skills I don't have to go through any authorization to operate. There is also no authorization to operate if I solely offer my business or training to a business and the business pays the bill. That's the key. If the business pays the bill there is no need for oversight. The oversight comes in where the individual consumer pays the bill and that is the crux of the law is consumer protection. I don't necessarily see anything wrong with putting together a study but the whole purpose of the law that is there now and I would like to see that somewhere in the resolution stating that there is a concern that there is reference to protection of the student that is involved in the training and that's really what the intent of the law of is currently as it exists.
