Roxanne Woeste, Legislative Council- Explains the bill regarding to mileage and travel expense reimbursement for state officials and employees. This bill increases mileage from 31 cents to 37 1/2 cents which is the current Federal mileage reimbursement rate.

Senator Nelson - Asked if this were to go through is it in the budget.

Woeste - Said she can not speak for all agencies but assumes their budgets include the 31 cents.

Senator Nelson - Looking at the general fund, other funds, asked if this included school districts, cities, towns, counties, and other subdivisions, other than what we generally say is state government.

Woeste - She did not believes it does and thought it only applies to state government.

Laura Glatt - University Systems- In support of 2058. Believe this bill is important to recognize the increase in cost of gas and the wear and tear of your vehicle when your asked to use your personal vehicle for state travel.

Senator Nelson - Asked if Higher Ed has included in their budget.

Glatt - Replied the Governors budget does propose an increase for higher education so it would be funded within existing budget or the increase funds that the Governors budget includes for higher education. She stated this wasn't specifically built in as a cost increase component when they built their budget, but it would be absorbed in those current resources.

Senator Nelson - Is concerned with this and other bills raising lodging, meals, mileage. That is why she asks if it is already in the budget.

Mike Brand - Director of Surface Mgmt., ND State Land Dept. - See written testimony. Considers himself neutral on this bill but does propose an amendment. (see proposed amendments).

Don Offerdahl - ND State Electrical Board - See written proposed amendments.

In support of bill with amendments. Stated that the City Inspector from Fargo gets 40 1/2 cents and our State Inspector gets 31 cents. Over 50% of their travel is over gravel roads which causes more wear and tear on their vehicles. They do not take any money out of the general fund.

They are self serving off of permits and fees. They have not had a fee increase since 1990.

He believes the employees are subsidizing the state for mileage. He discusses his proposed amendments. (see amendments)

Senator Syverson - Did some rough calculations and wondered if it would be more fiscally responsible for the state to provide the vehicle.

Offerdahl - Said he staff works odd hours and travel, they can not use state vehicles on their off hours.

Senator Lee - Thought it would be very difficult to log miles on gravel roads and wondered how that would be done.

Offerdahl - Said that they are rural inspectors and drive 70% of the time on gravel.

Senator Syverson - Asked if some agencies have a higher percentage on hard surface roads, so could we apply certain percentages to certain agencies.

Offerdahl - Said he cannot speak for other agencies. Possibly the Health Dept., they have rural nurses that use their own vehicles.

Minutes: Relating to mileage and travel expense reimbursement for state officials and employees.

Chairman Haas: We will open the hearing on SB 2058 and ask the clerk to read the title please.

Roxanne Woeste-Legislative Council-Neutral -Senate bill 2058 is this, all it does is increase the rate for mileage reimbursement from 31 cents to 37 and half cents per mile.

Chairman Haas: Roxanne how did they come up with 37 and half cents?

Roxanne: At the time that was the current federal reimbursement rate, as of February 1st it increased to 40 and half cents, at the time the commission was during there work, it was at 37 and half cents.

Chairman Haas: I see that there is a section crossed out on line 14, were we actually reimbursing on the basis of whether you drove a car or a truck?

Roxanne: Mr. Chairman, I believe so. Line 14, the senate did strike that language.

Chairman Haas: So prior, if that language is not stricken from the statute that when you submitted a travel voucher you had to indicate whether you were traveling by car or truck?

Roxanne: I don't process travel vouchers.

Rep. Klemin: Mr. Chairman I probably have submitted some erroneous travel things, because I drive a pickup, which is licensed as a truck.

Chairman Haas: Are there any further questions for Roxanne? Thank you Roxanne, pretty simple, straight forward change. Thank you very much. Is there any additional testimony on SB 2058? Is there any testimony in opposition of SB 2058.

Rep. Froseth: Could you explain the fiscal note, on this does that represent the difference between what is now 31 cents and 37 and half cents, that represents the difference six and half cents for the biennium, or is that the total amount of travel expenses paid?

Roxanne: The fiscal note does reflect the amount of anticipated increase, from 31 to 37 and half cents. There is an amount shown for 05 and 07 and 07 and 09. The amount expenditures that are to increase, not totally.

Rep. Froseth: Six and half cents will increase it 885,000 dollars.

Roxanne: That is correct, for other funds, the fiscal note was completed by Office of Management and Budget, they anticipate that general funds expenditures will increase by 170 and the other funds to increase by 185, for a total of 355,000 total, this would be for all state government.

Chairman Haas: So you say the increase is 6 and half cents, so to divide .065 into 170,000 it will get you how many miles. A lot of miles. The fiscal note dated February 4th, OK any further questions on the fiscal note for Roxanne. Is there any additional testimony on SB 2058.

TESTIMONY OF MIKE BRAND Director of Surface Management North Dakota State Land Department

SENATE BILL NO. 2058

Government and Veterans Affairs Committee January 21, 2005

Chairperson Krebsbach, members of the Senate Government and Veterans Affairs Committee, I am Mike Brand, Director of the Surface Management Division for the State Land Department.

I am here to present a proposed amendment to Senate Bill 2058 concerning mileage reimbursement for motor vehicles and trucks. The amendment removes the separate rate for travel by truck. The Department of Transportation motor pool charges agencies 28 cents per mile for a sedan/wagon while they charge 46 cents per mile for a light pickup/cargo van. Senate Bill 2058 proposes a lower rate for trucks than for other motor vehicles, just the reverse of motor pool charges. The statute is also not clear on whether pickups, vans and/or SUVs are considered to be trucks.

It appears that the easiest solution to this discrepancy is to remove the reference to a truck and allow a flat rate for motor vehicles. This would allow agencies to use the most appropriate vehicle for the job when a private motor vehicle is needed.
