**Senator Flakoll :** I believe there will be an amendment that will be forth coming that will include EMS individuals to the list of applicable individuals. Is there any problem that we foresee with that?

Pat Seaworth: The board doesn't have a position on that at this time, we assume that the #'s would be small and the impact would be minimal. Without actually knowing that we just don't

have a position we certainly aren't going to oppose it at least at this time. The board has not had a change to interpret.

Senator Seymour: I see the fiscal note says zero, is this a real fiscal note when it says zero?

Pat Seaworth: No, obviously the fiscal impact is not zero, it is just that it is impossible for us to come up with a concrete figure. The amount of the waiver varies with the various students, if the calculations are done manually we would have had to survey all the campuses and they would have had to manually go through their records to come up with actual #'s. We do know that the # is small relative to the total budgets on the campuses. A few \$'s for a hand full of students, the # is small and then it will be partially offset by the administrative savings.

Mark Weber: Director of Golden Heart Paramedics,

**Senator G. Lee:** When you say EMS, does this include all levels of emergency personal from paramedics, to EMT to first responders?

Mark Weber: The first responders are not included in that. But EMT basic, EMT intermediates. and paramedics are included in that. There's actually a level of first responders, and typically first responders are, firefighters and police officers, highway patrol, already covered in that. We don't recognize first responders as EMS providers through the health department.

**Senator G. Lee:** Do we know how many of the #'s of people we would be looking to add then?:

Mark Weber: Probably not. I really don't know of anyone in the last five yrs. that have died. Throughout the country there have been accidents with ambulances. This does happen, look at anhydrous, and also tornado, this could happen.

Chairman Kelsch opened the hearing of SB 2079.

Pat Seaworth, general counsel for the State Board of Higher Education, testified in favor of the bill. (Testimony attached.)

Rep. Mueller: Can you give us an example of outstanding bonds?

Seaworth: There are a number of different bonds issued that are paid off with student fees.

Each campus has a student activity fee and a part of the fee goes to retire bonds issued to finance student union expansion or renovation. We also have a technology fee and part of the fee goes to pay for the infrastructure to support technology. All campuses have a Connect ND fee and that goes to retire bonds issued for that project.

Rep. Sitte: How much do average fees run at the universities.

**Seaworth:** It varies. At the larger campuses the total fees can range from \$400 to \$700 annually. The total can be as much as \$600 - \$700. I should add that does not count Valley

City State and Mayville State. Those two campuses have a notebook fee that adds another \$600 or \$700. Their total fees exceed \$1000.

Lt. Col. Dave Theile, staff judge advocate for the ND National Guard on behalf of Maj.

Gen. Haugen, testified in favor of the bill. The bill is strait forward and I will not talk to much about that. Maj.Gen. Haugen is down in Ft. Carson. We just had 50 more soldiers return last night. We're going to have 300 soldiers that came in last week returning to ND tomorrow. I can tell you they are in good spirits. They have had a very difficult mission. They've drank more than a couple of beers in Ft. Carson and they deserve it. We're very, very excited to have them come home. The only remaining soldiers over there with the 141st are ten soldiers with the rear detachment. As supportive as this Legislative Assembly has been, I thought you'd like to know

**Chairman Kelsch:** Thank you so much for that information.

John Jacobsen, chairman, of the Legislative Committee of the ND Veterans Coordinating Council. (Testimony attached.) The Council has instructed me to ask for your support of SB 2079 to include the amendment for the EMTs. It's a good bill and I think that our veterans, peace officers, firefighters and EMTs all have earned something like this for our dependents.

Dean Lampe, executive director, ND Emergency Medical Services Association, testified in favor of the bill. (Testimony attached.) He presented an amendment drafted with the help of Rep. Johnson. As the bill is currently written it refers to "emergency medical technician." The amendment would change that to "emergency medical services."

### **Senate Education Committee Testimony on SB 2079**

Pat Seaworth, General Counsel

Chairman Freborg and members of the Senate Education Committee:

I am here today in support of SB 2079, which was introduced at the request of the State Board of Higher Education. This legislation will allow the waiver of all tuition and fee charges for dependents of veterans and survivors of firefighters and peace officers. Also, the bill extends the time permitted to complete a degree, from four to five years.

Current law establishing entitlement to a waiver of tuition and fees for dependents of certain veterans and survivors of firefighters and peace officers prohibits waiver of fees charged to retire outstanding bonds. Some fees are allocated in part to operations and in part to retire bonds. However, because our finance system does not calculate a waiver of a portion of a fee, this must be done manually. The cost of setting up the financial accounting system to calculate the portion of the fees relating only to debt retirement is cost restrictive, due to the small number of students affected. The proposed change will provide for waiver of all fee charges to qualifying students. It will favorably impact about 50-75 students, saving each of them a few dollars every semester. The fiscal impact on the campuses will be minimal, and lost revenue will be offset in part by administrative savings realized due to elimination of the manual tasks. The portion of fees collected to cover associated debt has always been more than sufficient and this change will not materially impact revenues available for debt repayment.

The law now permits students granted a waiver up to thirty-six months or eight semesters to complete a degree. Most students today are employed and many are supporting families. The average student requires more than four years and eight semesters to complete a bachelor's degree. Given the increase in the number of part-time and other non-traditional students and increased degree credit requirements in many programs, extending the completion period to five years and ten semesters is warranted.

### North Dakota Emergency Medical Services Association

Good morning, Chairman Freborg and members of the committee. My name is Mark Weber, and I am the Director of Golden Heart Paramedics in Rugby, North Dakota and a licensed, practicing paramedic by training. I am also the President of the North Dakota Emergency Medical Services (EMS) Association. Our association represents approximately 1600 individual EMS provider members throughout the state who primarily serve on North Dakota's 143 licensed ambulance services. On behalf of our membership and me personally, I am pleased to share with you this morning our thoughts concerning this bill and why we offer this important amendment to this legislation.

The North Dakota EMS Association thanks Senator Flakoll for assisting us in preparing the amendment to correct what we feel is an inadvertent omission from the current law. As you know, Law Enforcement, Fire, and Ambulance Services are typically thought of as "First Responders" in virtually all emergency and disaster scenarios. Presently, Section 15-10-18 of North Dakota Century Code is designed to recognize the ultimate sacrifice of an individual who gives his or her life in the line of duty. The present law recognizes veterans, peace officers and firefighters and, unfortunately leaves out ambulance service personnel.

Quite honestly, our association was under the impression that our EMS providers across the state were already included in this law. However, we were reviewing the bills introduced for this session, we noticed that this bill was being offered to increase the amount of time allowed for degree completion when we noticed that EMS providers were not being recognized among the group of emergency first responders.

Our rationale is simple and straight forward. If you can think back to the Red River Valley floods, the Minot train derailment, or other emergency situations, you will recall that it was law enforcement, fire, and EMS that responded to these dangerous emergencies. We cannot imagine that it would be the State's wish that if "First Responder's" lives would have been lost while these individuals were engaged in emergency operations, only firefighters' and peace officers' sacrifices would have been recognized while Emergency Medical Technicians' sacrifices would not have been.

Our association has been in touch with Chancellor Potts office and we have been told that the Board will not take a position on this issue. We understand the Board of Higher Education sought this bill only to make it easier to administer the fees and to lengthen the allowable period provided to obtain the degree.

We sincerely hope that this committee, the legislature, and the Governor will help us to correct this oversight. Thank you for the opportunity to be heard and I would be happy to answer any questions you may have.

My name is John L. Jacobsen. I am the chairman of the Legislative Committee of the North Dakota Veterans Coordinating Council. I am a member of both the VFW and the American Legion. I am also a member of the VFW National Legislative Committee. We work directly with our Members of Congress on legislation at the national level.

I served 29 years in the ND National Guard and the US Army Reserve, retiring in 1995 with the rank of Colonel. I served on active duty in 1991 in the Persian Gulf stationed in the United Arab Emirates.

The NDVCC membership is comprised of 15 members representing the five (5) veterans' organizations in the state. They are:

- > AMVETS
- > Disabled American Veterans (DAV)
- > Veterans of Foreign Wars (VFW)
- > Vietnam Veterans of America (VVA)

These organizations represent approximately 60,000 veterans currently living in North Dakota.

I am a member of the Legislative Committee of the NDVCC. I am not a member of the NDVCC but report directly to them. In order for the Legislative Committee to support any bill brought up before our Legislature, concurrence must be unanimous, that is all 15 members must agree that we should support the bill. A single negative response will kill our support.

Chairman Kelsch and members of the House Education committee:

I am here today to support SB 2079, which was introduced at the request of the State Board of Higher Education. This legislation allows the waiver of all fee charges for eligible dependents of veterans and survivors of firefighters and peace officers. The bill also extends the time permitted to complete a degree, from four to five years.

Current law establishing entitlement to a waiver of tuition and fees for dependents of certain veterans (resident veterans killed in action, disabled or POWs) and survivors of firefighters and peace officers prohibits waiver of fees charged to retire outstanding bonds. Some fees are allocated in part to operations and in part to retire bonds. Because our finance system does not calculate a waiver of a portion of a fee, this must be done manually. There would be a significant additional expense to make the customized programming changes, plus ongoing maintenance costs to revise and update these customized changes, in order to avoid the manual work. To avoid the necessity of the manual work or the expensive customization, SB 2079 provides for a waiver of all fees, including fees for outstanding bonds. It will favorably impact about 100 students, saving each of them anywhere from just a few dollars to perhaps as much as \$60 or \$70 each semester, depending on size and type of bond issues at a particular campus and number of credits a student takes.

The bill also extends the maximum time for completing a degree from thirty-six months or eight semesters to forty-five months or ten semesters. In part because most students are employed and may enroll in fewer classes each semester due to work or family demands, and also due to increased educational requirements in many programs and careers, students who complete requirements for a bachelor's degree in four years are no longer the norm.

The Senate amended the bill to add survivors of emergency medical technicians to those students eligible for the waiver. The Board does not oppose this amendment.

### North Dakota Emergency Medical Services Association

Good morning, Chairwoman Kelsch and members of the committee. My name is Dean Lampe, and I am the Executive Director of the North Dakota Emergency Medical Services (EMS) Association. Our association represents approximately 1600 individual EMS provider members throughout the state who primarily serve on North Dakota's 143 licensed ambulance services. On behalf of our membership, I am pleased to share with you this morning our thoughts concerning this bill and why support this legislation with amendments.

First of all, we are grateful to Representative Johnson for his assistance in preparing amendments to this bill which remove an ambiguity in the engrossed Senate Bill. This is a Legislative Council bill which was originally requested by the State Board of Higher Education to increase the amount of time allowed for a qualifying dependent to obtain a degree. The bill was amended in the Senate Education Committee to include Emergency Medical Technicians in addition to other "first responders" that previously included firefighters, law enforcement, and veterans. In virtually all emergency or disaster scenarios, law enforcement, fire and EMS are considered as "first responders." This engrossed bill was reported back to the Senate from committee with a 6-0 Do Pass recommendation; and, it passed on the Senate floor by a vote of 44 Yea, 0 Nay.

These amendments only clarify who would be considered Emergency Medical Service personnel by referencing current Century Code section 23-27 which describes the various EMS provider levels. As the engrossed bill currently reads, it refers to "Emergency Medical Technician," which is only one of several provider levels of practice. Our membership urges this committee to recommend Do Pass on this bill with these amendments
