Senator Seymour: What's the value of the report? What makes it so valuable?

Jerry Coleman: School finance facts is a publication that identifies specific information on school districts in the state so it contains information on average daily membership financial expenditures and revenues, taxable evaluation, mill levy that kind of thing. So it is extremely important for those that are interested in financing.

Senator G. Lee: In the bill draft you have a lot of things deleted, in terms of specifics that go into that report. If those are taken out, will what goes into that report, change?

Jerry Coleman: We will present the information that already exists in the finance tax publication. There is one thing in that list that I noted that is not in our finance tax publication, either we can put it in there, or make it available in our school directory information. That would be the last one there that deals with information on nonpublic schools. We have very limited information on nonpublic school. We have like accreditation and approval requirements and recorded in our school directory and has been for years. There's another place to pick up that information.

Senator G. Lee: This then would give you the latitude to put information into that report that you saw as being valuable, and delete what things you didn't think were important.

Jerry Coleman: Yes, it does give us that latitude.

Senator Flakoll: Have you consider ever mailing those out during the off yr. session? So that we would have that provided for us, school finance tax, even # yrs. we go through lack of information in that respect. There was a ? someplace there.

Jerry Coleman: Sounds like you would request that information annually. (meter 1827 other) information is published on our web-site so this is easily accessible. Traditionally we have made a formal document and distributed that to the legislative committees.

Testimony in opposition of Bill:

Doug Johnson: North Dakota Council Education my only concern of the bill is that the deletion of the items that are listed, we feel that it is important that they remain in tact, the rest of bill we

RE: SB 2083 - distribution of school district finance facts report - amendment

For biennial reports filed according to N.D.C.C. § 54-06-04, the Secretary of State is allowed to do the following under subsection 6 of that section:

"All reports required under this section to be submitted to the secretary of state must be subsequently transmitted by the secretary of state to the state archivist for official and public use following their receipt and review by the secretary of state."

There is not a similar option for the Secretary of State in N.D.C.C. § 15.1-02-09, either in current law or in the changes proposed in the subject bill.

To establish a clearer administrative process, I request that the following sentence be inserted on page 1, line 10, after "February."

"The secretary of state must subsequently transmit the report to the state archivist for official and public use."

Without the directive, the report remains in the Secretary of State's office for an extended period where it is not accessible by those who may wish to review it.

Madam Chairman and members of the committee:

My name is Jerry Coleman and I am the Assistant Director of School Finance and Organization for the Department of Public Instruction. I am here to speak in favor of SB 2083.

Section 15.1-02-09 of the North Dakota Century Code requires the superintendent of public instruction to include financial information with the agency biennial report. The biennial report is the report required by executive and administrative offices and is submitted to the governor and the secretary of state (NDCC 54-06-04).

The amendment eliminates the requirement to publish financial information in the biennial report and replaces it with a requirement to publish that information in a separate annual report to the governor, legislative council and secretary of state by the end of February each year. This annual report is the "School Finance Facts" publication that the department has routinely published for many years.

The purpose of the amendment is to avoid compliance problems due to the submission date of the biennial report. That report is due December 1 and financial data from school districts is not processed and finalized until late January or February.

The amendment does not have any fiscal impact.

That concludes my testimony. I would be happy to answer any questions the committee may have.
