Minutes:

Chairman Trenbeath opened the hearing on SB 2112 relating to identification as an organ donor on non driver photo identification cards.

All members were present

Senator Brown said the purpose of this legislation is to allow the ND DOT drivers license division to put a donor designation on a ND issued photo ID card. He is submitting this at the request of a constituent (Scott Allen) who does not have a drivers license but does have a state photo ID card. When Scott Allen attempted to have a donor designation put on his ID he was told that it could not be done without changing the law.

Scott Allen appeared in favor of SB 2112 along with his parents Esther Allen and Clyde Allen.

David Sprynczynatyk (Director, ND DOT) appeared in favor of SB 2112.

There was no testimony in opposition to SB 2112.

Senator Nething motioned a Do Pass. Seconded by Senator Espegard.

Senator Warner asked about the legal implications in the medical community.

Dave Peske (ND Medical Association) said that the receiving facility has the protocol set up, and upon receiving the identification takes the steps to do the harvesting of the organs.

Senator Warner asked if this is subject to objection from family members, if it is subject to challenge.

Chip Thomas, (ND Healthcare Association) In favor of SB 2112. This is a gray area in great debate right now in the legal field. Law articles circulating in ND would suggest that if an institution operated on good faith based on a specific drivers license donor designation, and on that solely, they would be operating within the parameters of the statutes that are currently in place. However, because there is a human element in this, if the institution would also ask an attending responsible adult or guardian what their thoughts were about the persons intent, the query supersedes the designation on the card. Right now, there is great discussion and debate with respect to what an institution does with respect to fulfilling the intent.

Janelle Johnson (Medcenter One Health) This identifies the wishes of the individual and allows the emergency room personnel time to maintain life sustaining measures until family members can be contacted and the issues can be worked through.

Roll call vote 6-0-0. Passed. Floor carrier is Senator Espegard.

The hearing of SB 2112 was closed.

<u>ChairmanWeisz</u> reopened the hearing on SB 2112.

Senator Brown: I would like to introduce you to SB2112. Last year Scott Allan approached me about a problem he had. He wanted to be identified as an organ donor. He does not have a drivers license, but he does have a ND ID card issued by the ND DOT. He went to the Fargo DOT office and tried to have organ donor added to his ID card and was told this could not be done. To be able to do it the law will need to be changed. Scott called me and asked for help. I am here to propose we change the law and add organ donor designation to be added to a ND issued ID card. The point is to encourage more people to be organ donors.

Scott Allen: (1.7) I want to thank you for letting me come and testify on bill SB2112. I do not drive a car so I don't have a drivers license. That is why I got an identification ID card at the ND DOT. I told them I wanted to be an organ donor, but they said they could not put it on an ID card. I talked to Senator Brown to see what could be done. He said that a new law would have

to be passed so he sponsored the bill before you. If you would pass this bill I would like to be the first person to get this ID card with the organ donor on it. I thank you very much for this opportunity to talk to you.

Senator Brown: Urged a do pass on this bill.

Rep. Delmore I think it is very important that we pass this and I hope you will be the first to have the ID card.

Rep. Weiler We want to make for sure he is the first one to get the ID card if we do pass this bill.

Arnold Thomas: President of ND Health care Assoc. We are pleased to support this measure. Wondered why we hadn't thought of this measure and am pleased to support it and hope it does pass.

<u>Dave Sprynczynatyk:</u> (4.0) We are in support of this bill and make it clear we always follow legislative intent.

Rep. Ruby This is probably the only way to identify a donor. Is there separate donor cards that some people get? Is there any other way information can be shared or provided to the health care facility or anything.

<u>Dave Sprynczynatyk:</u>(5.4) There are other ways to do ID cards.

Lynn Heinert: There are donor cards that are offered through the Lyons Clubs, I Bank, one with the hospital. The hospital, I believe, have an electronic data base that shows all the registered donors.
