Senator April Fairfield - See written handouts- Senator Fairfield told how heavily we rely on lobbyists and the most precious commodity elected officials have is public confidence. She said this bill is not a response to anything done wrong but a testimony to what we do right in ND. She briefly went through the bill. She said that disclosing information makes it more acceptable. If travel expenses are paid for a legislator it must be reported according to this bill.

A gift not reported is not allowed. She then went over the amendments.

Senator Fairfield - No event precipitated this. Public policies are of an interest to her and the democratic process. Campaign finance is not readily addressed and what happens once you have won the election. She believes in greater disclosure laws.

Senator Lee - Stated she doesn't believe there is a problem now. She does have a problem with getting approval for every trip.

Senator Fairfield - Would like disclosure.

Senator Lee - Thought that the reporting should go on the legislators report than requiring that the legislative council approve it.

Senator Fairfield - See no problem with that. Point is not who does the reporting but that it is reported.

Senator Nelson - Mentioned that anyone who lives in a border city has the problem of traveling out of state when its just a neighboring city like Moorhead.

Al Jaeger - Sec of State - See written testimony- Concerned about procedure.

Senator Nelson - Asked if lobbyists also report.

Jaeger - Once a year. Political Action Committees have to report as well as legislators.

Senator Krebsbach - Asked if the \$25 limit also pertains to travel.

Jaeger - Yes, in the lobbyist detailed report. He is also concerned on impact on staff and resources.

Chairman Haas: If the lobbyist doesn't come in an register in July, if they wait until late November or December, you don't prorate the fee do you?

Secretary of State: The fee is not prorated at all. Each time a registration is added there is work related to that. What the law says that there is a base fee and each time they add an organization it is 5 dollars.

Rep. Klemin: One is on the fee, I understood you to say that the Senate GVA committee increased the fee and it was not made at your request?

Secretary of State: It wasn't, I hadn't specifically asked that it be raised, but they decided that it would be good to raise and we do in the process give them a name badge that they may or may not wear, but there are different things that we do. Certainly the amount of work that is with it, the extra five dollars represents the processing.

Rep. Klemin: Is there a requirement for a fiscal note when we have increase like this in a bill? **Secretary of State:** Usually the legislative council lets me know.

Rep. Klemin: At the end of this bill, page 4, the last paragraph about the Internet and electronic filing, I guess, does it say it is in the statute?

Secretary of State: I think that was kind of added in reference to the changes the committee decided to make to the bill.

Chairman Haas: The law didn't say you had to do this with pencil and paper, if the job is described you simply have to implement it, which ever way is suitable.

Rep. Froseth: Page 2, line 20, report any gift of 50 dollars or more. Revoking the license, I would like to have you give us some information on how often that happens and on the back page is that annual report that has to be filed and I think that you should have amended that it has to be reported on all the daily newspapers electronically.

Secretary of State: The last part, you will have to decide whether you want it published in all the papers or not. The ceiling at one point was 25 dollars and I believe it was two sessions ago, it was increased to 50 dollars and so it has been that long since that ceiling has come up. I think you have to keep in mind that the 50 dollar level, we really don't have that many people that are

reporting those, in other words they are able to do a lot of things for less then 50 dollars. The revocation, that only comes into play when we are at the end of the cycle and the years ended and they are suppose file a report and they have already registered with us, but they missed the August 1st deadline and then they missed the second deadline and so what the law says that after you missed the second deadline and you are already registered, we just automatically lift your registration. You have registered, but you have never filed your report and so that is the only time that comes in. If you didn't file your report it was a criminal infraction. You can imagine if I took a handful of those down to the states attorney and they have a murder and a robbery on there desk, you can about imagine a lot doesn't get done with that in terms of prosecution and so essentially what the fine does, is that we find that people respond rather well to financial incentives.

Minutes: Chairman Brown called the conference committee to order to discuss SB 2303. All members were present: Senators Judy Lee and Carolyn Nelson, Representatives Haas, Grande, and Potter.

Representative Haas- It is becoming increasingly difficult for lobbyists to adhere to the \$50 limit on taking legislators out for dinner, etc. Our committee thought the amount should be raised to \$75.

Representative Grande- A full reporting technique is required, most meals are now around \$65, and that figure will more than likely go up in the future.

Representative Haas- If we feel like there is a huge threat to the democratic process and an unnecessary influence being exerted because lobbyists take legislators out to dinner, we would feel differently. However, the lobbyists help us learn more of the details with the various issues out there. Our committee didn't think it was appropriate to put an undue reporting requirement on lobbyists.

Representative Potter- She feels that \$75 was too high in the first place, and disagreed with the House committee's view.

Senator Brown- Our committee on the Senate side, felt very strongly that \$50 was an adequate limit to spend on legislators.

Senator Judy Lee- An increase to \$75 is too much in my opinion.

Senator Nelson- The prime sponsor of the legislation is not in favor of tripling the amount that was in the original bill.

Representative Haas- The question we need to ask ourselves is: will there be a difference that an influence a lobbyist would have on a legislator by increasing the amount to \$75?

Representative Grande- I'm planning our end of the year party, and it was very easily \$55 per person. The average is currently \$63 per person. I'm wondering what the amount will be two years from now?

Senator Nelson- Is it true that only six lobbyists have reported exceptional expenses?

Secretary of State Al Jaeger appeared before the committee- Out of the 600 reports that my office does during the legislative cycle, there are only a dozen that file reports on exceeding the amount.

Senator Brown- I have a report that shows most states go by a similar system that we do, when it comes to reporting requirements.

Representative Haas- How would \$60 for a limit sound for a reasonable compromise? Interacting with lobbyists is a normal part of the way on how we operate as legislators.

RE: SB 2303 - Lobbyist Reporting Requirements

My comments related to this bill are not about the merits of the reporting but about our concerns as they relate to the procedures outlined in the bill and the possible staffing and financial impact it would have on the Secretary of State's office for carrying out those procedures.

Under current law, the registration cycle for a lobbyist begins July 1 and ends on June 30 of the succeeding year regardless of when during the cycle the lobbyist registered or how many days during the registration cycle they engaged in lobbying. The quarterly reporting requirement does not appear to address those realities.

I have listed below the number of lobbyists registered during the past four registration cycles and the number that filed reports indicating they had reportable expenditures. The highest numbers of registrants, of course, represent the cycle in which the legislature meets.

July 2000/June 2001 - 629 registrants representing 974 entities with 27 reporting expenditures July 2001/June 2002 - 269 registrants representing 419 Entities with 3 reporting expenditures July 2002/June 2003 - 634 registrants representing 974 Entities with 18 reporting expenditures July 2003/June 2004 - 272 registrants representing 425 Entities with 4 reporting expenditures

Our current procedure is to scan the expenditure report when it is received. It is then made available upon request. It is very seldom that someone requests to see a report. As proposed in this bill and during a legislative cycle, the agency would be required to scan an extra 1,800 to 2,000 reports, which would takes time and staff, which the agency is currently not budgeted for.

If the reports are to provide disclosure to the public, it would be necessary to post them in a readily assessable format such as the agency's website. But, to do that, it would require an estimated \$20,000 to develop the application for posting the reports on the agency's website, which amount is not currently available in the agency's budget. The application would have to be one where the scanned report could be viewed because the agency does not have the staff, time, and resources to manually input the data from the these numbers of reports each quarter.

WASHINGTON, May 15, 2003 - The Center for Public Integrity conducted a survey of lobby disclosure laws in all 50 states. The survey focused on the registration, spending reports, public access and enforcement regulations governing state lobbyists. The 48 questions used in the survey had multiple-choice answers with numerical values, with 100 possible points. Answers that promote openness, accountability and public access were assigned higher values. The resulting total score for each state is listed below,including a ranking relative to other states.

Scores of 80 and higher are considered satisfactory to excellent. Scores of 70 to 79 are considered relatively satisfactory. Scores of 60 to 69 are considered barely passing. Scores below 60 are considered failing.

Update:

The office of the Secretary of the Commonwealth of Virignia contacted us in March 2004 to provide additional information related to the state's lobbying disclosure laws and practices. After carefully reviewing this information, the Center has revised the Virginia score, moving it into a tie for 16th place, up from 32nd place.







RE: First Engrossment of Engrossed SB 2303 - Legislative Lobbying

Under current law, the registration cycle for a lobbyist begins July 1 and ends on June 30 of the succeeding year regardless of when during the cycle the lobbyist registered or how many days during the registration cycle they actually engaged in lobbying. Then, by August 1 after the end of the registration cycle, the lobbyist is required to file with the Secretary of State a report itemizing his or her reportable expenditures made during that registration year.

As it was originally introduced, Section 1 of the bill would have required quarterly reports. Without other significant changes to the present law, this requirement would have presented a logistical and processing challenge. The Senate removed this requirement along with Section 2 of the original bill. It then made several other changes and added the now Section 2 to this engrossed bill.

Section 1 of the Engrossed Bill includes three areas of change.

- 1. Throughout, there are numerous changes made to updating text style and lengthy paragraphs are broken up into subsections, which make this section of law much easier to read.
- 2. On page 2, lines 21 and 22, it makes it clear that the \$50 reporting threshold on any single occasion applies individually to the legislator and the governor as well as to the spouse and any other family member of the legislator and the governor.
- 3. On page 2, a line 24 through 27, the change clarifies the information that the lobbyist must report if he or she exceeds the \$50 or more reporting threshold.

Section 2 of the Engrossed Bill includes three areas of change.

- 1. Throughout, are the same changes as noted above in explanation # 1 for Section 1.
- 2. On page 4, lines 11 and 12, the Secretary of State is to make available to the public a report of the total amount of expenditures reported.
- On page 4, lines 13 through 16, the Secretary of State is authorized and may, as resources
 permit, establish electronic registration and reporting procedures and make lobbyist reports
 available on the agency's website.

CHAPTER 54-05.1 LEGISLATIVE LOBBYING

3/19/65 Current Law

54-05.1-01. Legislative intent. It is hereby declared to be the intent of the legislative assembly to require that lobbyists register as such before engaging in lobbying activity and to require certain reporting procedures by lobbyists.

54-05.1-02. Applicability - Meaning of lobbyist.

- This chapter applies to any person who, in any manner whatsoever, directly or indirectly, performs any of the following activities:
 - a. Attempts to secure the passage, amendment, or defeat of any legislation by the legislative assembly or the approval or veto of any legislation by the governor of the state.
 - Attempts to influence decisions made by the legislative council or by an interim committee of the legislative council.
- This chapter does not apply to any person who is:
 - a. A legislator.
 - b. A private citizen appearing on the citizen's own behalf.
 - c. An employee, officer, board member, volunteer, or agent of the state or its political subdivisions whether elected or appointed and whether or not compensated, who is acting in that person's official capacity.
 - d. Invited by the chairman of the legislative council, an interim committee of the legislative council, or a standing committee of the legislative assembly to appear before the council, interim committee, or standing committee for the purpose of providing information.
 - e. An individual who appears before a legislative committee for the sole purpose of presenting testimony on behalf of a trade or professional organization or a business or industry if the individual is introduced to the committee by the registered lobbyist for the trade or professional organization or the business or industry.
- 3. For the purposes of this chapter, persons required to register under this chapter because of the performance of the activities described in subsection 1 must be known as "lobbyists".

54-05.1-03. Registration as a lobbyist - Fee - Filing of information - Public inspection - Certificate of registration.

1. Any person who shall engage or be engaged by any other person either on a part-time or on a full-time basis for any of the activities listed in section 54-05.1-02, shall, before doing anything in furtherance of such purposes, register with the secretary of state and receive a certificate of registration and a distinctive lobbyist identification badge that must be prominently worn by the lobbyist when engaged in any of the activities listed in section 54-05.1-02 while on the capitol grounds. In lieu of wearing the official badge provided by the secretary of state, a lobbyist may wear a reasonable reproduction of the official badge that contains the name of the lobbyist and any of the following: the word lobbyist, the registration number of the lobbyist, or the organization name of the lobbyist in characters no smaller than one-quarter inch [6.35 millimeters]. The registrant shall state in writing the registrant's full name

and business address, the name and address of the person or persons upon whose behalf the registrant appears, all persons, corporations, limited liability companies, associations, groups, or organizations in whose interest the registrant appears or works, the duration of such employment or appearances, and by whom the registrant is paid or is to be paid. The registration period commences on July first and expires on June thirtieth of the following calendar year unless an earlier expiration date is requested by the registrant. Lobbyists required to be registered shall file with the secretary of state, prior to the issuance of a certificate of registration, a written authorization to act as lobbyist. Such authorization must be signed by the person or official of the corporation, limited liability company, association, group, or organization employing such lobbyist and may be filed by facsimile transmission. The secretary of state shall charge a fee of twenty dollars for registering each lobbyist and the first person or entity represented by the lobbyist and an additional fee of five dollars for each subsequent person or entity represented by the lobbyist.

- 2. Each person registering to act as a lobbyist shall file, on or before August first following the expiration of the registration period, with the secretary of state a detailed report. The report must include a statement as to each expenditure, if any, of fifty dollars or more expended on any single occasion during the legislative session or the interim, as the case may be, on any individual in carrying out the lobbyist's work or include a statement that no reportable expenditures were made during the reporting period. A state official or agency may not require reporting of lobbyist expenditures other than is required under this subsection. The secretary of state shall provide a prescribed form for reporting pursuant to this chapter. The secretary of state shall charge and collect fees for late filing of the detailed expenditure report as follows:
 - a. Within sixty days after the date provided in this subsection for filing the detailed expenditure report, twenty-five dollars;
 - b. Thereafter, fifty dollars; and
 - c. If any currently registered lobbyist fails to file a detailed expenditure report and pay any late fee by October first, the lobbyist's registration is automatically revoked. The lobbyist's registration may be reinstated if the lobbyist thereafter files the detailed expenditure report and pays any outstanding late fee.
- 3. All information required to be filed under the provisions of this section with the secretary of state and that previously filed must be compiled by the secretary of state within forty days after the close of the period for which such information is filed and such files must be open and accessible for public inspection during the normal working hours.

54-05.1-04. Granting and revoking of certificates - Referrals and reports to the attorney general.

- 1. It is the duty and responsibility of the secretary of state:
 - a. To grant a certificate of registration and to design and furnish a distinctive lobbyist identification badge to any person registering under section 54-05.1-03 who supplies the information therein required.
 - b. To revoke the certificate of registration of any person who has been convicted of violating any of the provisions of this chapter.
 - c. To refer on the secretary of state's own motion or on the verified complaint of any member of the legislative assembly or on the verified complaint of any state official, board, commission, department, or agency, or on the verified

complaint of any other person, to the attorney general for investigation, the activities of any person who the secretary of state has reason to believe has been acting as a lobbyist and who may be in violation of the requirements of this chapter.

- d. To make available upon request of any citizen expenditures by categories reported by registered lobbyists to have been expended on each individual in carrying out that person's work.
- e. To supply a current list of registered lobbyists for each legislator upon request.
- 2. In addition, the secretary of state may revoke the certificate of registration issued pursuant to this chapter for failure to file the reports required by this chapter when due, but no certificate may be revoked if, prior to the last day for filing such reports, the secretary of state has been informed in writing of extenuating circumstances justifying such failure.

54-05.1-05. Invitations and gifts to legislators.

- When any lobbyist invites a legislator to attend a function sponsored in whole or in part by the lobbyist or the principal, the lobbyist shall, upon the request of the legislator, supply the legislator with the true or estimated cost of the gratuity and allow the legislator to attend the function and pay the legislator's own share of the expenses.
- 2. When any lobbyist offers a gift of a non-information-bearing nature to a legislator, the lobbyist shall, upon the request of the legislator, supply the legislator with the true or estimated cost of the gratuity and allow the legislator to pay the cost of and receive the gift.

54-05.1-06. Unlawful means to influence legislative assembly. In addition to the violation of any other provision of this chapter, it is unlawful for any lobbyist or for any other person:

- To directly or indirectly give or agree to give any money, property, or valuable thing, or any security therefor, to any person for that person's service or the service of any other person in procuring the passage or defeat of any measure before the legislative assembly or either house thereof, or before any committee thereof, upon the contingency or condition that any measure will be passed or defeated.
- To directly or indirectly receive or agree to receive any such money, property, thing of value, or security for such service, upon any such contingency or condition, as set forth in the preceding subsection.
- 3. To attempt to influence any member of the legislative assembly without first making known to such member the real and true interest the person has in such measure, either personally or as agent or attorney.

54-05.1-07. **Penalty.** Any person who violates any provisions of this chapter is guilty of a class B misdemeanor except that a violation of section 54-05.1-02 or 54-05.1-03 is an infraction.
