She described the resolution indicating the budget section authorizes the budget section to hold public legislative hearings required with the receipt of new block grant funds during the period from the recess of the 59th Legislative Assembly to September 30 of 2007. Currently there is only one block grant that imposes the requirement of a public hearing, the Community Services Block Grant which hearing has been held. A resolution of this purpose has been in force at past sessions.

Senator Tallackson motioned to have a DO PASS, Senator Thane seconded. A vote was not taken at this time.

After hearing no further comments, the hearing on SCR 4001 closed.
