Minutes:

Senator Stanley Lyson, Chairman of the Senate Natural Resources Committee brought the committee meeting to order.

All members of the committee were present.

Senator Stanley Lyson opened the hearing on SCR 4023 expressing the Legislative Assembly's commendation and support for the efforts of the Lake Agassiz Water Authority to deliver water to eastern North Dakota.

Senator Joel Heitkamp of District 26, cosponsor of SCR 4023 introduced the resolution stating he wanted this resolution to become before this committee because it was this committee that created the Lake Agassiz Water Authority last session. He wanted to let the committee know that the authority has been meeting regularly and listed towns or rural areas that are represented on the board. They have been working very hard on the report of the study that will be coming out of the bureau. If the details could be worked out the best way to move the water would be the

Cheyenne, but ground water supply for the west-central part and the Lake of the Woods in Minnesota are also options. Finally, this a resolution to recognize and support the hard work of the authority and let them know the legislature is keeping an eye on them.

Senator John Traynor questioned why the already built 118 miles of the McClusky Canal and the New Rockford Canal are not be considered by the Authority as a means of conveyance of water to the valley.

Senator Heitkamp answered that when considering connecting the canals, more and more it is looking like a pipeline wll be the route. There is talk of a pipeline down Interstate 94 or Highway 200. Those in the southern valley would like the pipeline to run at least as far as the Cheyenne and then be accessed.

Senator Traynor asked why the canals can't be connected and not be waste all the money already invested.

Senator Heitkamp stated the canal system would have been the best system, but finishing that out is still devil's in the details. He further commented that Fargo, West Fargo, Moorhead and the small surrounding towns are growing so rapidly they are becoming one. The water permitting is not there to meet the municipal needs of a community of Fargo, much less industry.

Senator Tim Mathern of District 11, cosponsor of SCR 4023 testified that the Red River corridor is an economic factor for the entire state of North Dakota. This resolution says lets do what we can to make sure that continues even if that seems sharing water resources from the entire state. Lets not jeopardize but plan for the future.

Dale Frink, (7.0) North Dakota State Engineer with the North Dakota Water Commission testified that they are support of SCR 4023.

Mike Dwyer representing the North Dakota Water Users Association testified in support of SCR 4023, stating that they are working with many water bills this session, but the most critical need in the state for water supply is in the eastern part of the state.

Senator Lyson asked for opposing testimony and hearing non closed the hearing on SCR 4023.

Senator Rich Wardner asked why the existing canals can't just be used to bring water to the Cheyenne. It seems simple, "Just finish the ditch".

Senator Heitkamp stated the problem is some recognition of some sort to control the biota before the canal project will happen. The problem might not be to sell the conveyance of water to the eastern part of the state to the city population, but how is it paid for in the future when it is needed in the rural area. That is why this board needs to so diverse, so other communities and the rural areas can have input and be involved.

Discussion was held as to the extremely large block that is at the end of the McClusky Canal to stop any possibility of biota entering Canada.

Senator Ben Tollefson asked if our federal delegation is involved with the biota transfer problem.

Senator Heitkamp told the committee the delegation is in support of the authority and have always believed it should be Missouri River water that is supplied to the east. The Lake of the Woods option is of federal concern and in the end will cost as much as the pipeline for conveyance of the Missouri River water.

Senator Wardner made a motion for a Do Pass of SCR 4023.

Senator Michael Every second the motion.

Minutes:

Chr. Jon O. Nelson: I will open the hearing on SCR 4023 and ask the clerk to read the title. Quorum was present.

Rep. Lois Delmore, Dist. 43: The Lake Agassiz Water Authority is a very important issue in the eastern part of ND. It tries to look at a long term water supply. I ask that you give it a do pass.

Chr. Nelson: Are there any questions? Seeing none, thank you for your testimony. Is there further supporting testimony?

Sen. Tom Fischer, Dist 46: Last session, we created the Lake Agassiz Water Authority to deliver water to eastern ND. We've been working on it since 1944. Permits are slow in coming. They have elected officials and service representatives for all of the rural districts and cities in the area of the Authority. Now, we need the support of the United States to get water to eastern ND.

Chr. Nelson: Are there any questions?

Rep. David Drovdal: Do we have more than the Lake Agassiz Water Authority working on this issue in delivering water like the Garrison Diversion? Are we taking one over the other in this resolution?

Fischer: The Garrison Conservancy District is working with the Lake Agassiz Water Authority. Garrison Diversion Conservancy is doing a study with the Bureau of Reclamation with options for bringing water to the east. That study will be completed by December of this year. Dave Koland of Garrison serves as a secretary of the Lake Agassiz Water Authority, so they're working together, not against each other.

Drovdal: Is this the principal water authority that is working on this or are there other water authorities?

Fischer: No, there are no others. This is the principal group. There was a group, the Eastern Dakota Water Users, that dissolved to put this into statute.

Chr. Nelson: Wouldn't a joint basin board be looking at that same issue?

Fischer: The Red River Basin Commission?

Chr. Nelson: Yes.

Fischer: The Basin Commission doesn't have any authority to their policy. The commission that comprises Manitoba....

Chr. Nelson: I'm talking about the Devils Lake Joint Board.

Fischer: If we get the outlet to Devils Lake, we'll have a water supply to eastern ND for a time. The Devils Lake board is assisting temporarily in getting water to the east. I don't know how long it can last. It will come to a point where they won't want us to take any more water because of fishing.
