- 1 A BILL for an Act to amend and reenact section 41-09-99 of the North Dakota Century Code,
- 2 relating to limitations on waiver of state law protections for agricultural liens.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1. AMENDMENT.** Section 41-09-99 of the North Dakota Century Code is 5 amended and reenacted as follows:

6	41-0	09-99. (9-602) Waiver and variance of rights and duties. Except as otherwise
7	provided in	section 41-09-119, to the extent that they give rights to a debtor or obligor and
8	impose duti	es on a secured party, the debtor or obligor may not waive or vary the rules stated
9	in the following listed sections:	
10	1.	Paragraph 3 of subdivision d of subsection 2 of section 41-09-17, which deals with
11		use and operation of the collateral by the secured party;
12	2.	Section 41-09-20, which deals with requests for an accounting and requests
13		concerning a list of collateral and statement of account;
14	3.	Section 41-09-22, which deals with perfection and priority of agricultural liens.
15	<u>4.</u>	Subsection 3 of section 41-09-104, which deals with collection and enforcement of
16		collateral;
17	4. <u>5.</u>	Subsection 1 of section 41-09-105 and subsection 3 of section 41-09-111 to the
18		extent that they deal with application or payment of noncash proceeds of collection,
19		enforcement, or disposition;
20	5. <u>6.</u>	Subsection 1 of section 41-09-105 and subsection 4 of section 41-09-111 to the
21		extent that they require accounting for or payment of surplus proceeds of collateral;
22	6. <u>7.</u>	Section 41-09-106 to the extent that it imposes upon a secured party that takes
23		possession of collateral without judicial process the duty to do so without breach of
24		the peace;

 11 failure to comply with this chapter.
