ENGROSSED SENATE BILL NO. 2010

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the insurance
2 commissioner; to provide an appropriation to the legislative council; to provide for fund
3 transfers; to provide for making payments of insurance premiums tax collections to fire
4 departments; and to amend and reenact section 26.1-01-09 of the North Dakota Century Code,
5 relating to the commissioner's salary.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1. BASE LEVEL FUNDING INFORMATION.** The amounts identified in this
8 section represent the base level funding component appropriated to the insurance
9 commissioner in section 3 of this Act as follows:

10 Salaries and wages	\$5,096,278
11 Operating expenses	2,163,377
12 Grants to fire districts	<u>6,420,000</u>
13 Total special funds appropriation - Base level	\$13,679,655

14 **SECTION 2. FUNDING ADJUSTMENTS OR ENHANCEMENTS INFORMATION.** The
15 amounts identified in this section represent the funding adjustments or enhancements to the
16 base funding level for the insurance commissioner which are included in the appropriation in
17 section 3 of this Act as follows:

18 Salaries and wages	\$696,324
19 Operating expenses	15,000
20 Grants to fire districts	<u>(100,000)</u>
21 Total special funds appropriation - Adjustments/enhancements	\$611,324

22 **SECTION 3. APPROPRIATION.** The funds provided in this section, or so much of the
23 funds as may be necessary, are appropriated from special funds derived from federal funds

1 and other income, to the insurance commissioner for the purpose of defraying the expenses of
2 that agency, for the biennium beginning July 1, 2007, and ending June 30, 2009, as follows:

3 Salaries and wages	\$5,792,602
4 Operating expenses	2,178,377
5 Grants	<u>6,320,000</u>
6 Total special funds appropriation	\$14,290,979

7 **SECTION 4. APPROPRIATION - LEGISLATIVE COUNCIL.** There is appropriated out
8 of any moneys in the insurance regulatory trust fund in the state treasury, not otherwise
9 appropriated, the sum of \$60,000, or so much of the sum as may be necessary, to the
10 legislative council for the purpose of defraying expenses of legislative members attending
11 functions of the national conference of insurance legislators, for the biennium beginning July 1,
12 2007, and ending June 30, 2009.

13 **SECTION 5. INSURANCE PREMIUMS TAX COLLECTIONS PAYMENTS.** Section 3
14 of this Act includes the sum of \$6,320,000, or so much of the sum as may be necessary to the
15 insurance commissioner, of which \$6,200,000 is for the purpose of making payments of
16 insurance premiums tax collections to fire departments and \$120,000 is for the purpose of
17 making two equal payments to the North Dakota firefighter's association for the biennium
18 beginning July 1, 2007, and ending June 30, 2009.

19 **SECTION 6. BONDING FUND.** Section 3 of this Act includes the sum of \$44,131, or
20 so much of the sum as may be necessary, from the state bonding fund to pay bonding fund
21 administrative expenses for the biennium beginning July 1, 2007, and ending June 30, 2009.

22 **SECTION 7. FIRE AND TORNADO FUND.** Section 3 of this Act includes the sum of
23 \$1,003,804, or so much of the sum as may be necessary, from the state fire and tornado fund
24 to pay fire and tornado fund administrative expenses for the biennium beginning July 1, 2007,
25 and ending June 30, 2009.

26 **SECTION 8. UNSATISFIED JUDGMENT FUND.** Section 3 of this Act includes the
27 sum of \$16,546, or so much of the sum as may be necessary, from the state unsatisfied
28 judgment fund to pay unsatisfied judgment fund administrative expenses for the biennium
29 beginning July 1, 2007, and ending June 30, 2009.

30 **SECTION 9. PETROLEUM TANK RELEASE COMPENSATION FUND.** Section 3 of
31 this Act includes the sum of \$108,674, or so much of the sum as may be necessary, from the

1 petroleum tank release compensation fund to pay petroleum tank release compensation fund
2 administrative expenses for the biennium beginning July 1, 2007, and ending June 30, 2009.

3 **SECTION 10. ANHYDROUS AMMONIA STORAGE FACILITY INSPECTION FUND.**

4 Section 3 of this Act includes the sum of \$150,000, or so much of the sum as may be
5 necessary, from the anhydrous ammonia storage facility inspection fund to pay for anhydrous
6 ammonia tank inspection costs for the biennium beginning July 1, 2007, and ending June 30,
7 2009.

8 **SECTION 11. AMENDMENT.** Section 26.1-01-09 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **26.1-01-09. Salary of commissioner.** The annual salary of the commissioner is
11 ~~seventy seven~~ seventy-six thousand ~~seven~~ five hundred ~~thirty-nine~~ eleven dollars through June 30,
12 ~~2006~~ 2008, and ~~seventy-three~~ seventy-nine thousand five hundred ~~sixty-eight~~ seventy-one
13 dollars thereafter.
