

**HOUSE BILL NO. 1056**

1 A BILL for an Act to amend and reenact section 52-04-22 of the North Dakota Century Code,  
2 relating to the unemployment insurance federal advance interest repayment fund; and to  
3 provide a continuing appropriation.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 52-04-22 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **52-04-22. Federal advance interest repayment fund - Continuing appropriation.**

8 There is created the federal advance interest repayment fund, to which will be credited all  
9 assessments collected by the division for the purpose of paying interest due on federal  
10 advances to the state trust fund. The fund must consist of all interest collected on delinquent  
11 contributions, all penalties provided by the Unemployment Compensation Law, and funds  
12 borrowed from sources other than federal advances which are placed in this fund. All moneys  
13 accruing to this fund in any manner must be maintained in this separate interest-bearing  
14 account at the Bank of North Dakota or invested in deposits of the Bank of North Dakota.

15 Moneys in this fund may also be used for the purpose of repaying funds placed in this  
16 fund which are borrowed from sources other than federal advances and for the purpose of  
17 paying interest due on other than federal advances. However, moneys in this fund may not be  
18 expended or available for expenditure in any manner which would permit their substitution for,  
19 or a corresponding reduction in, federal funds which would in the absence of the moneys be  
20 available to finance expenditures for the administration of the bureau.

21 Moneys in this fund may also be used for the purpose of paying principal and interest  
22 costs associated with the acquisition and renovation of land and a building to be used as an  
23 office facility by job service North Dakota in Grand Forks, North Dakota. Moneys in this fund  
24 also may be used for the purpose of paying principal and interest costs associated with the

1 acquisition and renovation of land and building to be used as an office facility by job service  
2 North Dakota in Bismarck, North Dakota. Moneys in this fund may be used for the purpose of  
3 paying the costs of repair, renovation, or alteration of job service-owned office facilities.  
4 Moneys in this fund may be used for the purpose of paying the replacement rate charged for  
5 use of state fleet vehicles. Moneys in this fund may be used for the purposes of reemployment  
6 and administration of programs to ensure the integrity of the unemployment insurance program  
7 in this state. Moneys in this fund are hereby appropriated for the purposes specified in this  
8 section including the purpose of paying principal and interest costs associated with the  
9 acquisition and renovation of land and a building to be used as an office facility by job service  
10 North Dakota in Grand Forks, North Dakota. Moneys in this fund are appropriated for the  
11 purpose of paying the principal and interest costs associated with the acquisition and  
12 renovation of land and a building to be used as an office facility by job service North Dakota in  
13 Bismarck, North Dakota. Moneys in this fund are appropriated for the purpose of paying the  
14 costs of repair, renovation, or alteration of job service-owned office facilities. Moneys in this  
15 fund are appropriated for the purpose of paying the replacement rate charged for use of state  
16 fleet vehicles. Moneys in this fund are appropriated for the purposes of reemployment and  
17 administration of programs to ensure the integrity of the unemployment insurance program in  
18 this state.
