- Determine the standing committees that will receive the report from the Commissioner of Commerce on the department's goals and objectives, its long-term goals and objectives, and on commerce benchmarks (NDCC § 54-60-03)
- Review and adopt project plan for replacement of legislative technology applications and approve deliverables of each completed project phase (2005 S.L., ch. 29, § 5)
- Administer appropriation for committee room renovations (2007 S.L., ch. 1, § 7)
- Review Legislative Council staff services during the 2007-08 interim for the purpose of determining future legislative staffing needs (2007 S.L., ch. 1, § 8)
- Review legislative rules
