



#### Population Density in North Dakota by County: 2000






#### Net Migration with Population Change in North Dakota by County. July 1, 2005 to July 1, 2006


## 2000 Census – Rural and Urban Population Distributions by Age and Gender for North Dakota


Figure 1. Percent Change in Population by Age Group North Dakota and the U.S.: Census 2000 to July 1, 2004 Estimate


#### North Dakota Households by Type: 1960 to 2000




## Population Distribution by Age of Earner in North Dakota: 1980-2020






# PERCENT CHANGE IN PERSONS: 2000 to 2010 & 2000 to 2020




## Projected Change in Earners, by Income Type, by Age Cohort, in North Dakota: 2000 to 2020

#### What We Know

- Traditional economic development approaches are not working in most rural places, and alternatives are needed
- There is a positive relationship between economic growth and entrepreneurship (GEM): Global Entrepreneurship Monitor
  - No countries with high levels of entrepreneurial activity experienced low rates of economic growth
- 1997-2001, 2.2 million nonemployee firms were added in U.S., with a 31% increase in sales (Census)
- Most new job growth and innovation (2/3rds) are coming from small firms (NCOE) National Centers of Excellence





### **EDS - Early Lessons**


- 180 collaborative responses involving 2,000 organizations for Kellogg RFP showed:
- Commitment, creativity, and resourcefulness to chart a new economic future
- Key principles embraced -- systems, customer focus, regionalism, inclusiveness, effectiveness
- Collaboration governments, nonprofits, private sector reaching across political and social boundaries, including youth and others normally left out of decision-making ---"no wrong door"





Create climate and culture in which entrepreneurs and entrepreneurship can flourish

- 3 organizing principles:

  - Regionally-oriented
  - Entrepreneur-focused










## N.D. Labor Force, by Generation






# Total Personal Income in North Dakota by Source: 1969 to 2003




#### Gross State Product

- North Dakota's Gross State Product totaled \$22.7 billion in 2004.
- The Information industry, along with Professional and Technical services captured 7.4% of that total in 2004, or nearly \$1.7 billion (a 54.5% increase from \$1.1 billion in 1997.






# Total Personal Income in North Dakota Non-Metro Counties by Source: 1969 to 2003









## Persons Ages 65 and Older as a Percent of the Total Population in North Dakota by County: 2020




#### Seniors' economic contribution INCOME:

- Nearly \$ 3 billion in income (18% of state's total)
  - Social Security \$1.3 billion
  - Private pensions \$1 billion
  - Medicaid \$529 million
  - Veteran's pensions \$55 million



# Aggregate Household Income for Householders 65 and Older as a Percent of Total Aggregate Household Income in North Dakota by County: 2000









#### Seniors' economic contribution---WEALTH

- In 2001, the wealth of North Dakota's 261,570 households was estimated at \$92.4 billion
- Seniors 60 and over owned 51% of the wealth
- In next 15 years, it is estimated that \$37.6 billion will be transferred
- Over the next 50 years, an estimated \$205.7 billion will be transferred
